LONG TITLE

28 Section 1. Section **53E-3-518** is enacted to read:

29 **53E-3-518. School counselor services.**

30 No later than July 1, 2019, the State Board of Education shall make rules specifying:

31 (1) the recommended direct and indirect services a school counselor may provide;

32 (2) the recommended amount of time a school counselor may spend on direct and

33 indirect services; and

34 (3) prohibited activities for a school counselor.
