CRIMINAL THREAT OR INTERFERENCE AMENDMENTS

LONG TITLE

General Description:

This bill concerns criminal offenses conducted against a public servant, party official, or voter.

Highlighted Provisions:

This bill:

- ▶ defines terms;
- ▶ modifies the elements and penalties for certain criminal offenses perpetrated

against:

- a public servant, party official, or voter;
- an immediate family member of the public servant, party official, or voter;
- an individual who resides in the household of a public servant, party official, or

voter; or

- an individual or entity in whose welfare the public servant, party official, or

voter is interested;

- ▶ expands the scope of the offense of a threat against a public servant or party official

to apply to a former public servant or party official;

- ▶ clarifies provisions regarding the offense of interference with a public servant's

performance of an official function;



- 26 ▶ amends the scope of criminal offenses concerning a juror and clarifies the
- 27 applicability of the separate offense of tampering with a juror;
- 28 ▶ modifies provisions concerning the offense of denial of a public servant's use of
- 29 public property;
- 30 ▶ consolidates and repeals overlapping provisions concerning threatening elected
- 31 officials; and
- 32 ▶ makes technical and conforming changes.

264 demonstrate continuing unlawful conduct and be related either to each other or to the
265 enterprise. At least one of the episodes comprising a pattern of unlawful activity shall have
266 occurred after July 31, 1981. The most recent act constituting part of a pattern of unlawful
267 activity as defined by this part shall have occurred within five years of the commission of the
268 next preceding act alleged as part of the pattern.
