	Section 1. Section <b>53-7-225</b> is amended to read:
	53-7-225. Times for sale and discharge of fireworks Criminal penalty

	(1) Except as provided in Section 53-7-221, this section supersedes any other code
pr	rovision regarding the sale or discharge of fireworks.

(2) A person may sell class C common state approved explosives in the state as

28	follows:
29	(a) beginning on June 24 and ending on July 25;
30	(b) beginning on December 29 and ending on December 31; and
31	(c) two days before and on the Chinese New Year's eve.
32	(3) A person may not discharge class C common state approved explosives in the state
33	except as follows:
34	(a) between the hours of 11 a.m. and 11 p.m., except that on July 4 and July 24, the
35	hours are 11 a.m. to midnight:
36	(i) beginning on July 2 and ending on July 5; and
37	(ii) beginning on July 22 and ending on July 25;
38	(b) between the hours of 11 a.m. and 11 p.m. on:
39	(i) September 17; or
40	(ii) September 16, if September 17 is a Sunday;
41	[(b)] (c) (i) beginning at 11 a.m. on December 31 and ending at 1 a.m. on the following
42	day; or
43	(ii) if New Year's eve is on a Sunday and the county, municipality, or metro township
44	determines to celebrate New Year's eve on the prior Saturday, then a person may discharge
45	class C common state approved explosives on that prior Saturday within the county,
46	municipality, or metro township;
47	[(c)] (d) between the hours of 11 a.m. and 11 p.m. on January 1; and
48	[(d)] (e) beginning at 11 a.m. on the Chinese New Year's eve and ending at 1 a.m. on
49	the following day.
50	(4) A person is guilty of an infraction, punishable by a fine of up to \$1,000, if the
51	person discharges a class C common state approved explosive:
52	(a) outside the legal discharge dates and times described in Subsection (3); or
53	(b) in an area in which fireworks are prohibited under Subsection 15A-5-202.5(1)(b).
54	(5) (a) Except as provided in Subsection (5)(b) or (c), a county, a municipality, a metro
55	township, or the state forester may not prohibit a person from discharging class C common
56	state approved explosives during the permitted periods described in Subsection (3).
57	(b) (i) As used in this Subsection (5)(b), "negligent discharge":
58	(A) means the improper use and discharge of a class C common state approved

59	explosive; and
60	(B) does not include the date or location of discharge or the type of explosive used.
61	(ii) A municipality or metro township may prohibit:
62	(A) the discharge of class C common state approved explosives in certain areas with
63	hazardous environmental conditions, in accordance with Subsection 15A-5-202.5(1)(b); or
64	(B) the negligent discharge of class C common state approved explosives.
65	(iii) A county may prohibit the negligent discharge of class C common state approved
66	explosives.
67	(c) The state forester may prohibit the discharge of class C common state approved
68	explosives as provided in Subsection 15A-5-202.5(1)(b) or Section 65A-8-212.
69	(6) If a municipal legislative body, the state forester, or a metro township legislative
70	body provides a map to a county identifying an area in which the discharge of fireworks is
71	prohibited due to a historical hazardous environmental condition under Subsection
72	15A-5-202.5(1)(b), the county shall, before June 1 of that same year:
73	(a) create a county-wide map, based on each map the county has received, indicating
74	each area within the county in which fireworks are prohibited under Subsection
75	15A-5-202.5(1)(b);
76	(b) provide the map described in Subsection (6)(a) to:
77	(i) each retailer that sells fireworks within the county; and
78	(ii) the state fire marshal; and
79	(c) publish the map on the county's website.
80	(7) A retailer that sells fireworks shall display:
81	(a) a sign that:
82	(i) is clearly visible to the general public in a prominent location near the point of sale;
83	(ii) indicates the legal discharge dates and times described in Subsection (3); and
84	(iii) indicates the criminal charge and fine associated with discharge:
85	(A) outside the legal dates and times described in Subsection (3); and
86	(B) within an area in which fireworks are prohibited under Subsection
87	15A-5-202.5(1)(b); and
88	(b) the map that the county provides, in accordance with Subsection (6)(b).
