Section 1. Section 36-12-1 is amended to read:
36-12-1. Definitions.
As used in this chapter:
(1) "House majority party ratio" means the number obtained by dividing the number of
representatives who are members of the majority party in the House of Representatives by the
total number of representatives in the House of Representatives.
[(1)] (2) (a) "Interim committees" means legislative committees that are formed from
the membership of each house to function between sessions of the Legislature in order to study
subjects of legislative concern.
(b) "Interim committees" includes a commission, committee, council, task force, board,
or panel, in which legislative participation is required by law, which committee functions
between sessions of the Legislature.
[(2)] (3) "Legislative director" means the director of the Office of Legislative Research
and General Counsel, the legislative fiscal analyst, or the legislative auditor general.
(4) "Legislative management majority party ratio" means the number obtained by
dividing the number of majority party members on the Legislative Management Committee by
the total number of members on the Legislative Management Committee.
[(3)] (5) "Major political party" means either of the two political parties having the
greatest number of members elected to the two houses of the Legislature.
[(4)] (6) "Professional legislative staff" means the legislative directors and the
members of their staffs.
(7) "Senate majority party ratio" means the number obtained by dividing the number of

59	senators who are members of the majority party in the Senate by the total number of senators in
60	the Senate.
61	[(5)] (8) "Standing committees" means legislative committees organized under the
62	rules of each house of the Legislature for the duration of the legislative biennial term to
63	consider proposed legislation. As used in this chapter, "standing committees" excludes
64	appropriations committees, appropriations subcommittees, and rules committees.
65	Section 2. Section 36-12-6 is amended to read:
66	36-12-6. Permanent committees House and Senate management Legislative
67	Management Committee Membership Meetings Quorum.
68	(1) (a) There [are] is hereby established as [permanent committees] a permanent
69	committee of the Legislature a House Management Committee [and a Senate Management
70	Committee. The House Management Committee shall consist of consisting of eight members
71	of the House of Representatives[, four from each major political party. The membership shall
72	include the elected leadership of the House of Representatives and additional members chosen
73	at the beginning of each annual general session by the minority party caucus as needed to
74	complete the full membership].
75	(b) Membership in the House Management Committee shall consist of:
76	(i) members of the majority party in a number equal to the number of members on the
77	committee multiplied by the House majority party ratio, with the resulting number rounded
78	down to the nearest whole number; and
79	(ii) members in the minority party in a number equal to the total number of committee

99	from each major political party. The membership shall include the elected leadership of the
100	Senate and additional members chosen at the beginning of each annual general session by the
101	appropriate party caucus as needed to complete the full membership].
102	(b) Membership in the Senate Management Committee shall consist of:
103	(i) members of the majority party in a number equal to the number of members on the
104	committee multiplied by the Senate majority party ratio, with the resulting number rounded

106	(ii) members in the minority party in a number equal to the total number of committee
107	members minus the number of majority party members.

127	Committee and the Senate Management Committee meeting jointly. [The]
128	(c) During odd-numbered calendar years, the president of the Senate or [his] the
129	president's designee shall [be chairman during 1987,] serve as chair and the speaker of the
130	House of Representatives or [his] the speaker's designee shall [be vice-chairman] serve as

143	section] in a position that is based on a member's elected leadership position, or if a vacancy
144	occurs in a position that is appointed by the speaker or president, a replacement shall be chosen
145	by <u>:</u>
146	(i) the president of the Senate, if the vacancy is a majority-party member of Senate;
147	(ii) the speaker of the House of Representatives, if the vacancy is a majority-party
148	member of the House of Representatives; or

150	which the vacancy occurs, if the vacancy is a member of a minority party.

155	prescribing rules and policies pertaining to their respective powers and duties.

157	of a quorum has authority to act in any matter falling within the jurisdiction of the committee.

162	(1) There [is] are created within the Legislative Management Committee three
163	subcommittees [having equal representation from each major political party. The
164	subcommittees, their membership, and their functions are as follows:] as provided in this
165	section.
166	(2) (a) The Research and General Counsel Subcommittee[, comprising] shall consist of
167	six members[7] as follows:
168	(i) members of the majority party in a number equal to the number of members on the
169	subcommittee multiplied by the legislative management majority party ratio, with the resulting
170	number rounded down to the nearest whole number; and
171	(ii) members in the minority party in a number equal to the total number of
172	subcommittee members minus the number of majority party members.
173	(b) The subcommittee shall recommend to the Legislative Management Committee a
174	person or persons to hold the positions of director of the Office of Legislative Research and
175	General Counsel and legislative general counsel.
176	[(b)] (3) (a) The Budget Subcommittee[, comprising] shall consist of six members[;] as
177	<u>follows:</u>
178	(i) members of the majority party in a number equal to the number of members on the
179	subcommittee multiplied by the legislative management majority party ratio, with the resulting
180	number rounded down to the nearest whole number; and
181	(ii) members in the minority party in a number equal to the total number of
182	subcommittee members minus the number of majority party members.

183	(b) The subcommittee shall recommend to the Legislative Management Committee a
184	person to hold the position of legislative fiscal analyst.
185	[(c)] (4) (a) The Audit Subcommittee[, comprising] which shall consist of four
186	members[, shall:] as follows:
187	(i) members of the majority party in a number equal to the number of members on the
188	subcommittee multiplied by the legislative management majority party ratio, with the resulting
189	number rounded down to the nearest whole number; and
190	(ii) members in the minority party in a number equal to the total number of
191	subcommittee members minus the number of majority party members.
192	(b) The subcommittee shall:
193	(i) recommend to the Legislative Management Committee a person to hold the position
194	of legislative auditor general; and
195	(ii) (A) review all requests for audits;
196	(B) prioritize those requests; and
197	(C) hear all audit reports and refer those reports to other legislative committees for
198	their further review and action as appropriate.
199	[(2)] (5) The members of each subcommittee of the Legislative Management
200	Committee shall be appointed from the membership of the Legislative Management Committee
201	by an appointments committee comprised of the speaker and the minority leader of the House
202	of Representatives and the president and the minority leader of the Senate.
203	[(3)] (6) Each subcommittee of the Legislative Management Committee shall meet as
204	often as necessary to perform its duties. They may meet during and between legislative
205	sessions.

222	(i) members of the majority party in a number equal to the Senate majority party ratio

224	(ii) members in the minority party in a number equal to the number three minus the
225	number of majority party members; and
226	(iii) the highest ranking members of each party's Senate leadership filling the
227	respective party seats; and
228	(b) three members of the House Management Committee, with:
229	(i) members of the majority party in a number equal to the House majority party ratio
230	multiplied by three, with the resulting number rounded down to the nearest whole number;
231	(ii) members in the minority party in a number equal to the number three minus the
232	number of majority party members; and
233	(iii) the highest ranking members of each party's house leadership filling the respective
234	party seats.
235	(2) The Subcommittee on Oversight shall:
236	(a) review and approve the budget for the Office of Legislative Fiscal Analyst, the
237	Office of Legislative Research and General Counsel, and the Office of Legislative Auditor
238	General; and
239	(b) provide an annual performance review for the legislative fiscal analyst, the director
240	of the Office of Legislative Research and General Counsel, and the legislative auditor general.
241	(3) (a) This subcommittee shall meet no later than June 1st of each year to conduct the
242	annual performance review and no later than November 1st of each year to review and approve
243	the budget of these offices.
244	(b) This subcommittee may meet as often as necessary to perform its duties.
