31	Section 1. Section 53G-7-1002 is amended to read:
32	53G-7-1002. Internet and online safety policy required.
33	(1) State funds may not be provided to any local school board that provides access to
34	the Internet or an online service unless the local school board adopts and enforces a policy to
35	restrict access to Internet or online sites, databases, or networks that contain obscene or
36	pornographic material as described in Section 76-10-1203.
37	(2) This part applies to any computer, phone, or other device capable of accessing the
38	Internet provided to students or educators.
39	Section 2. Section 53G-7-1003 is amended to read:
40	53G-7-1003. Process and content standards for policy Internal testing of filters.
41	(1) "Policy" as used in this section means the elementary and secondary school online
42	access policy adopted by a local school board to meet the requirements of Section 53G-7-1002.
43	(2) (a) Each policy shall be developed under the direction of the local school board,
44	adopted in an open meeting, and have an effective date. The local school board shall review
45	the policy at least every three years, and a footnote shall be added to the policy indicating the
46	effective date of the last review.
47	(b) Notice of the availability of the policy shall be posted in a conspicuous place within
48	each school. The local school board may issue any other public notice it considers appropriate.
49	(3) The policy shall:
50	(a) state that it restricts access to Internet or online sites, databases, or networks that
51	contain obscene or pornographic material and shall state how the local school board intends to
52	meet the requirements of Section 53G-7-1002;
53	(b) inform the public that administrative procedures and guidelines for the staff to
54	follow in enforcing the policy have been adopted and are available for review at the school; and
55	(c) inform the public that procedures to handle complaints about the policy, its
56	enforcement, or about observed behavior have been adopted and are available for review at the
57	school.
58	(4) The local school board shall periodically, but not less than every six months,

59	perform a check of the Internet filtering software utilized by each school to insure that the
60	requirements of Section 53G-7-1002 are being met. These checks shall take into consideration
61	parental complaints received by a school regarding content accessed by students.
62	(5) The local school board shall create a record each time a check of Internet filtering
63	software allows access to obscene or pornographic material. The records shall be compiled into
64	a report and provided to the Internet filtering software provider.
65	(6) Records created in accordance with Subsection (5) shall be compiled and reported
66	to the state school board not later than September 30 of each year. The report shall detail efforts
67	to curtail the access reported in Subsection (5).
68	(7) The state school board shall compile all records received in accordance with
69	Subsection (6) into a report to be presented to the Education Interim Committee no later than
70	November 30 of each year.
