44	(vii) a noise maker;

59	(a) ensuring nothing obstructs a walkway or the view of a meeting attendee;
60	(b) ensuring that nothing disrupts, disturbs, or otherwise impedes the orderly course of
61	the meeting;
62	(c) protecting state property from damage or disarray;
63	(d) prohibiting speech likely to incite or produce imminent lawless action, fighting
64	words, or obscenity; and
65	(e) prohibiting any activity or item that poses a danger to the safety of a meeting
66	attendee.
67	(2) To preserve order and decorum in accordance with Subsection (1), the chair may:
68	(a) prohibit the following:
69	(i) standing, waving, yelling, cheering, whistling, or clapping;
70	(ii) loud noises;
71	(iii) food or drink, other than water in a closed container;
72	(iv) musical instruments;
73	(v) any item that may require excessive cleanup; or
74	(vi) to the extent necessary to preserve order and decorum, any other item or activity
