- Section 1. Section **53B-1-105** is amended to read:
- 53B-1-105. Appointment of commissioner of higher education -- Qualifications -- Duties.
  - (1) (a) The board [appoints], upon approval from the governor and with the consent of the Senate for each appointee nominated on or after May 8, 2012, shall appoint a commissioner of higher education to serve at its pleasure as its chief executive officer.
