LONG TITLE

General Description:

This bill amends provisions related to assigning a letter grade to a school based on the proficiency, learning gains, or college and career readiness of the school's students.

► amends provisions related to the letter grade that is assigned to the percentage of points earned under school grading.

Be it enacted by the Legislature of the state of Utah:



26 Section 1. Section 53A-1-1110 is amended to read:

27 **53A-1-1110. Letter grade based on percentage of maximum points earned.**

 29 school shall receive a letter grade based on the percentage of the maximum number of points
 30 the school may earn as calculated under Section 53A-1-1109 as follows:

31 [~~(a) A, 100% - 80%;~~]

32 [~~(b) B, 79% - 70%;~~]

33 [~~(c) C, 69% - 60%;~~]

34 [~~(d) D, 59% - 50%; and~~]

50 (2) (a) For each school year after the 2015-16 school year, the endpoints of the ranges
 51 [~~listed in Subsections (1)(a) through (1)(e) by five~~] described in Subsection (1) shall, except as
 52 provided in Subsection (2)(b), increase by two percentage points[~~, except~~] over the previous
 53 school year, until the lower endpoint of the A range [~~may not be greater than~~] equals 90%.

54 (b) The board may increase the endpoints of the ranges described in Subsection (1) by
 55 more than two percentage points over the previous school year if the increase is established in
 56 rules made in accordance with Title 63G, Chapter 3, Utah Administrative Rulemaking Act.
