40	funded project providing cancer education, screening, and treatment services to those who are
41	victims of mill tailings exposure, resulted in the diagnosis of 39 new cancers and 32 cases of
42	precancerous polyps;
43	WHEREAS, funding has been exhausted and program activities halted, pending
44	continued federal support;
45	WHEREAS, the United States Secretary of Health and Human Services should instruct
46	the Health Resources and Services Administration to fund cancer education, screening, and
47	treatment services to victims of mill tailings exposure until 2044, or until another equitable
48	resolution can be reached through the United States Department of Energy;

50	federal resources to ensure cancer education, screening, and treatment services to victims of
