14	Retail sales and use of the following shall be exempt from the tax on retail
15	sales imposed under section 9771 of this title and the use tax imposed under
16	section 9773 of this title.

18	(51) The following machinery, including repair parts and parts or
19	accessories sold for the machinery, used for timber cutting, timber removal,
20	and processing of timber or other solid wood forest products intended to be

1	sold ultimately at retail: skidders with grapple and cable, feller bunchers, cut
2	to-length processors, forwarders, delimbers, loader slashers, log loaders,
3	whole-tree chippers, stationary screening systems, and firewood processors,
4	elevators, and screens. The Department of Taxes shall publish guidance
5	relating to the application of this exemption.
