| 15 | breeding purposes may take out annually, on or before April 1, a special        |
| 16 | license for the domestic pets or wolf-hybrids, provided:                        |
| 17 | (1) He or she keeps the domestic pets or wolf-hybrids within a proper           |
| 18 | enclosure. A proper enclosure is a locked fence or structure of sufficient      |
| 19 | height and sufficient depth into the ground to prevent the entry of young       |
