9	It is hereby enacted by the General Assembly of the State of Vermont:
10	C. 1. FINDINGS
11	202) vill mark the 250th anniversary of: the Vermont Declaration of
12	Independence, adopted on January 15, 1777 in Westminster; the original
13	Vermont Constitution, adepted on July 8, 1777 in Windsor; and the American
14	victory at the Battle of Bennington, fought on August 16, 1777. These historic
15	events are central to the history of our State and merit a coordinated set of
16	commemorative celebrations that promotes civic pride, tourism, and
17	scholarship.
18	Sec. 2. VERMONT 250TH COMMISSION; CREATION; REPORT
19	(a) Creation. There is errested the Vermont 250th Commission.

1	(b) Momborship. The Commission shall consist of nine members from
2	geographically diverse parts of the State, who are well known in their
3	respective regions, have a professional background or strong interest in
4	Vermont history, and who shall be appointed as follows:
5	(1) two numbers, who shall not be members of the House, whom the
6	Speaker of the House shall appoint;
7	(2) two members who shall not be members of the Senate, whom the
8	Committee on Committees shall appoint;
9	(3) two members of the General Assembly whom the Governor shall
10	appoint;
11	(4) the State Historic Preservation Officer or designee;
12	(5) the Executive Director of the Vermont Historical Society or
13	designee; and
14	(6) the President of the Executive Board of Directors of the Bennington
15	Area Chamber of Commerce or designee.
16	(c) Powers and duties. The Commission shall plan and sponsor events for
17	both the general public and the scholarly community commemorating the
18	250th anniversary of the adoption of the Vermont Declaration of Independence
19	and the first Vermont Constitution and of the American victory at the Buttle of
20	Bennington. The Commission may consult and partner with public and
21	private sector organizations in Vermont and in other states.

1	(1) Report. On or before February 15, 2020, the Commission shall submit
2	a written report to the House Committees on Appropriations and on
3	Government Operations and the Senate Committees on Appropriations and on
4	Government Operations, proposing a long-term budget, including an allocation
5	of State and private-sector costs and an initial description of events that the
6	Commission may plan and sponsor.
7	(e) Meetings.
8	(1) The President of the Board of the Greater Bennington Area Chamber
9	of Commerce shall call the first meeting of the Commission, to occur on or
10	before September 1, 2019.
11	(2) The Committee at its first meeting shall select a chair from among
12	its members.
13	(3) A majority of the membership shall constitute a quorum.
14	(4) A member attending remotely may count toward the quorum and
15	cast a vote.
16	(5) The Commission shall not be limited to a specific number of
17	meetings. However, it shall not spend funds beyond the amount of the
18	appropriation provided for in subsection (g) of this section.
19	(6) The Commission shall cease to exist on December 31, 2027.
20	(f) Compensation and reimbursement. Members of the Commission who
21	are not employees of the State of Vermont and are not otherwise reimbursed

- for their attendance shall be entitled to reimburgement of expenses, pursuant to
- 2 32 V.S.A § 1010, to the extent funds appropriated for the Commission remain
- 3 available.
- 4 (g) Appropriations. The sum of \$2,000.00 is appropriated to the Vermont
- 5 250th Commission from the General Fund in fiscal year 2020 for
- 6 reimbursement of expenses for members of the Commission and for
- 7 miscellaneous administrative costs the Commission may mey.
- 8 Sec. 3. EFFECTIVE DATE
- 9 This act shall take effect on passage.
 - Sec. 1. VERMONT 250TH COMMISSION
 - (a) Creation. There is created the Vermont 250th Commission.
 - (b) Membership. The Commission shall be composed of the following members:
 - (1) one person from each of the counties of Addison, Bennington, Chittenden, Rutland, Windham, and Windsor, appointed by the Governor from a name or names that each county's legislative delegation shall submit;
 - (2) one member of the Senate, not from any of the counties listed in subdivision (b)(1) of this section, appointed by the Committee on Committees;
 - (3) one member of the House, not from any of the counties listed in subdivision (b)(1) of this section, appointed by the Speaker of the House;
 - (4) the Executive Director of the Vermont Historical Society or designee;
 - (5) the State Curator or designee;
 - (6) the State Historic Preservation Officer or designee;
 - (7) one person, appointed by the Vermont Commission on Native American Affairs:
 - (8) one person who is the author of published Vermont history books, appointed by the Governor; and

(9) one person, appointed by the Governor.

(c) Powers and duties. The Commission shall plan and sponsor events in advance of and in commemoration of the 250th anniversary of the State of Vermont and that also look to the future of the State. The Commission shall coordinate with the Agency of Education, the Agency of Agriculture, Food and Markets, the Department of Tourism and Marketing, and with other State agencies and departments; with federal agencies and departments; with the municipalities of the State; and with national and local public and private sector organizations in this and other states for assistance and support in planning and conducting commemorative semiquincentennial activities.

(d) Meetings

- (1) The Historic Preservation Officer or designee shall call the first meeting of the Commission to occur on or before September 1, 2020.
- (2) The Committee shall select a chair from among its members at the first meeting.
 - (3) A majority of the membership shall constitute a quorum.
- (4) A member attending remotely shall count toward the quorum and cast a vote.
- (5) The Commission shall not be limited to a specific number of meetings. However, it shall not incur expenses in excess of its appropriated funds.
 - (6) The Commission shall cease to exist on December 31, 2027.

(e) Compensation and reimbursement.

- (1) For attendance at meetings during adjournment of the General Assembly, a legislative member of the Commission serving in his or her capacity as a legislator shall be entitled to per diem compensation and reimbursement of expenses pursuant to 2 V.S.A. § 406. These payments shall be made from monies appropriated to the Commission.
- (2) Other members of the Commission shall be entitled to per diem compensation and reimbursement of expenses as permitted under 32 V.S.A. § 1010. These payments shall be made from monies appropriated to the Commission.

Sec. 1a. APPROPRIATION

The sum of \$25,000.00 is appropriated to the Agency of Administration for the Vermont 250th Commission from the General Fund in fiscal year 2020

for reimbursement of expenses for members of the Commission and for miscellaneous administrative costs the Commission may incur.

Sec. 2. EFFECTIVE DATE

This act shall take effect on passage.
