

**ESHB 1273** - S COMM AMD

1 Strike everything after the enacting clause and insert the  
2 following:

3 "NEW SECTION. **Sec. 1.** A new section is added to chapter 28A.210  
4 RCW to read as follows:

5 (1) By the beginning of the 2022-23 school year, school districts  
6 and private schools must make menstrual hygiene products available at  
7 no cost in all gender-neutral bathrooms and bathrooms designated for  
8 female students located in schools that serve students in any of  
9 grades six through twelve. If a school building serving grades six  
10 through twelve does not have a gender-neutral bathroom, then the  
11 products must also be available in at least one bathroom accessible  
12 to male students or in a school health room accessible to all  
13 students. For schools that serve students in grades three through  
14 five, school districts and private schools must make menstrual  
15 hygiene products available in a school health room or other location  
16 as designated by the school principal.

17 (2) Menstrual hygiene products must include sanitary napkins,  
18 tampons, or similar items.

19 (3) School districts and private schools must bear the cost of  
20 supplying menstrual hygiene products. School districts and private  
21 schools may seek grants or partner with nonprofit or community-based  
22 organizations to fulfill this obligation.

23 (4) This section governs school operation and management under  
24 RCW 28A.710.040 and 28A.715.020 and applies to charter schools  
25 established under chapter 28A.710 RCW and state-tribal compact  
26 schools established under chapter 28A.715 RCW.

27 NEW SECTION. **Sec. 2.** (1) By the beginning of the 2022-23  
28 academic year, institutions of higher education as defined in RCW  
29 28B.92.030 must make menstrual hygiene products available at no cost  
30 in all gender-neutral bathrooms and bathrooms designated for female  
31 students.

1 (2) Menstrual hygiene products must include sanitary napkins,  
2 tampons, or similar items.

3 (3) Institutions of higher education must bear the cost of  
4 supplying menstrual hygiene products. Institutions of higher  
5 education may seek grants or partner with nonprofit or community-  
6 based organizations to fulfill this obligation.

7 NEW SECTION. **Sec. 3.** Section 2 of this act constitutes a new  
8 chapter in Title 28B RCW."

9 On page 1, line 2 of the title, after "bathrooms;" strike the  
10 remainder of the title and insert "adding a new section to chapter  
11 28A.210 RCW; and adding a new chapter to Title 28B RCW."
