- 6 health system, as deemed appropriate by the department.

EFFECT: Directs the Department of Health to convene a work group to study the root causes of rising behavioral health issues in Washington communities. Requires the members of the work group to be representative of individuals with actual, practical experience dealing with the behavioral health system, and requires the membership to include individuals who have received behavioral health services, behavioral health service providers, tribal representatives, law enforcement officers, and advocates. Requires the work group to present a progress report to the Governor and the Legislature by December 15, 2022, and its findings and recommendations by June 30, 2023.
