1 AN ACT Relating to modifying miscellaneous provisions impacting  
2 department of fish and wildlife licensing requirements; amending RCW  
3 77.08.010, 77.08.075, 77.32.155, 77.32.470, 77.32.480, 77.32.520, and  
4 79A.80.040; and adding a new section to chapter 77.32 RCW.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 **Sec. 1.** RCW 77.08.010 and 2017 3rd sp.s. c 8 s 2 are each  
7 amended to read as follows:

8 The definitions in this section apply throughout this title or  
9 rules adopted under this title unless the context clearly requires  
10 otherwise.

11 (1) "Angling gear" means a line attached to a rod and reel  
12 capable of being held in hand while landing the fish or a handheld  
13 line operated without rod or reel.

14 (2) "Bag limit" means the maximum number of game animals, game  
15 birds, or game fish which may be taken, caught, killed, or possessed  
16 by a person, as specified by rule of the commission for a particular  
17 period of time, or as to size, sex, or species.

18 (3) "Building" means a private domicile, garage, barn, or public  
19 or commercial building.

20 (4) "Closed area" means a place where the hunting of some or all  
21 species of wild animals or wild birds is prohibited.

- 1 (5) "Closed season" means all times, manners of taking, and  
2 places or waters other than those established by rule of the  
3 commission as an open season. "Closed season" also means all hunting,  
4 fishing, taking, or possession of game animals, game birds, game  
5 fish, food fish, or shellfish that do not conform to the special  
6 restrictions or physical descriptions established by rule of the  
7 commission as an open season or that have not otherwise been deemed  
8 legal to hunt, fish, take, harvest, or possess by rule of the  
9 commission as an open season.
- 10 (6) "Closed waters" means all or part of a lake, river, stream,  
11 or other body of water, where fishing or harvesting is prohibited.
- 12 (7) "Commercial" means related to or connected with buying,  
13 selling, or bartering.
- 14 (8) "Commission" means the state fish and wildlife commission.
- 15 (9) "Concurrent waters of the Columbia river" means those waters  
16 of the Columbia river that coincide with the Washington-Oregon state  
17 boundary.
- 18 (10) "Contraband" means any property that is unlawful to produce  
19 or possess.
- 20 (11) "Covered animal species" means any species of elephant,  
21 rhinoceros, tiger, lion, leopard, cheetah, pangolin, marine turtle,  
22 shark, or ray either: (a) Listed in appendix I or appendix II of the  
23 convention on international trade in endangered species of wild flora  
24 and fauna; or (b) listed as critically endangered, endangered, or  
25 vulnerable on the international union for conservation of nature and  
26 natural resources red list of threatened species.
- 27 (12) "Covered animal species part or product" means any item that  
28 contains, or is wholly or partially made from, any covered animal  
29 species.
- 30 (13) "Deleterious exotic wildlife" means species of the animal  
31 kingdom not native to Washington and designated as dangerous to the  
32 environment or wildlife of the state.
- 33 (14) "Department" means the department of fish and wildlife.
- 34 (15) "Director" means the director of fish and wildlife.
- 35 (16) "Distribute" or "distribution" means either a change in  
36 possession for consideration or a change in legal ownership.
- 37 (17) "Endangered species" means wildlife designated by the  
38 commission as seriously threatened with extinction.
- 39 (18) "Ex officio fish and wildlife officer" means:

1 (a) A commissioned officer of a municipal, county, or state  
2 agency having as its primary function the enforcement of criminal  
3 laws in general, while the officer is acting in the respective  
4 jurisdiction of that agency;

5 (b) An officer or special agent commissioned by one of the  
6 following: The national marine fisheries service; the Washington  
7 state parks and recreation commission; the United States fish and  
8 wildlife service; the Washington state department of natural  
9 resources; the United States forest service; or the United States  
10 parks service, if the agent or officer is in the respective  
11 jurisdiction of the primary commissioning agency and is acting under  
12 a mutual law enforcement assistance agreement between the department  
13 and the primary commissioning agency;

14 (c) A commissioned fish and wildlife peace officer from another  
15 state who meets the training standards set by the Washington state  
16 criminal justice training commission pursuant to RCW 10.93.090,  
17 43.101.080, and 43.101.200, and who is acting under a mutual law  
18 enforcement assistance agreement between the department and the  
19 primary commissioning agency; or

20 (d) A Washington state tribal police officer who successfully  
21 completes the requirements set forth under RCW 43.101.157, is  
22 employed by a tribal nation that has complied with RCW 10.92.020(2)  
23 (a) and (b), and is acting under a mutual law enforcement assistance  
24 agreement between the department and the tribal government.

25 (19) "Fish" includes all species classified as game fish or food  
26 fish by statute or rule, as well as all finfish not currently  
27 classified as food fish or game fish if such species exist in state  
28 waters. The term "fish" includes all stages of development and the  
29 bodily parts of fish species.

30 (20) "To fish" and its derivatives means an effort to kill,  
31 injure, harass, harvest, or capture a fish or shellfish.

32 (21) "Fish and wildlife officer" means a person appointed and  
33 commissioned by the director, with authority to enforce this title  
34 and rules adopted pursuant to this title, and other statutes as  
35 prescribed by the legislature. Fish and wildlife officer includes a  
36 person commissioned before June 11, 1998, as a wildlife agent or a  
37 fisheries patrol officer.

38 (22) "Fish broker" means a person who facilitates the sale or  
39 purchase of raw or frozen fish or shellfish on a fee or commission  
40 basis, without assuming title to the fish or shellfish.

1 (23) "Fish dealer" means a person who engages in any activity  
2 that triggers the need to obtain a fish dealer license under RCW  
3 77.65.280.

4 (24) "Fishery" means the taking of one or more particular species  
5 of fish or shellfish with particular gear in a particular  
6 geographical area.

7 (25) "Food, food waste, or other substance" includes human and  
8 pet food or other waste or garbage that could attract large wild  
9 carnivores.

10 (26) "Fresh water" means all waters not defined as salt water  
11 including, but not limited to, rivers upstream of the river mouth,  
12 lakes, ponds, and reservoirs.

13 (27) "Fur-bearing animals" means game animals that shall not be  
14 trapped except as authorized by the commission.

15 (28) "Fur dealer" means a person who purchases, receives, or  
16 resells raw furs for commercial purposes.

17 (29) "Game animals" means wild animals that shall not be hunted  
18 except as authorized by the commission.

19 (30) "Game birds" means wild birds that shall not be hunted  
20 except as authorized by the commission.

21 (31) "Game farm" means property on which wildlife is held,  
22 confined, propagated, hatched, fed, or otherwise raised for  
23 commercial purposes, trade, or gift. The term "game farm" does not  
24 include publicly owned facilities.

25 (32) "Game reserve" means a closed area where hunting for all  
26 wild animals and wild birds is prohibited.

27 (33) "To hunt" and its derivatives means an effort to kill,  
28 injure, harass, harvest, or capture a wild animal or wild bird.

29 (34) "Illegal items" means those items unlawful to be possessed.

30 (35)(a) "Intentionally feed, attempt to feed, or attract" means  
31 to purposefully or knowingly provide, leave, or place in, on, or  
32 about any land or building any food, food waste, or other substance  
33 that attracts or could attract large wild carnivores to that land or  
34 building.

35 (b) "Intentionally feed, attempt to feed, or attract" does not  
36 include keeping food, food waste, or other substance in an enclosed  
37 garbage receptacle or other enclosed container unless specifically  
38 directed by a fish and wildlife officer or animal control authority  
39 to secure the receptacle or container in another manner.

40 (36) "Large wild carnivore" includes wild bear, cougar, and wolf.

1 (37) "License year" means the period of time for which a  
2 recreational license is valid. The license year begins April 1st, and  
3 ends March 31st.

4 (38) "Limited-entry license" means a license subject to a license  
5 limitation program established in chapter 77.70 RCW.

6 (39) "Limited fish seller" means a licensed commercial fisher who  
7 sells his or her fish or shellfish to anyone other than a wholesale  
8 fish buyer thereby triggering the need to obtain a limited fish  
9 seller endorsement under RCW 77.65.510.

10 (40) "Money" means all currency, script, personal checks, money  
11 orders, or other negotiable instruments.

12 (41) "Natural person" means a human being.

13 (42)(a) "Negligently feed, attempt to feed, or attract" means to  
14 provide, leave, or place in, on, or about any land or building any  
15 food, food waste, or other substance that attracts or could attract  
16 large wild carnivores to that land or building, without the awareness  
17 that a reasonable person in the same situation would have with regard  
18 to the likelihood that the food, food waste, or other substance could  
19 attract large wild carnivores to the land or building.

20 (b) "Negligently feed, attempt to feed, or attract" does not  
21 include keeping food, food waste, or other substance in an enclosed  
22 garbage receptacle or other enclosed container unless specifically  
23 directed by a fish and wildlife officer or animal control authority  
24 to secure the receptacle or container in another manner.

25 (43) "Nonresident" means a person who has not fulfilled the  
26 qualifications of a resident.

27 (44) "Offshore waters" means marine waters of the Pacific Ocean  
28 outside the territorial boundaries of the state, including the marine  
29 waters of other states and countries.

30 (45) "Open season" means those times, manners of taking, and  
31 places or waters established by rule of the commission for the lawful  
32 hunting, fishing, taking, or possession of game animals, game birds,  
33 game fish, food fish, or shellfish that conform to the special  
34 restrictions or physical descriptions established by rule of the  
35 commission or that have otherwise been deemed legal to hunt, fish,  
36 take, or possess by rule of the commission. "Open season" includes  
37 the first and last days of the established time.

38 (46) "Owner" means the person in whom is vested the ownership  
39 dominion, or title of the property.

1 (47) "Person" means and includes an individual; a corporation; a  
2 public or private entity or organization; a local, state, or federal  
3 agency; all business organizations, including corporations and  
4 partnerships; or a group of two or more individuals acting with a  
5 common purpose whether acting in an individual, representative, or  
6 official capacity.

7 (48) "Personal property" or "property" includes both corporeal  
8 and incorporeal personal property and includes, among other property,  
9 contraband and money.

10 (49) "Personal use" means for the private use of the individual  
11 taking the fish or shellfish and not for sale or barter.

12 (50) "Predatory birds" means wild birds that may be hunted  
13 throughout the year as authorized by the commission.

14 (51) "To process" and its derivatives mean preparing or  
15 preserving fish, wildlife, or shellfish.

16 (52) "Protected wildlife" means wildlife designated by the  
17 commission that shall not be hunted or fished.

18 (53) "Raffle" means an activity in which tickets bearing an  
19 individual number are sold for not more than (~~twenty-five dollars~~)  
20 \$25 each and in which a permit or permits are awarded to hunt or for  
21 access to hunt big game animals or wild turkeys on the basis of a  
22 drawing from the tickets by the person or persons conducting the  
23 raffle.

24 (54) "Resident" has the same meaning as defined in RCW 77.08.075.

25 (55) "Salt water" means those marine waters seaward of river  
26 mouths.

27 (56) "Seaweed" means marine aquatic plant species that are  
28 dependent upon the marine aquatic or tidal environment, and exist in  
29 either an attached or free floating form, and includes but is not  
30 limited to marine aquatic plants in the classes Chlorophyta,  
31 Phaeophyta, and Rhodophyta.

32 (57) "Senior" means a person (~~seventy~~) 70 years old or older.

33 (58) "Shark fin" means a raw, dried, or otherwise processed  
34 detached fin or tail of a shark.

35 (59)(a) "Shark fin derivative product" means any product intended  
36 for use by humans or animals that is derived in whole or in part from  
37 shark fins or shark fin cartilage.

38 (b) "Shark fin derivative product" does not include a drug  
39 approved by the United States food and drug administration and

1 available by prescription only or medical device or vaccine approved  
2 by the United States food and drug administration.

3 (60) "Shellfish" means those species of marine and freshwater  
4 invertebrates that have been classified and that shall not be taken  
5 or possessed except as authorized by rule of the commission. The term  
6 "shellfish" includes all stages of development and the bodily parts  
7 of shellfish species.

8 (61) "State waters" means all marine waters and fresh waters  
9 within ordinary high water lines and within the territorial  
10 boundaries of the state.

11 (62) "To take" and its derivatives means to kill, injure,  
12 harvest, or capture a fish, shellfish, wild animal, bird, or seaweed.

13 (63) "Taxidermist" means a person who, for commercial purposes,  
14 creates lifelike representations of fish and wildlife using fish and  
15 wildlife parts and various supporting structures.

16 (64) "Trafficking" means offering, attempting to engage, or  
17 engaging in sale, barter, or purchase of fish, shellfish, wildlife,  
18 or deleterious exotic wildlife.

19 (65) "To trap" and its derivatives means a method of hunting  
20 using devices to capture wild animals or wild birds.

21 (66) "Unclaimed" means that no owner of the property has been  
22 identified or has requested, in writing, the release of the property  
23 to themselves nor has the owner of the property designated an  
24 individual to receive the property or paid the required postage to  
25 effect delivery of the property.

26 (67) "Unclassified wildlife" means wildlife existing in  
27 Washington in a wild state that have not been classified as big game,  
28 game animals, game birds, predatory birds, protected wildlife,  
29 endangered wildlife, or deleterious exotic wildlife.

30 (68) "To waste" or "to be wasted" means to allow any edible  
31 portion of any game bird, food fish, game fish, shellfish, or big  
32 game animal other than cougar to be rendered unfit for human  
33 consumption, or to fail to retrieve edible portions of such a game  
34 bird, food fish, game fish, shellfish, or big game animal other than  
35 cougar from the field. For purposes of this chapter, edible portions  
36 of game birds must include, at a minimum, the breast meat of those  
37 birds. Entrails, including the heart and liver, of any wildlife  
38 species are not considered edible.

1 (69) "Wholesale fish buyer" means a person who engages in any  
2 fish buying or selling activity that triggers the need to obtain a  
3 wholesale fish buyer endorsement under RCW 77.65.340.

4 (70) "Wild animals" means those species of the class Mammalia  
5 whose members exist in Washington in a wild state. The term "wild  
6 animal" does not include feral domestic mammals or old world rats and  
7 mice of the family Muridae of the order Rodentia.

8 (71) "Wild birds" means those species of the class Aves whose  
9 members exist in Washington in a wild state.

10 (72) "Wildlife" means all species of the animal kingdom whose  
11 members exist in Washington in a wild state. This includes but is not  
12 limited to mammals, birds, reptiles, amphibians, fish, and  
13 invertebrates. The term "wildlife" does not include feral domestic  
14 mammals, old world rats and mice of the family Muridae of the order  
15 Rodentia, or those fish, shellfish, and marine invertebrates  
16 classified as food fish or shellfish by the director. The term  
17 "wildlife" includes all stages of development and the bodily parts of  
18 wildlife members.

19 (73) "Wildlife meat cutter" means a person who packs, cuts,  
20 processes, or stores wildlife for consumption for another for  
21 commercial purposes.

22 (74) "Youth" means a person (~~((fifteen years old for fishing and))~~)  
23 under (~~((sixteen))~~) 16 years old for fishing and hunting.

24 **Sec. 2.** RCW 77.08.075 and 2014 c 48 s 2 are each amended to read  
25 as follows:

26 (1) For the purposes of this title or rules adopted under this  
27 title, "resident" means(~~(÷~~

28 ~~(1)A))~~ a natural person who has maintained a permanent place of  
29 abode within the state for at least (~~((ninety))~~) 90 days immediately  
30 preceding an application for a license, has established by formal  
31 evidence an intent to continue residing within the state, is not  
32 licensed to hunt or fish as a resident in another state or country,  
33 and is not receiving resident benefits of another state or country.

34 (~~((a))~~) (2) For purposes of this section, "permanent place of  
35 abode" means a residence in this state that a person maintains for  
36 personal use.

37 (~~((b))~~) (a) A natural person can demonstrate that the person has  
38 maintained a permanent place of abode in Washington by showing that  
39 the person:



1 (i) Uses a Washington state address for federal income tax or  
2 state tax purposes;

3 (ii) Designates this state as the person's residence for  
4 obtaining eligibility to hold a public office or for judicial  
5 actions;

6 (iii) Is a registered voter in the state of Washington; or

7 (iv) Is a custodial parent with a child attending  
8 prekindergarten, kindergarten, elementary school, middle school, or  
9 high school in this state.

10 ~~((e))~~ (b) A natural person can demonstrate the intent to  
11 continue residing within the state by showing that he or she:

12 (i) Has a valid Washington state driver's license; or

13 (ii) Has a valid Washington state identification card, if the  
14 person is not eligible for a Washington state driver's license; and

15 (iii) Has registered the person's vehicle or vehicles in  
16 Washington state(~~(~~

17 ~~(2) The spouse of a member of the United States armed forces if~~  
18 ~~the member qualifies as a resident under subsection (1), (3), or (4)~~  
19 ~~of this section, or a natural person age eighteen or younger who does~~  
20 ~~not qualify as a resident under subsection (1) of this section, but~~  
21 ~~who has a parent or legal guardian who qualifies as a resident under~~  
22 ~~subsection (1), (3), or (4) of this section;~~

23 ~~(3) A member of the United States armed forces temporarily~~  
24 ~~stationed in Washington state on predeployment orders. A copy of the~~  
25 ~~person's military orders is required to meet this condition;~~

26 ~~(4) An active duty, nonretired member of the United States armed~~  
27 ~~forces who is permanently stationed in Washington or who designates~~

29 ~~certificate" or enlistment or reenlistment documents. A copy of the~~

33 **Sec. 3.** RCW 77.32.155 and 2017 c 255 s 1 are each amended to  
34 read as follows:

35 (1) (a) ~~((When purchasing any hunting license, persons under the~~  
36 ~~age of eighteen))~~ All persons purchasing any hunting license for the  
37 first time, if born on or after January 1, 1972, shall present  
38 certification of completion of a course of instruction ~~((of at least~~  
39 ~~ten hours))~~ in the safe handling of firearms, safety, conservation,

1 and sporting/hunting behavior. (~~All persons purchasing any hunting~~  
2 ~~license for the first time, if born after January 1, 1972, shall~~  
3 ~~present such certification.~~)

4 (b) (i) The director may establish a program for training persons  
5 in the safe handling of firearms, conservation, and sporting/hunting  
6 behavior and shall prescribe the type of instruction and the  
7 qualifications of the instructors. The director shall, as part of  
8 establishing the training program, exempt the following individuals  
9 from the firearms skills portion of any instruction course completed  
10 over the internet:

11 (A) (~~Members~~) Current or retired members of the United States  
12 military;

13 (B) Current or retired general authority Washington peace  
14 officers as defined in RCW 10.93.020;

15 (C) Current or retired limited authority Washington peace  
16 officers as defined in RCW 10.93.020, if the officer is or was duly  
17 authorized by his or her employer to carry a concealed pistol;

18 (D) Current or retired specially commissioned Washington peace  
19 officers as defined in RCW 10.93.020, if the officer is or was duly  
20 authorized by his or her commissioning agency to carry a concealed  
21 pistol; (~~and~~)

22 (E) Current or retired Washington peace officers as defined in  
23 RCW 43.101.010 who have met the requirements of RCW 43.101.095 or  
24 43.101.157 and whose certification is in good standing or has not  
25 been revoked; and

26 (F) Current or retired federal peace officers as defined in RCW  
27 10.93.020.

28 (ii) The director may cooperate with the national rifle  
29 association, organized sports/outdoor enthusiasts' groups, or other  
30 public or private organizations when establishing the training  
31 program.

32 (c) Upon the successful completion of a course established under  
33 this section, the trainee shall receive a hunter education  
34 certificate signed by an authorized instructor. The certificate is  
35 evidence of compliance with this section.

36 (d) The director may accept certificates from other states that  
37 persons have successfully completed firearm safety, hunter education,  
38 or similar courses as evidence of compliance with this section.

39 (2) (a) The director may authorize a once in a lifetime, one  
40 license year deferral of hunter education training for individuals

1 who are accompanied, while hunting, by a nondeferred Washington-  
2 licensed hunter who (~~has held a Washington hunting license for the~~  
3 ~~prior three years and is over eighteen~~) is at least 18 years of age.  
4 The commission shall adopt rules for the administration of this  
5 subsection to avoid potential fraud and abuse.

6 (b) The director is authorized to collect an application fee, not  
7 to exceed (~~twenty dollars~~) \$20, for obtaining the once in a  
8 lifetime, one license year deferral of hunter education training from  
9 the department. This fee must be deposited into the fish and wildlife  
10 enforcement reward account and must be used exclusively to administer  
11 the deferral program created in this subsection.

12 (c) For the purposes of this subsection, "accompanied" means to  
13 go along with another person while staying within a range of the  
14 other person that permits continual unaided visual and auditory  
15 communication.

16 (3) To encourage the participation of an adequate number of  
17 instructors for the training program, the commission shall develop  
18 nonmonetary incentives available to individuals who commit to serving  
19 as an instructor. The incentives may include additional hunting  
20 opportunities for instructors.

21 (4) The commission is authorized to adopt rules to offer a one-  
22 time discount of up to \$20 on a hunting license purchase to first-  
23 time resident hunters who have completed the Washington hunter  
24 education training program.

25 **Sec. 4.** RCW 77.32.470 and 2020 c 148 s 20 are each amended to  
26 read as follows:

27 (1) A personal use saltwater, freshwater, combination, or  
28 temporary(~~(, or family fishing weekend)~~) license is required for all  
29 persons (~~fifteen~~) 16 years of age or older to fish for or possess  
30 fish taken for personal use from state waters or offshore waters.

31 (2) The fees for annual personal use saltwater, freshwater, or  
32 combination licenses are as follows:

33 (a) A combination license allows the holder to fish for or  
34 possess fish, shellfish, and seaweed from state waters or offshore  
35 waters. The fee for this license is (~~forty-five dollars~~) \$45 for  
36 residents(~~(, one hundred eight dollars)~~) and \$108 for nonresidents(~~(,~~  
37 ~~and five dollars for youth)~~). There is an additional (~~fifty-cent~~)  
38 50 cent surcharge for this license, to be deposited in the rockfish  
39 research account created in RCW 77.12.702.

1 (b) A saltwater license allows the holder to fish for or possess  
2 fish taken from saltwater areas. The fee for this license is  
3 ~~((twenty-five dollars))~~ \$25 for residents, ~~((fifty-two dollars))~~ \$52  
4 for nonresidents, and five dollars for resident seniors. There is an  
5 additional ~~((fifty-cent))~~ 50 cent surcharge for this license, to be  
6 deposited in the rockfish research account created in RCW 77.12.702.

7 (c) A freshwater license allows the holder to fish for, take, or  
8 possess food fish or game fish species in all freshwater areas. The  
9 fee for this license is ~~((twenty-five dollars))~~ \$25 for residents,  
10 ~~((seventy-five dollars))~~ \$75 for nonresidents, and five dollars for  
11 resident seniors.

12 (3)(a) A temporary combination fishing license is valid for one  
13 to three consecutive days and allows the holder to fish for or  
14 possess fish, shellfish, and seaweed taken from state waters or  
15 offshore waters. The fee for this temporary fishing license is:

16 (i) One day - ~~((Eight dollars))~~ \$8 for residents and ~~((sixteen~~  
17 ~~dollars))~~ \$16 for nonresidents;

18 (ii) Two days - ~~((Twelve dollars))~~ \$12 for residents and  
19 ~~((twenty-four dollars))~~ \$24 for nonresidents; and

20 (iii) Three days - ~~((Fifteen dollars))~~ \$15 for residents and  
21 ~~((thirty dollars))~~ \$30 for nonresidents.

22 (b) The fee for a charter stamp is eight dollars for a one-day  
23 temporary combination fishing license for residents and nonresidents  
24 for use on a charter boat as defined in RCW 77.65.150.

25 (c) ~~((Except for active duty military personnel serving in any~~  
26 ~~branch of the United States armed forces, the temporary combination~~  
27 ~~fishing license is not valid on game fish species for an eight-~~  
28 ~~consecutive-day period beginning on the opening day of the lowland~~  
29 ~~lake fishing season as defined by rule of the commission.~~

30 ~~((d))~~) The temporary combination fishing license fee for active  
31 duty military personnel serving in any branch of the United States  
32 armed forces is the resident rate ~~((as set forth in (a) of this~~  
33 ~~subsection))~~. Active duty military personnel must provide a valid  
34 military identification card at the time of purchase of the temporary  
35 license to qualify for the resident rate.
