29 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

30 <u>NEW SECTION.</u> Sec. 1. RCW 1.08.025 directs the code reviser, 31 with the approval of the statute law committee, to prepare 32 legislation for submission to the legislature "concerning 33 deficiencies, conflicts, or obsolete provisions" in statutes. This 34 act makes technical, nonsubstantive amendments as follows:

(1) Section 1001 of this act places legislatively recognized daysin calendar order.

37 (2) Section 1002 of this act corrects a cross reference38 concerning the sentencing of sex offenders.

1 (3) Section 1003 of this act corrects a drafting error concerning 2 the number of hours of supervised experience for licensed advanced 3 social workers.

4 (4) Section 1004 of this act renumbers a definition section in 5 order to combine two subsections defining the term "commercial 6 telephone solicitor."

7 (5) Sections 1005 through 1007 of this act correct errors in
8 internal references of the Washington business corporation act.

9 (6) Section 1008 of this act removes a duplicative cross 10 reference created by merging multiple amendments.

11 (7) Section 1009 of this act corrects a cross reference 12 concerning the definition of liquor retailers.

13 (8) Section 1010 of this act decodifies sections relating to 14 various groups whose work has concluded.

(9) Section 1011 of this act repeals a session law section omitted in error from the repeal of RCW 10.31.115 by chapter 1, Laws of 2023 sp. sess.

18 (10) Sections 2001 through 2051 of this act adjust cross 19 references to reflect recodification of sections and changes in 20 subsection numbering.

(11) Sections 3001 through 3011 of this act merge multiple amendments created when sections were amended without reference to other amendments made in the same session.

(12) Sections 4001 through 4010 of this act change the term
 "marijuana" to "cannabis" in uncodified notes published in the
 Revised Code of Washington.

(13) Sections 5001 through 5172 of this act change the term "nursing care quality assurance commission" to "state board of nursing," in accordance with chapter 123, Laws of 2023, and "advanced registered nurse practitioner" to "advanced practice registered nurse," in accordance with chapter 239, Laws of 2024.

## PART I

#### GENERAL CORRECTIONS

34 Sec. 1001. RCW 1.16.050 and 2024 c 76 s 3 are each amended to 35 read as follows:

36 (1) The following are state legal holidays:

37 (a) Sunday;

38 (b) The first day of January, commonly called New Year's Day;

(c) The third Monday of January, celebrated as the anniversary of
 the birth of Martin Luther King, Jr.;

3 (d) The third Monday of February, to be known as Presidents' Day
4 and celebrated as the anniversary of the births of Abraham Lincoln

(e) The last Monday of May, commonly known as Memorial Day;

10 (g) The fourth day of July, the anniversary of the Declaration of 11 Independence;

12 (h) The first Monday in September, to be known as Labor Day;

13 (i) The eleventh day of November, to be known as Veterans Day;

14 (j) The fourth Thursday in November, to be known as Thanksgiving 15 Day;

16 (k) The Friday immediately following the fourth Thursday in17 November, to be known as Native American Heritage Day; and

18 (1) The twenty-fifth day of December, commonly called Christmas 19 Day.

(2) Employees of the state and its political subdivisions, except 20 21 employees of school districts and except those nonclassified employees of institutions of higher education who hold appointments 22 or are employed under contracts to perform services for periods of 23 less than twelve consecutive months, are entitled to one paid holiday 24 25 per calendar year in addition to those specified in this section. Each employee of the state or its political subdivisions may select 26 the day on which the employee desires to take the additional holiday 27 28 provided for in this section after consultation with the employer pursuant to guidelines to be promulgated by rule of the appropriate 29 personnel authority, or in the case of local government by ordinance 30 31 or resolution of the legislative authority.

32 (3) Employees of the state and its political subdivisions, including employees of school districts and those nonclassified 33 employees of institutions of higher education who hold appointments 34 or are employed under contracts to perform services for periods of 35 less than twelve consecutive months, are entitled to two unpaid 36 holidays per calendar year for a reason of faith or conscience or an 37 organized activity conducted under the auspices of a religious 38 39 denomination, church, or religious organization. This includes 40 employees of public institutions of higher education, including

1 community colleges, technical colleges, and workforce training programs. The employee may select the days on which the employee 2 desires to take the two unpaid holidays after consultation with the 3 employer pursuant to guidelines to be promulgated by rule of the 4 appropriate personnel authority, or in the case of local government 5 6 by ordinance or resolution of the legislative authority. If an employee prefers to take the two unpaid holidays on specific days for 7 a reason of faith or conscience, or an organized activity conducted 8 under the auspices of a religious denomination, church, or religious 9 organization, the employer must allow the employee to do so unless 10 11 the employee's absence would impose an undue hardship on the employer 12 or the employee is necessary to maintain public safety. Undue hardship shall have the meaning established in rule by the office of 13 14 financial management under RCW 43.41.109.

(4) If any of the state legal holidays specified in this section 15 16 are also federal legal holidays but observed on different dates, only 17 the state legal holidays are recognized as a paid legal holiday for 18 employees of the state and its political subdivisions. However, for port districts and the law enforcement and public transit employees 19 of municipal corporations, either the federal or the state legal 20 21 holiday is recognized as a paid legal holiday, but in no case may 22 both holidays be recognized as a paid legal holiday for employees.

(5) Whenever any state legal holiday:

(a) Other than Sunday, falls upon a Sunday, the following Mondayis the legal holiday; or

26 (b) Falls upon a Saturday, the preceding Friday is the legal 27 holiday.

(6) Nothing in this section may be construed to have the effect of adding or deleting the number of paid holidays provided for in an agreement between employees and employers of political subdivisions of the state or as established by ordinance or resolution of the local government legislative authority.

7 (iii) An attempt to commit any crime listed in this subsection 8 (1)(a); or

9 (b) Has a prior conviction for an offense listed in RCW 10 9.94A.030((<del>(31)(b)</del>)) <u>(37)(b)</u>, and is convicted of any sex offense 11 other than failure to register.

12 (2) An offender convicted of rape of a child in the first or 13 second degree or child molestation in the first degree who was 14 seventeen years of age or younger at the time of the offense shall 15 not be sentenced under this section.

16 (3) (a) Upon a finding that the offender is subject to sentencing 17 under this section, the court shall impose a sentence to a maximum 18 term and a minimum term.

19 (b) The maximum term shall consist of the statutory maximum 20 sentence for the offense.

(c) (i) Except as provided in (c) (ii) of this subsection, the minimum term shall be either within the standard sentence range for the offense, or outside the standard sentence range pursuant to RCW 9.94A.535, if the offender is otherwise eligible for such a sentence.

25 (ii) If the offense that caused the offender to be sentenced 26 under this section was rape of a child in the first degree, rape of a child in the second degree, or child molestation in the first degree, 27 and there has been a finding that the offense was predatory under RCW 28 9.94A.836, the minimum term shall be either the maximum of the 29 standard sentence range for the offense or twenty-five years, 30 31 whichever is greater. If the offense that caused the offender to be 32 sentenced under this section was rape in the first degree, rape in the second degree, indecent liberties by forcible compulsion, or 33 kidnapping in the first degree with sexual motivation, and there has 34 been a finding that the victim was under the age of fifteen at the 35 time of the offense under RCW 9.94A.837, the minimum term shall be 36 either the maximum of the standard sentence range for the offense or 37 twenty-five years, whichever is greater. If the offense that caused 38 39 the offender to be sentenced under this section is rape in the first degree, rape in the second degree with forcible compulsion, indecent 40

liberties with forcible compulsion, or kidnapping in the first degree with sexual motivation, and there has been a finding under RCW 9.94A.838 that the victim was, at the time of the offense, developmentally disabled, mentally disordered, or a frail elder or vulnerable adult, the minimum sentence shall be either the maximum of the standard sentence range for the offense or twenty-five years, whichever is greater.

8 (d) The minimum terms in (c)(ii) of this subsection do not apply 9 to a juvenile tried as an adult pursuant to RCW 13.04.030(1)(e) (i) 10 or (v). The minimum term for such a juvenile shall be imposed under 11 (c)(i) of this subsection.

12 (4) A person sentenced under subsection (3) of this section shall 13 serve the sentence in a facility or institution operated, or utilized 14 under contract, by the state.

15 (5) When a court sentences a person to the custody of the 16 department under this section, the court shall, in addition to the 17 other terms of the sentence, sentence the offender to community 18 custody under the supervision of the department and the authority of 19 the board for any period of time the person is released from total 20 confinement before the expiration of the maximum sentence.

(6) (a) As part of any sentence under this section, the court
shall also require the offender to comply with any conditions imposed
by the board under RCW 9.95.420 through 9.95.435.

(b) An offender released by the board under RCW 9.95.420 is 24 25 subject to the supervision of the department until the expiration of 26 the maximum term of the sentence. 32 Sec. 1003. RCW 18.225.090 and 2024 c 371 s 14 are each amended 33 to read as follows:

(1) The secretary shall issue a license to any applicant who demonstrates to the satisfaction of the secretary that the applicant meets the following education and experience requirements for the applicant's practice area.

38 (a) Licensed social work classifications:

39 (i) Licensed advanced social worker:

1 (A) Graduation from a master's social work educational program 2 accredited by the council on social work education or a social work 3 doctorate program at a university accredited by a recognized 4 accrediting organization, and approved by the secretary based upon 5 nationally recognized standards;

(I) At least 90 hours must include direct supervision as specified in this subsection by a licensed independent clinical social worker, a licensed advanced social worker, or an equally qualified licensed mental health professional. (II) 800 hours must be in direct client contact; and

20 (D) Successful completion of continuing education requirements 21 established in rule by the secretary in consultation with the 22 committee, including a minimum number of hours in professional 23 ethics.

24 (ii) Licensed independent clinical social worker:

(A) Graduation from a master's level social work educational program accredited by the council on social work education or a social work doctorate program at a university accredited by a recognized accrediting organization, and approved by the secretary based upon nationally recognized standards;

(B) Successful completion of an approved examination;

31 (C) Successful completion of a supervised experience requirement. 32 The supervised experience requirement consists of a minimum of 3,000 33 hours of experience, over a period of not less than two years, with supervision by an approved supervisor who has been licensed for at 34 least two years and, as specified in this subsection, may be either a 35 36 licensed independent clinical social worker who has had at least one year of experience in supervising the clinical social work of others 37 or an equally qualified licensed mental health practitioner. Of those 38 39 supervised hours:

40 (I) At least 1,000 hours must be direct client contact; and

1 2 (II) Hours of direct supervision must include:

(1) At least 100 hours by a licensed mental health practitioner;

3 (2) At least 70 hours of supervision with a licensed independent 4 clinical social worker meeting the qualifications under this 5 subsection (1)(a)(ii)(C); the remaining hours may be supervised by an 6 equally qualified licensed mental health practitioner; and

7 (3) At least 60 hours must be in one-to-one supervision and the 8 remaining hours may be in one-to-one supervision or group 9 supervision; and

10 (D) Successful completion of continuing education requirements 11 established in rule by the secretary in consultation with the 12 committee, including a minimum number of hours in professional 13 ethics.

14 (b) Licensed mental health counselor:

(i) (A) Graduation from a master's or doctoral level educational program in counseling that consists of at least 60 semester hours or 90 quarter hours, or includes at least 60 semester hours or 90 quarter hours of graduate coursework that includes the following topic areas:

(I) Mental health counseling orientation and ethical practice;

21 (II) Social and cultural diversity;

22 (III) Human growth and development;

23 (IV) Career development;

24 (V) Counseling and helping relationships;

25 (VI) Group counseling and group work;

26 (VII) Diagnosis and treatment;

27 (VIII) Assessment and testing; and

28 (IX) Research and program evaluation; or

(B) Graduation from a master's or doctoral level educational 29 program in a related discipline from a college or university approved 30 31 by the secretary based upon nationally recognized standards. An 32 applicant who satisfies the educational requirements for licensure 33 under this subsection (1)(b)(i)(B) is not qualified to exercise the privilege to practice under the counseling compact established in 34 chapter 18.17 RCW unless the master's or doctoral level educational 35 program in a related discipline consists of at least 60 semester 36 hours or 90 quarter hours, or includes at least 60 semester hours or 37 90 quarter hours of graduate coursework that includes the topic areas 38 39 specified in (b)(i)(A)(I) through (IX) of this subsection;

40 (ii) Successful completion of an approved examination;

1 (iii) Successful completion of a supervised experience requirement. The experience requirement consists of a minimum of 36 2 months full-time counseling or 3,000 hours of postgraduate mental 3 health counseling under the supervision of a qualified licensed 4 mental health counselor or equally qualified licensed mental health 5 6 practitioner, in an approved setting. The 3,000 hours of required experience includes a minimum of 100 hours spent in immediate 7 supervision with the qualified licensed mental health counselor, and 8 includes a minimum of 1,200 hours of direct counseling with 9 10 individuals, couples, families, or groups; and

(iv) Successful completion of continuing education requirements established in rule by the secretary in consultation with the committee, including a minimum number of hours in professional ethics.

(c) Licensed marriage and family therapist:

16 (i) Graduation from a master's degree or doctoral degree 17 educational program in marriage and family therapy or graduation from 18 an educational program in an allied field equivalent to a master's 19 degree or doctoral degree in marriage and family therapy approved by 20 the secretary based upon nationally recognized standards;

21

(ii) Successful passage of an approved examination;

(iii) Successful completion of a supervised experience requirement. The experience requirement consists of a minimum of 3,000 hours of marriage and family therapy. Of the total supervision, 100 hours must be with a licensed marriage and family therapist with at least two years' clinical experience; the other 100 hours may be with an equally qualified licensed mental health practitioner. Total experience requirements include:

(A) 1,000 hours of direct client contact; at least 500 hours must
 be gained in diagnosing and treating couples and families; plus

31 (B) At least 200 hours of qualified supervision with a 32 supervisor. At least 100 of the 200 hours must be one-on-one 33 supervision, and the remaining hours may be in one-on-one or group 34 supervision.

The written findings and conclusions shall be provided to the local government, and made available to all 23 24 interested persons, parties, groups, and agencies of record on the 25 proposal;

(e) If the department recommends changes to the proposed master program or amendment, within thirty days after the department mails the written findings and conclusions to the local government, the local government may:

30 (i) Agree to the proposed changes by written notice to the 31 department; or

(ii) Submit an alternative proposal. If, in the opinion of the 32 department, the alternative is consistent with the purpose and intent 33 of the changes originally submitted by the department and with this 34 chapter it shall approve the changes and provide notice to all 35 36 recipients of the written findings and conclusions. 5 (4) The department shall approve the segment of a master program 6 relating to critical areas as defined by RCW 36.70A.030((<del>(5)</del>)) 7 provided the master program segment is consistent with RCW 90.58.020 8 and applicable shoreline guidelines, and if the segment provides a 9 level of protection of critical areas at least equal to that provided 10 by the local government's critical areas ordinances adopted and 11 thereafter amended pursuant to RCW 36.70A.060(2).

12 (5) The department shall approve those segments of the master program relating to shorelines of statewide significance only after 13 determining the program provides the optimum implementation of the 14 policy of this chapter to satisfy the statewide interest. If the 15 16 department does not approve a segment of a local government master 17 program relating to a shoreline of statewide significance, the 18 department may develop and by rule adopt an alternative to the local 19 government's proposal.

(6) In the event a local government has not complied with the requirements of RCW 90.58.070 it may thereafter upon written notice to the department elect to adopt a master program for the shorelines within its jurisdiction, in which event it shall comply with the provisions established by this chapter for the adoption of a master program for such shorelines.

26 Upon approval of such master program by the department it shall 27 supersede such master program as may have been adopted by the 28 department for such shorelines.

29 (7) A master program or amendment to a master program takes effect when and in such form as approved or adopted by the 30 31 department. 25 Sec. 3001. RCW 18.130.175 and 2023 c 469 s 19 and 2023 c 425 s 26 25 are each reenacted and amended to read as follows:

(1) In lieu of disciplinary action under RCW 18.130.160 and if the disciplining authority determines that the unprofessional conduct may be the result of an applicable impairing or potentially impairing health condition, the disciplining authority may refer the license holder to a physician health program or a voluntary substance use disorder monitoring program approved by the disciplining authority.

33 The cost of evaluation and treatment shall be the responsibility 34 of the license holder, but the responsibility does not preclude 35 payment by an employer, existing insurance coverage, or other 36 sources. Evaluation and treatment shall be provided by providers 37 approved by the entity or the commission. The disciplining authority

may also approve the use of out-of-state programs. Referral of the 1 license holder to the physician health program or voluntary substance 2 use disorder monitoring program shall be done only with the consent 3 of the license holder. Referral to the physician health program or 4 voluntary substance use disorder monitoring program may also include 5 6 probationary conditions for a designated period of time. If the license holder does not consent to be referred to the program or does 7 not successfully complete the program, the disciplining authority may 8 take appropriate action under RCW 18.130.160 which 9 includes suspension of the license unless or until the disciplining authority, 10 11 in consultation with the director of the applicable program, 12 determines the license holder is able to practice safely. The secretary shall adopt uniform rules for the evaluation by the 13 disciplining authority of return to substance use or program 14 violation on the part of a license holder in the program. 15 The 16 evaluation shall encourage program participation with additional 17 conditions, in lieu of disciplinary action, when the disciplining authority determines that the license holder is able to continue to 18 19 practice with reasonable skill and safety.

(2) In addition to approving the physician health program or the 20 21 voluntary substance use disorder monitoring program that may receive referrals from the disciplining authority, the disciplining authority 22 23 may establish by rule requirements for participation of license who are not being investigated or monitored by the 24 holders 25 disciplining authority. License holders voluntarily participating in the approved programs without being referred by the disciplining 26 27 authority shall not be subject to disciplinary action under RCW 28 18.130.160 for their impairing or potentially impairing health condition, and shall not have their participation made known to the 29 disciplining authority, if they meet the requirements of this section 30 31 and the program in which they are participating.

32 (3) The license holder shall sign a waiver allowing the program to release information to the disciplining authority if the licensee 33 does not comply with the requirements of this section or is unable to 34 practice with reasonable skill or safety. The physician health 35 program or voluntary substance use disorder program shall report to 36 the disciplining authority any license holder who fails to comply 37 with the requirements of this section or the program or who, in the 38 39 opinion of the program, is unable to practice with reasonable skill 40 or safety. License holders shall report to the disciplining authority

1 if they fail to comply with this section or do not complete the 2 program's requirements. License holders may, upon the agreement of 3 the program and disciplining authority, reenter the program if they 4 have previously failed to comply with this section.

(4) Program records including, but not limited to, case notes, 5 6 progress notes, laboratory reports, evaluation and treatment records, electronic and written correspondence within the program, and between 7 the program and the participant or other involved entities including, 8 but not limited to, employers, credentialing bodies, referents, or 9 other collateral sources, relating to license holders referred to or 10 11 voluntarily participating in approved programs are confidential and 12 exempt from disclosure under chapter 42.56 RCW and shall not be subject to discovery by subpoena or admissible as evidence except: 13

(a) To defend any civil action by a license holder regarding the restriction or revocation of that individual's clinical or staff privileges, or termination of a license holder's employment. In such an action, the program will, upon subpoena issued by either party to the action, and upon the requesting party seeking a protective order for the requested disclosure, provide to both parties of the action written disclosure that includes the following information:

(i) Verification of a health care professional's participation in the physician health program or voluntary substance use disorder monitoring program as it relates to aspects of program involvement at issue in the civil action;

(ii) The dates of participation;

26 (iii) Whether or not the program identified an impairing or 27 potentially impairing health condition;

(iv) Whether the health care professional was compliant with the requirements of the physician health program or voluntary substance use disorder monitoring program; and

31 (v) Whether the health care professional successfully completed 32 the physician health program or voluntary substance use disorder 33 monitoring program; and

34 (b) Records provided to the disciplining authority for cause as 35 described in subsection (3) of this section. Program records relating 36 to license holders mandated to the program, through order or by 37 stipulation, by the disciplining authority or relating to license 38 holders reported to the disciplining authority by the program for 39 cause, must be released to the disciplining authority at the request 40 of the disciplining authority. Records held by the disciplining 1 authority under this section are exempt from chapter 42.56 RCW and 2 are not subject to discovery by subpoena except by the license 3 holder.

4 (5) This section does not affect an employer's right or ability
5 to make employment-related decisions regarding a license holder. This
6 section does not restrict the authority of the disciplining authority
7 to take disciplinary action for any other unprofessional conduct.

8 (6) A person who, in good faith, reports information or takes 9 action in connection with this section is immune from civil liability 10 for reporting information or taking the action.

11 (a) The immunity from civil liability provided by this section 12 shall be liberally construed to accomplish the purposes of this 13 section, and applies to both license holders and students and 14 trainees when students and trainees of the applicable professions are 15 served by the program. The persons entitled to immunity shall 16 include:

17 (i) An approved physician health program or voluntary substance18 use disorder monitoring program;

19 (ii) The professional association affiliated with the program;

20 (iii) Members, employees, or agents of the program or 21 associations;

(iv) Persons reporting a license holder as being possibly impaired or providing information about the license holder's impairment; and

(v) Professionals supervising or monitoring the course of the program participant's treatment or rehabilitation.

(b) The courts are strongly encouraged to impose sanctions on program participants and their attorneys whose allegations under this subsection are not made in good faith and are without either reasonable objective, substantive grounds, or both.

31 (c) The immunity provided in this section is in addition to any 32 other immunity provided by law.

15 (c) According to the national institute of drug abuse, nearly 16 half of 12th grade students have used illicit drugs, six in 10 have 17 drank alcohol, and four in 10 have used ((marijuana [cannabis])) 18 cannabis;

19 (d) The COVID-19 pandemic has increased the prevalence of and 20 exacerbated existing behavioral health disorders for minors across 21 the state; and

(e) A major barrier to behavioral health support for minors islack of awareness and access to information about existing services.

(2) The legislature intends to require that contact information for a suicide prevention organization, depression or anxiety support organization, eating disorder support organization, substance abuse support organization, and a mental health referral service for children and teens be listed on the home page of each public school website for the following reasons:

30 (a) Immediate access to behavioral health services often prevents31 suicide, attempted suicide, and other self-harm; and

32 (b) Students in public schools often have access to and spend 33 time on the website for their school.

34 Sec. 4002. 2015 c 207 s 1 (uncodified) is amended to read as 35 follows:

36 The legislature intends to further the government-to-government 37 relationship between the state of Washington and federally recognized 38 Indian tribes in the state of Washington by authorizing the governor 39 to enter into agreements concerning the regulation of ((marijuana

1 [cannabis])) cannabis. Such agreements may include provisions pertaining to: The lawful commercial production, processing, sale, 2 3 and possession of ((marijuana [cannabis])) cannabis for both recreational and medical purposes; ((marijuana [cannabis])) cannabis-4 related research activities; law enforcement, both criminal and 5 6 civil; and taxation. The legislature finds that these agreements will 7 facilitate and promote a cooperative and mutually beneficial relationship between the state and the tribes regarding matters 8 relating to the legalization of ((marijuana [cannabis])) cannabis, 9 particularly in light of the fact that federal Indian law precludes 10 11 the state from enforcing its civil regulatory laws in Indian country. 12 Such cooperative agreements will enhance public health and safety, ensure a lawful and well-regulated ((marijuana [cannabis])) cannabis 13 market, encourage economic development, and provide fiscal benefits 14 15 to both the tribes and the state.

16 Sec. 4003. 2015 c 70 s 2 (uncodified) is amended to read as 17 follows:

18 The legislature finds that since voters approved Initiative Measure No. 692 in 1998, it has been the public policy of the state 19 20 to permit the medical use of ((marijuana [cannabis])) cannabis. 21 Between 1998 and the present day, there have been multiple legislative attempts to clarify what is meant by the medical use of 22 ((marijuana [cannabis])) cannabis and to ensure qualifying patients 23 24 have a safe, consistent, and adequate source of ((marijuana [cannabis])) cannabis for their medical needs. 25

The legislature further finds that qualifying patients are people 26 27 with serious medical conditions and have been responsible for finding 28 their own source of ((marijuana [cannabis])) cannabis for their own personal medical use. Either by growing it themselves, designating 29 someone to grow for them, or participating in collective gardens, 30 31 patients have developed methods of access in spite of continued federal opposition to the medical use of ((marijuana [cannabis])) 32 cannabis. In a time when access itself was an issue and no safe, 33 consistent source of ((marijuana [cannabis])) cannabis was available, 34 this unregulated system was permitted by the state to ensure some, 35 albeit limited, access to ((marijuana [cannabis])) cannabis for 36 medical use. Also permitted were personal possession limits of 37 38 fifteen plants and twenty-four ounces of useable ((marijuana (cannabis)) cannabis, which was deemed to be the amount of 39

1 ((marijuana [cannabis])) cannabis needed for a sixty-day supply. In a
2 time when supply was not consistent, this amount of ((marijuana
3 [cannabis])) cannabis was necessary to ensure patients would be able
4 to address their immediate medical needs.

The legislature further finds that while possession amounts are 5 6 provided in statute, these do not amount to protection from arrest and prosecution for patients. In fact, patients in compliance with 7 state law are not provided arrest protection. They may be arrested 8 and their only remedy is to assert an affirmative defense at trial 9 that they are in compliance with the law and have a medical need. Too 10 11 many patients using ((marijuana [cannabis])) cannabis for medical 12 purposes today do not know this; many falsely believe they cannot be arrested so long as their health care provider has authorized them 13 for the medical use of ((marijuana [cannabis])) cannabis. 14

15 legislature further finds that in 2012 voters passed The 16 Initiative Measure No. 502 which permitted the recreational use of ((marijuana [cannabis])) cannabis. For the first time in our nation's 17 history, ((marijuana [cannabis])) cannabis would be regulated, taxed, 18 19 and sold for recreational consumption. Initiative Measure No. 502 provides for strict regulation on the production, processing, and 20 21 distribution of ((marijuana [cannabis])) cannabis. Under Initiative Measure No. 502, ((marijuana [cannabis])) cannabis is trackable from 22 23 seed to sale and may only be sold or grown under license. ((Marijuana [Cannabis])) Cannabis must be tested for impurities and purchasers of 24 25 ((marijuana [cannabis])) cannabis must be informed of the THC level in the ((marijuana [cannabis])) cannabis. Since its passage, two 26 27 hundred fifty producer/processor licenses and sixty-three retail 28 licenses have been issued, covering the majority of the state. With the current product canopy exceeding 2.9 million square feet, and 29 retailers in place, the state now has a system of safe, consistent, 30 31 and adequate access to ((marijuana [cannabis])) cannabis; the 32 marketplace is not the same marketplace envisioned by the voters in 1998. While medical needs remain, the state is in the untenable 33 position of having a recreational product that is tested and subject 34 to production standards that ensure safe access for recreational 35 users. No such standards exist for medical users and, consequently, 36 the very people originally meant to be helped through the medical use 37 of ((marijuana [cannabis])) cannabis do not know if their product has 38 been tested for molds, do not know where their ((marijuana 39 40 [cannabis])) cannabis has been grown, have no certainty in the level

of THC or CBD in their products, and have no assurances that their products have been handled through quality assurance measures. It is not the public policy of the state to allow qualifying patients to only have access to products that may be endangering their health.

The legislature, therefore, intends to adopt a comprehensive act 5 6 that uses the regulations in place for the recreational market to provide regulation for the medical use of ((marijuana [cannabis])) 7 cannabis. It intends to ensure that patients retain their ability to 8 grow their own ((marijuana [cannabis])) cannabis for their own 9 medical use and it intends to ensure that patients have the ability 10 11 to possess more ((marijuana [cannabis])) cannabis-infused products, useable ((marijuana [cannabis])) <u>cannabis</u>, and ((marijuana 12 [cannabis])) cannabis concentrates than what is available to a 13 14 nonmedical user. It further intends that medical specific regulations be adopted as needed and under consultation of the departments of 15 16 health and agriculture so that safe handling practices will be 17 adopted and so that testing standards for medical products meet or exceed those standards in use in the recreational market. 18

19 The legislature further intends that the costs associated with 20 implementing and administering the medical ((marijuana [cannabis])) 21 <u>cannabis</u> authorization database shall be financed from the health 22 professions account and that these funds shall be restored to the 23 health professions account through future appropriations using funds 24 derived from the dedicated ((marijuana [cannabis])) <u>cannabis</u> account.

The people intend to stop treating adult ((marijuana [cannabis])) cannabis use as a crime and try a new approach that:

(1) Allows law enforcement resources to be focused on violent andproperty crimes;

31 (2) Generates new state and local tax revenue for education,32 health care, research, and substance abuse prevention; and

(3) Takes ((marijuana [cannabis])) <u>cannabis</u> out of the hands of
 illegal drug organizations and brings it under a tightly regulated,
 state-licensed system similar to that for controlling hard alcohol.

36 This measure authorizes the state liquor control board to 37 regulate and tax ((marijuana [cannabis])) <u>cannabis</u> for persons 38 twenty-one years of age and older, and add a new threshold for 39 driving under the influence of ((marijuana [cannabis])) <u>cannabis</u>. 1 Sec. 4005. 2017 c 317 s 12 (uncodified) is amended to read as
2 follows:

The legislature finds that protecting the state's children, 3 youth, and young adults under the legal age to purchase and consume 4 ((marijuana [cannabis])) <u>cannabis</u>, by establishing limited 5 6 restrictions on the advertising of ((marijuana [cannabis])) cannabis and ((marijuana [cannabis])) cannabis products, is necessary to 7 assist the state's efforts to discourage and prevent underage 8 consumption and the potential risks associated with underage 9 consumption. The legislature finds that these restrictions assist the 10 in maintaining a strong and effective regulatory and 11 state enforcement system as specified by the federal government. The 12 legislature finds this act leaves ample opportunities for licensed 13 ((marijuana [cannabis])) cannabis businesses to market their products 14 to those who are of legal age to purchase them, without infringing on 15 16 the free speech rights of business owners. Finally, the legislature 17 finds that the state has a substantial and compelling interest in enacting this act aimed at protecting Washington's children, youth, 18 19 and young adults.

20 Sec. 4006. 2015 2nd sp.s. c 4 s 101 (uncodified) is amended to 21 read as follows:

22 (1) (a) The legislature finds the implementation of Initiative Measure No. 502 has established a clearly disadvantaged regulated 23 24 legal market with respect to prices and the ability to compete with the unregulated medical dispensary market and the illicit market. The 25 legislature further finds that it is crucial that the state continues 26 27 to ensure a safe, highly regulated system in Washington that protects valuable state revenues while continuing efforts towards disbanding 28 29 the unregulated ((marijuana [cannabis])) cannabis markets. The 30 legislature further finds that ongoing evaluation on the impact of 31 meaningful ((marijuana [cannabis])) cannabis tax reform for the purpose of stabilizing revenues is crucial to the overall effort of 32 protecting the citizens and resources of this state. The legislature 33 further finds that a partnership with local jurisdictions in this 34 effort is imperative to the success of the legislature's policy 35 objective. The legislature further finds that sharing revenues to 36 promote a successful partnership in achieving the legislature's 37 38 intent should be transparent and hold local jurisdictions accountable for their use of state shared revenues. The legislature further 5 6 intends to share ((marijuana [cannabis])) cannabis tax revenues with local jurisdictions for public safety purposes and to facilitate the 7 ongoing process of ensuring a safe regulated ((marijuana [cannabis])) 8 cannabis market in all communities across the state. 9

10 The legislature further finds ((marijuana [cannabis])) (b) cannabis use for qualifying patients is a valid and necessary option 11 12 health care professionals may recommend for their patients. 4 (c) It is the legislature's specific public policy objective to 5 provide qualifying patients and their designated providers a retail 6 sales and use tax exemption on ((marijuana [cannabis])) <u>cannabis</u> 7 purchased or obtained for medical use when authorized by a health 8 care professional.

9 (d) To measure the effectiveness of the exemption provided in 10 chapter 4, Laws of 2015 2nd sp. sess. in achieving the specific 11 public policy objective described in (c) of this subsection, the 12 department of revenue must provide the necessary data and assistance 13 to the state liquor and cannabis board for the report required in RCW 14 69.50.535.

15 Sec. 4007. 2020 c 236 s 1 (uncodified) is amended to read as 16 follows:

(1) The legislature finds that additional efforts are necessary 17 18 to reduce barriers to entry to the cannabis industry for individuals and communities most adversely impacted by the enforcement of 19 20 cannabis-related laws. In the interest of establishing a cannabis 21 industry that is equitable and accessible to those most adversely 22 impacted by the enforcement of drug-related laws, including cannabisrelated laws, the legislature finds a social equity program should be 23 24 created.

25 (2) The legislature finds that individuals who have been arrested or incarcerated due to drug laws, and those who have resided in areas 26 27 of high poverty, suffer long-lasting adverse consequences, including impacts to employment, business ownership, housing, health, and long-28 term financial well-being. It is the intent of the legislature that implementation 9 of the social equity program authorized by this act not result in an 10 11 increase in the number of ((marijuana [cannabis])) cannabis retailer 12 licenses above the limit on the number of ((marijuana [cannabis])) 13 cannabis retailer licenses in the state established by the 14 (([Washington state liquor and cannabis])) Washington state liquor and cannabis board before January 1, 2020. 15

16 Sec. 4008. 2020 c 133 s 1 (uncodified) is amended to read as 17 follows:

18 The legislature finds that recent reports of lung illnesses 19 associated with vapor products demand serious attention by the state 20 in the interest of protecting public health and preventing youth 21 access. While state law grants the liquor and cannabis board broad authority to regulate vapor products containing ((marijuana 22 [cannabis])) cannabis, the legislature finds that risks to public 23 24 health and youth access can be mitigated by clarifying that the board 25 is granted specific authority to prohibit the use of any additive, 26 solvent, ingredient, or compound in ((marijuana [cannabis])) cannabis 27 vapor product production and processing and to prohibit any device 28 used in conjunction with a ((marijuana [cannabis])) cannabis vapor 29 product.

30 Sec. 4009. 2019 c 393 s 1 (uncodified) is amended to read as 31 follows:

The legislature intends to allow additional information on the labels and labeling of ((marijuana [cannabis])) <u>cannabis</u> products to assist consumers in making purchases of these products.

The legislature declares that labels and labeling should not make any disease claim indicating the product is intended for use in the diagnosis, treatment, cure, or prevention of any disease.

1 The legislature recognizes that it may be useful for a label or labeling to describe the intended role of a ((marijuana [cannabis])) 2 3 cannabis product that contains nutrients or other dietary ingredients, including herbs and other botanicals, to maintain a 4 structure or function of the body, or characterize the documented 5 6 mechanism by which the product acts to maintain such structure or 7 function, provided that the claim is truthful and not misleading.

8 Sec. 4010. 2007 c 371 s 1 (uncodified) is amended to read as 9 follows:

10 The legislature intends to clarify the law on medical ((marijuana [cannabis])) cannabis so that the lawful use of this substance is not 11 impaired and medical practitioners are able to exercise their best 12 judgment in the delivery of medical treatment, 13 professional qualifying patients may fully participate in the medical use of 14 15 ((marijuana [cannabis])) cannabis, and designated providers may 16 assist patients in the manner provided by this act without fear of 17 state criminal prosecution. This act is also intended to provide 18 clarification to law enforcement and to all participants in the 19 judicial system.

Training standards and the delivery system shall be relevant 35 36 to the needs of residents served by the assisted living facility and 37 recipients of long-term in-home personal care services and shall be

sufficient to ensure that administrators and caregiving staff have
 the skills and knowledge necessary to provide high quality,
 appropriate care.

(2) The recommendations on training standards and the delivery 4 system developed under subsection (1) of this section shall be based 5 on a review and consideration of the following: Quality of care; 6 availability of training; affordability, including the training costs 7 incurred by the department of social and health services and private 8 providers; portability of existing training requirements; competency 9 testing; practical and clinical coursework; methods of delivery of 10 training; standards for management and caregiving staff training; and 11 12 necessary enhancements for special needs populations and resident rights training. Residents with special needs include, but are not 13 limited to, residents with a diagnosis of mental illness, dementia, 14 or developmental disability. 15

16 Sec. 5002. RCW 18.50.032 and 1994 sp.s. c 9 s 704 are each 17 amended to read as follows:

Registered nurses and nurse midwives certified by the ((nursing care quality assurance commission)) state board of nursing under chapter 18.79 RCW shall be exempt from the requirements and provisions of this chapter.

22 Sec. 5003. RCW 18.79.010 and 1994 sp.s. c 9 s 401 are each 23 amended to read as follows:

24 It is the purpose of the ((nursing care quality assurance commission)) state board of nursing to regulate the competency and 25 26 quality of professional health care providers under its jurisdiction 27 by establishing, monitoring, and enforcing gualifications for licensing, consistent standards of practice, continuing competency 28 29 mechanisms, and discipline. Rules, policies, and procedures developed by the ((commission)) board must promote the delivery of quality 30 31 health care to the residents of the state of Washington.

32 Sec. 5004. RCW 18.79.040 and 2020 c 80 s 15 are each amended to 33 read as follows:

(1) "Registered nursing practice" means the performance of acts
 requiring substantial specialized knowledge, judgment, and skill
 based on the principles of the biological, physiological, behavioral,

7 This section does not prohibit (1) the nursing care of the sick, 8 without compensation, by an unlicensed person who does not hold 9 himself or herself out to be an advanced registered nurse 10 practitioner, or (2) the practice of registered nursing by a licensed 11 registered nurse or the practice of licensed practical nursing by a 12 licensed practical nurse.

13 Sec. 5006. RCW 18.79.070 and 2022 c 240 s 32 are each amended to 14 read as follows:

(1) The state ((nursing care quality assurance commission)) board of nursing is established, consisting of fifteen members to be appointed by the governor to four-year terms. The governor shall consider nursing members who are recommended for appointment by the appropriate professional associations in the state. No person may serve as a member of the ((commission)) board for more than two consecutive full terms.

(2) There must be seven registered nurse members, two advanced registered nurse practitioner members, three licensed practical nurse members, and three public members on the ((commission)) <u>board</u>. Each member of the ((commission)) <u>board</u> must be a resident of this state.

(ii) Beginning July 1, 2021, the second training for a 25 26 psychologist, a marriage and family therapist, a mental health 27 counselor, an advanced social worker, an independent clinical social 28 worker, a social worker associate-advanced, or a social worker 29 associate-independent clinical must be either: (A) An advanced 30 training focused on suicide management, suicide care protocols, or 31 effective treatments; or (B) a training in a treatment modality shown 32 to be effective in working with people who are suicidal, including 33 dialectical behavior therapy, collaborative assessment and management 34 of suicide risk, or cognitive behavior therapy-suicide prevention. If a professional subject to the requirements of this subsection has 35 36 already completed the professional's second training prior to July 1, 37 2021, the professional's next training must comply with this 38 subsection. This subsection (2)(a)(ii) does not apply if the licensee demonstrates that the training required by this subsection (2)(a)(ii) 39 40 is not reasonably available.

1 (b)(i) A professional listed in subsection (1)(a) of this section 2 applying for initial licensure may delay completion of the first 3 training required by this section for six years after initial 4 licensure if he or she can demonstrate successful completion of the 5 training required in subsection (1) of this section no more than six 6 years prior to the application for initial licensure.

39 (c) Remuneration also includes settlements or other proceeds 40 received by an individual as a result of a negotiated settlement for

1 termination of an individual written employment contract prior to its 2 expiration date. The proceeds are deemed assigned in the same 3 intervals and in the same amount for each interval as compensation 4 was allocated under the contract.

5

(d) Remuneration does not include:

6

(i) The payment of tips;

7 (ii) Supplemental benefit payments made by an employer to an 8 employee in addition to any paid family or medical leave benefits 9 received by the employee; or

10 (iii) Payments to members of the armed forces of the United 11 States, including the organized militia of the state of Washington, 12 for the performance of duty for periods not exceeding seventy-two 13 hours at a time.

14 (23)(a) "Serious health condition" means an illness, injury,15 impairment, or physical or mental condition that involves:

(i) Inpatient care in a hospital, hospice, or residential medicalcare facility, including any period of incapacity; or

(ii) Continuing treatment by a health care provider. A serious health condition involving continuing treatment by a health care provider includes any one or more of the following:

(A) A period of incapacity of more than three consecutive, full calendar days, and any subsequent treatment or period of incapacity relating to the same condition, that also involves:

(I) Treatment two or more times, within thirty days of the first day of incapacity, unless extenuating circumstances exist, by a health care provider, by a nurse or physician's assistant under direct supervision of a health care provider, or by a provider of health care services, such as a physical therapist, under orders of, or on referral by, a health care provider; or

30 (II) Treatment by a health care provider on at least one occasion 31 which results in a regimen of continuing treatment under the 32 supervision of the health care provider;

(B) Any period of incapacity due to pregnancy, or for prenatalcare;

35 (C) Any period of incapacity or treatment for such incapacity due 36 to a chronic serious health condition. A chronic serious health 37 condition is one which:

38 (I) Requires periodic visits, defined as at least twice a year, 39 for treatment by a health care provider, or by a nurse under direct 40 supervision of a health care provider; 1 (II) Continues over an extended period of time, including 2 recurring episodes of a single underlying condition; and

3 (III) May cause episodic rather than a continuing period of
4 incapacity, including asthma, diabetes, and epilepsy;

5 (D) A period of incapacity which is permanent or long term due to 6 a condition for which treatment may not be effective. The employee or 7 family member must be under the continuing supervision of, but need 8 not be receiving active treatment by, a health care provider, 9 including Alzheimer's, a severe stroke, or the terminal stages of a 10 disease; or

11 (E) Any period of absence to receive multiple treatments, including any period of recovery from the treatments, by a health 12 care provider or by a provider of health care services under orders 13 of, or on referral by, a health care provider, either for: (I) 14 Restorative surgery after an accident or other injury; or (II) a 15 16 condition that would likely result in a period of incapacity of more 17 than three consecutive, full calendar days in the absence of medical 18 intervention or treatment, such as cancer, severe arthritis, or 19 kidney disease.

20 (b) The requirement in (a)(i) and (ii) of this subsection for 21 treatment by a health care provider means an in-person visit to a 22 health care provider. The first, or only, in-person treatment visit 23 must take place within seven days of the first day of incapacity.

(c) Whether additional treatment visits or a regimen of
 continuing treatment is necessary within the thirty-day period shall
 be determined by the health care provider.

(d) The term extenuating circumstances in (a)(ii)(A)(I) of this 27 subsection means circumstances beyond the employee's control that 28 prevent the follow-up visit from occurring as planned by the health 29 care provider. Whether a given set of circumstances are extenuating 30 31 depends on the facts. For example, extenuating circumstances exist if 32 a health care provider determines that a second in-person visit is needed within the thirty-day period, but the health care provider 33 does not have any available appointments during that time period. 34

35 (e) Treatment for purposes of (a) of this subsection includes, 36 but is not limited to, examinations to determine if a serious health 37 condition exists and evaluations of the condition. Treatment does not 38 include routine physical examinations, eye examinations, or dental 39 examinations. Under (a)(ii)(A)(II) of this subsection, a regimen of 40 continuing treatment includes, but is not limited to, a course of

prescription medication, such as an antibiotic, or therapy requiring 1 special equipment to resolve or alleviate the health condition, such 2 as oxygen. A regimen of continuing treatment that includes taking 3 over-the-counter medications, such as aspirin, antihistamines, or 4 salves, or bed rest, drinking fluids, exercise, and other similar 5 6 activities that can be initiated without a visit to a health care provider, is not, by itself, sufficient to constitute a regimen of 7 continuing treatment for purposes of this title. 8

(f) Conditions for which cosmetic treatments are administered, 9 such as most treatments for acne or plastic surgery, are not serious 10 11 health conditions unless inpatient hospital care is required or 12 unless complications develop. Ordinarily, unless complications arise, the common cold, the flu, ear aches, upset stomach, minor ulcers, 13 headaches other than migraines, routine dental or orthodontia 14 problems, and periodontal disease are examples of conditions that are 15 16 not serious health conditions and do not qualify for leave under this 17 title. Restorative dental or plastic surgery after an injury or removal of cancerous growths are serious health conditions provided 18 all the other conditions of this section are met. Mental illness 19 resulting from stress or allergies may be serious health conditions, 20 21 but only if all the conditions of this section are met.

(g) (i) Substance abuse may be a serious health condition if the conditions of this section are met. However, leave may only be taken for treatment for substance abuse by a health care provider or by a licensed substance abuse treatment provider. Absence because of the employee's use of the substance, rather than for treatment, does not qualify for leave under this title.

28 (ii) Treatment for substance abuse does not prevent an employer 29 from taking employment action against an employee. The employer may not take action against the employee because the employee has 30 31 exercised his or her right to take medical leave for treatment. 32 However, if the employer has an established policy, applied in a nondiscriminatory manner that has been communicated to all employees, 33 that provides under certain circumstances an employee may be 34 terminated for substance abuse, pursuant to that policy the employee 35 36 may be terminated whether or not the employee is presently taking medical leave. An employee may also take family leave to care for a 37 covered family member who is receiving treatment for substance abuse. 38 39 The employer may not take action against an employee who is providing

1 care for a covered family member receiving treatment for substance 2 abuse.

(h) Absences attributable to incapacity under (a)(ii)(B) or (C) 3 of this subsection qualify for leave under this title even though the 4 employee or the family member does not receive treatment from a 5 6 health care provider during the absence, and even if the absence does 7 not last more than three consecutive, full calendar days. For example, an employee with asthma may be unable to report for work due 8 to the onset of an asthma attack or because the employee's health 9 care provider has advised the employee to stay home when the pollen 10 11 count exceeds a certain level. An employee who is pregnant may be 12 unable to report to work because of severe morning sickness.

13 (24) "Service is localized in this state" has the same meaning as 14 described in RCW 50.04.120.

15 (25) "Spouse" means a husband or wife, as the case may be, or 16 state registered domestic partner.

17 (26) "State average weekly wage" means the most recent average 18 weekly wage calculated under RCW 50.04.355 and available on January 19 1st of each year.

(27) "Supplemental benefit payments" means payments made by an
employer to an employee as salary continuation or as paid time off.
Such payments must be in addition to any paid family or medical leave
benefits the employee is receiving.

(28) "Typical workweek hours" means:

(a) For an hourly employee, the average number of hours workedper week by an employee within the qualifying period; and

(b) Forty hours for a salaried employee, regardless of the numberof hours the salaried employee typically works.

30 (a) For the purpose of premium assessment, the remuneration paid 31 by an employer to an employee. The maximum wages subject to a premium 32 assessment are those wages as set by the commissioner under RCW 33 50A.10.030;

(b) For the purpose of payment of benefits, the remuneration paid by one or more employers to an employee for employment during the employee's qualifying period. At the request of an employee, wages may be calculated on the basis of remuneration payable. The department shall notify each employee that wages are calculated on the basis of remuneration paid, but at the employee's request a 1 redetermination may be performed and based on remuneration payable;

3 (c) For the purpose of a self-employed person electing coverage 4 under RCW 50A.10.010, the meaning is defined by rule.

5 Sec. 5112. RCW 51.04.030 and 2024 c 62 s 16 are each amended to 6 read as follows:

(1) The director shall supervise the providing of prompt and 7 efficient care and treatment, including care provided by physician 8 assistants governed by the provisions of chapter 18.71A RCW, 9 including chiropractic care, and including care provided by licensed 10 advanced ((registered nurse practitioners)) practice registered 11 nurses, to workers injured during the course of their employment at 12 the least cost consistent with promptness and efficiency, without 13 discrimination or favoritism, and with as great uniformity as the 14 15 various and diverse surrounding circumstances and locations of 16 industries will permit and to that end shall, from time to time, establish and adopt and supervise the administration of printed 17 forms, rules, regulations, and practices for the furnishing of such 18 care and treatment: PROVIDED, That the medical coverage decisions of 19 20 the department do not constitute a "rule" as used in RCW 34.05.010(16), nor are such decisions subject to the rule-making 21 22 provisions of chapter 34.05 RCW except that criteria for establishing medical coverage decisions shall be adopted by rule 23 after 24 consultation with the workers' compensation advisory committee established in RCW 51.04.110: PROVIDED FURTHER, That the department 25 may recommend to an injured worker particular health care services 26 27 and providers where specialized treatment is indicated or where costeffective payment levels or rates are obtained by the department: AND 28 PROVIDED FURTHER, That the department may enter into contracts for 29 30 goods and services including, but not limited to, durable medical 31 equipment so long as statewide access to quality service is maintained for injured workers. 32

(3) Employers shall not engage in claim suppression.

10 (4) For the purposes of this section, "claim suppression" means 11 intentionally:

(a) Inducing employees to fail to report injuries;

13 (b) Inducing employees to treat injuries in the course of 14 employment as off-the-job injuries; or

15 (c) Acting otherwise to suppress legitimate industrial insurance 16 claims.

(a) Made to the department and the employer has not received a
copy of the application, the department shall immediately send a copy
of the application to the employer; or

(b) Made to a self-insured employer, the employer shall forthwith send a copy of the application to the department.

27 (1) Whenever an employer has notice or knowledge of an injury or 28 occupational disease sustained by any worker in his or her employment who has received treatment from a physician or a licensed advanced 29 ((registered nurse practitioner)) practice registered nurse, has been 30 31 hospitalized, disabled from work or has died as the apparent result such injury or occupational disease, the employer 32 of shall immediately report the same to the department on forms prescribed by 33 it. 3 (1) The legislature finds that high quality medical treatment and adherence to occupational health best practices can prevent 4 disability and reduce loss of family income for workers, and lower 5 6 labor and insurance costs for employers. Injured workers deserve high quality medical care in accordance with current health care best 7 practices. To this end, the department shall establish minimum 8 standards for providers who treat workers from both state fund and 9 self-insured employers. The department shall establish a health care 10 11 provider network to treat injured workers, and shall accept providers 12 into the network who meet those minimum standards. 30 (v) Whether the provider has been credentialed by another health 31 plan that follows national quality assurance guidelines; and

32 (vi) Alternative criteria for providers that are not credentialed 33 by another health plan.

The department shall develop alternative criteria for providers that are not credentialed by another health plan or as needed to address access to care concerns in certain regions.

37 (d) Network provider contracts will automatically renew at the 38 end of the contract period unless the department provides written 39 notice of changes in contract provisions or the department or 40 provider provides written notice of contract termination. The

In the case of permanent partial disability, not to extend beyond 27 the date when compensation shall be awarded him or her, except when 28 the worker returned to work before permanent partial disability award 29 is made, in such case not to extend beyond the time when monthly 30 31 allowances to him or her shall cease; in case of temporary disability 32 not to extend beyond the time when monthly allowances to him or her shall cease: PROVIDED, That after any injured worker has returned to 33 his or her work his or her medical and surgical treatment may be 34 continued if, and so long as, such continuation is deemed necessary 35 by the supervisor of industrial insurance to be necessary to his or 36 her more complete recovery; in case of a permanent total disability 37 not to extend beyond the date on which a lump sum settlement is made 38 39 with him or her or he or she is placed upon the permanent pension 40 roll: PROVIDED, HOWEVER, That the supervisor of industrial insurance,

1 solely in his or her discretion, may authorize continued medical and surgical treatment for conditions previously accepted by the 2 department when such medical and surgical treatment is deemed 3 necessary by the supervisor of industrial insurance to protect such 4 worker's life or provide for the administration of medical and 5 6 therapeutic measures including payment of prescription medications, but not including those controlled substances currently scheduled by 7 the pharmacy quality assurance commission as Schedule I, II, III, or 8 IV substances under chapter 69.50 RCW, which are necessary to 9 alleviate continuing pain which results from the industrial injury. 10 In order to authorize such continued treatment the written order of 11 12 the supervisor of industrial insurance issued in advance of the continuation shall be necessary. 13

The supervisor of industrial insurance, the supervisor's 14 15 designee, or a self-insurer, in his or her sole discretion, may authorize inoculation or other immunological treatment in cases in 16 17 which a work-related activity has resulted in probable exposure of 18 the worker to a potential infectious occupational disease. Authorization of such treatment does not bind the department or self-19 insurer in any adjudication of a claim by the same worker or the 20 21 worker's beneficiary for an occupational disease.

(5) (a) The legislature finds that the department and its business 22 23 and labor partners have collaborated in establishing centers for occupational health and education to promote best practices and 24 25 prevent preventable disability by focusing additional provider-based 26 resources during the first twelve weeks following an injury. The 27 centers for occupational health and education represent innovative 28 accountable care systems in an early stage of development consistent with national health care reform efforts. Many Washington workers do 29 not yet have access to these innovative health care delivery models. 30

31 (b) To expand evidence-based occupational health best practices, 32 the department shall establish additional centers for occupational 33 health and education, with the goal of extending access to at least 34 fifty percent of injured and ill workers by December 2013 and to all 35 injured workers by December 2015. The department shall also develop 36 additional best practices and incentives that span the entire period 37 of recovery, not only the first twelve weeks.

38 (c) The department shall certify and decertify centers for 39 occupational health and education based on criteria including 40 institutional leadership and geographic areas covered by the center

1 for occupational health and education, occupational health leadership and education, mix of participating health care providers necessary 2 3 to address the anticipated needs of injured workers, health services coordination to deliver occupational health best practices, 4 indicators to measure the success of the center for occupational 5 6 health and education, and agreement that the center's providers shall, if feasible, treat certain injured workers if referred by the 7 department or a self-insurer. 8

9 (d) Health care delivery organizations may apply to the 10 department for certification as a center for occupational health and 11 education. (f) The department shall develop and implement financial and nonfinancial incentives for center for occupational health and education providers that are based on progressive and measurable gains in occupational health best practices, and that are applicable throughout the duration of an injured or ill worker's episode of care.

(g) The department shall develop electronic methods of tracking 27 evidence-based quality measures to identify and improve outcomes for 28 injured workers at risk of developing prolonged disability. In 29 addition, these methods must be used to provide systematic feedback 30 31 to physicians regarding quality of care, to conduct appropriate 32 objective evaluation of progress in the centers for occupational health and education, and to allow efficient coordination of 33 services. 34

35 (6) If a provider fails to meet the minimum network standards 36 established in subsection (2) of this section, the department is 37 authorized to remove the provider from the network or take other 38 appropriate action regarding a provider's participation. The 39 department may also require remedial steps as a condition for a 40 provider to participate in the network. The department, with input

1 from the advisory group, shall establish waiting periods that may be 2 imposed before a provider who has been denied or removed from the 3 network may reapply.

(7) The department may permanently remove a provider from the 4 network or take other appropriate action when the provider exhibits a 5 6 pattern of conduct of low quality care that exposes patients to risk of physical or psychiatric harm or death. Patterns that qualify as 7 risk of harm include, but are not limited to, poor health care 8 outcomes evidenced by increased, chronic, or prolonged pain or 9 decreased function due to treatments that have not been shown to be 10 curative, safe, or effective or for which it has been shown that the 11 12 risks of harm exceed the benefits that can be reasonably expected based on peer-reviewed opinion. 13

14 (8) The department may not remove a health care provider from the 15 network for an isolated instance of poor health and recovery outcomes 16 due to treatment by the provider.

(9) When the department terminates a provider from the network, the department or self-insurer shall assist an injured worker currently under the provider's care in identifying a new network provider or providers from whom the worker can select an attending or treating provider. In such a case, the department or self-insurer shall notify the injured worker that he or she must choose a new attending or treating provider.

(10) The department may adopt rules related to this section.

25 (11) The department shall report to the workers' compensation 26 advisory committee and to the appropriate committees of the legislature on each December 1st, beginning in 2012 and ending in 27 2016, on the implementation of the provider network and expansion of 28 29 the centers for occupational health and education. The reports must include a summary of actions taken, progress toward long-term goals, 30 31 outcomes of key initiatives, access to care issues, results of 32 disputes or controversies related to new provisions, and whether any 33 changes are needed to further improve the occupational health best practices care of injured workers. 34
