- 1 AN ACT Relating to the profession of dental therapist; amending 2 RCW 18.32.030, 18.32.0351, 18.120.020, 18.130.040, 18.260.010,
- 3 18.260.040, 18.260.070, 18.260.080, 69.41.030, and 70.350.020;
- 4 reenacting and amending RCW 69.41.010; adding a new chapter to Title
- 5 18 RCW; creating a new section; and providing an effective date.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 7 NEW SECTION. Sec. 1. The legislature finds that good oral
- 8 health is an integral piece of overall health and well-being. Without
- 9 treatment, dental disease compromises overall health and requires
- 10 increasingly costly interventions. However, most dental disease can
- 11 be prevented at little cost through routine dental care and disease
- 12 prevention.
- Dental-related issues are a leading reason that Washingtonians
- 14 seek care in hospital emergency departments, which has become the
- 15 source of care for many, especially uninsured and low-income
- 16 populations.
- 17 It is the intent of the legislature to expand access to oral
- 18 health care for all Washingtonians through an evidence-based mid-
- 19 level dental provider called a dental therapist. Dental therapy is a
- 20 strategy to address racial and ethnic disparities in health and rural
- 21 health care access gaps. Dental therapists are also a strategy to

increase workforce diversity in health care and expand career opportunities for existing members of the dental care workforce such as dental hygienists.

It is the legislature's intent that dental therapists will meet the needs of local communities as they work under the direction of a licensed Washington dentist. The legislature intends for dental therapists to be incorporated into the dental care workforce and used to effectively treat more patients.

It is the intent of the legislature to follow the national commission on dental accreditation's standards for dental therapy education. This will ensure that dental therapists are trained to the highest quality standards and provide state-to-state consistency. It is the intent of the legislature that incorporating the commission on dental accreditation's standards for dental therapy education will pave the way for Washington education institutions to become accredited programs and for students to qualify for financial aid.

It is also the intent of the legislature to provide an efficient and reasonable pathway, through a limited license, for federally certified dental health aide therapists or tribally licensed dental therapists to become a Washington state licensed dental therapist.

- NEW SECTION. Sec. 2. The definitions in this section apply throughout this chapter unless the context clearly requires otherwise.
- 24 (1) "Close supervision of a dentist" means that a supervising 25 dentist:
 - (a) Has personally examined and diagnosed the patient and has personally authorized the procedures to be performed;
- 28 (b) Is continuously on-site while the procedure in question is 29 being performed; and
- 30 (c) Is capable of responding immediately in the event of an 31 emergency.
- 32 (2) "Committee" means the dental hygiene examining committee 33 established in chapter 18.29 RCW.
- 34 (3) "Dental therapist" means a person licensed to practice dental 35 therapy under this chapter.
- 36 (4) "Dental therapy" means the services and procedures specified 37 in section 5 of this act.
- 38 (5) "Dentist" means a person licensed to practice dentistry under 39 chapter 18.32 RCW.

- 8 licensed by the department under this chapter. Every person licensed
- 9 to practice dental therapy in this state shall renew their license
- 10 and comply with administrative procedures, administrative
- 11 requirements, continuing education requirements, and fees provided in
- 12 RCW 43.70.250 and 43.70.280.

- NEW SECTION. Sec. 4. (1) The department shall issue a license to practice as a dental therapist to any applicant who:
- 15 (a) Pays any applicable fees established by the secretary under 16 RCW 43.70.110 and 43.70.250;
- 17 (b) Submits, on forms provided by the secretary, the applicant's 18 name, address, and other applicable information as determined by the 19 secretary;
- 20 (c) Completes a preceptorship of at least four hundred hours 21 under the close supervision of a dentist;
 - (d) Passes an examination approved by the committee; and
- 23 (e) Successfully completes a dental therapist program that is 24 accredited, or has received initial accreditation, by the commission 25 on dental accreditation.
 - (2) (a) The secretary shall establish the date and location of the examination. Applicants who meet the education requirements for licensure must be scheduled for the next examination following the filing of the application. The secretary shall establish by rule the examination application deadline.
 - (b) The examination must contain subjects appropriate to the scope of practice and questions on laws in the state of Washington regulating dental therapy practice.
- 34 (c) The committee shall establish by rule the requirements for a 35 reexamination if the applicant has failed the examination.
- 36 (d) The committee may approve an examination prepared or 37 administered by a private testing agency or association of licensing 38 authorities.

- NEW SECTION. Sec. 5. (1) Subject to the limitations in this section and section 6 of this act, a dental therapist may provide the following services and procedures:

 - (b) Preliminary charting of the oral cavity;
- 9 (c) Making radiographs;
 - (d) Mechanical polishing;

- 18 (k) Placement of temporary restorations;
- 19 (1) Fabrication of soft occlusal guards;
- 20 (m) Tissue conditioning and soft reline;

- 23 (o) Dressing changes;
- 24 (p) Tooth reimplantation;
 - (q) Administration of local anesthetic;
- 26 (r) Administration of nitrous oxide;
- 27 (s) Emergency palliative treatment of dental pain;
- 28 (t) The placement and removal of space maintainers;
- 29 (u) Cavity preparation;
- 30 (v) Restoration of primary and permanent teeth;
- 31 (w) Placement of temporary crowns;
- 32 (x) Preparation and placement of preformed crowns;
- 33 (y) Pulpotomies on primary teeth;
- 34 (z) Indirect and direct pulp capping on primary and permanent 35 teeth;
- 36 (aa) Stabilization of reimplanted teeth;
- 37 (bb) Extractions of primary teeth;
- 38 (cc) Suture placement and removal;
- 39 (dd) Brush biopsies;

- (gg) Oral evaluation and assessment of dental disease and the formulation of an individualized treatment plan;
- (hh) The supervision of expanded function dental auxiliaries and dental assistants. However, a dental therapist may supervise no more than a total of four expanded function dental auxiliaries and dental assistants at any one time in any one practice setting. A dental therapist may not supervise an expanded function dental auxiliary or dental assistant with respect to tasks that the dental therapist is not authorized to perform;
- (ii) Nonsurgical extractions of periodontally diseased permanent teeth with tooth mobility of plus 3 to plus 4 if the teeth are not unerupted, are not impacted, are not fractured, and do not need to be sectioned for removal; and
- 16 (jj) The dispensation and oral administration of drugs pursuant 17 to subsection (2) of this section.
 - (2) (a) A dental therapist may dispense and orally administer the following drugs within the parameters of the practice plan contract established in section 6 of this act: Nonnarcotic analgesics, anti-inflammatories, preventive agents, and antibiotics.
 - (b) The authority to dispense and orally administer drugs extends only to the drugs identified in this subsection and may be further limited by the practice plan contract.
 - (c) The authority to dispense includes the authority to dispense sample drugs within the categories established in this subsection if the dispensing is permitted under the practice plan contract.
- 28 (d) A dental therapist may not dispense or administer narcotic 29 drugs as defined in chapter 69.50 RCW.
- 30 NEW SECTION. Sec. 6. (1) A dental therapist may only practice dental therapy under the supervision of a dentist licensed under 31 chapter 18.32 RCW and pursuant to a written practice plan contract 32 with the supervising dentist. In circumstances authorized by the 33 supervising dentist in the written practice plan contract, a dental 34 therapist may provide services without the prior examination or 35 diagnosis of a dentist and without the dentist being personally on 36 site when services are provided. The contract must, at a minimum, 37 38 contain the following elements:

1 (a) The level of supervision required and circumstances when the 2 prior knowledge and consent of the supervising dentist is required;

- (b) Practice settings where services and procedures may be provided;
- (c) Any limitations on the services or procedures the dental therapist may provide;
- (d) Age and procedure-specific practice protocols, including case selection criteria, assessment guidelines, and imaging frequency;
- (e) Procedures for creating and maintaining dental records for patients treated by the dental therapist;
- (f) A plan to manage medical emergencies in each practice setting where the dental therapist provides care;
- (g) A quality assurance plan for monitoring care provided by the dental therapist or, including patient care review, referral follow-up, and a quality assurance chart review;
- (h) Protocols for administering and dispensing medications, including the specific circumstances under which the medications may be dispensed and administered;
- (i) Criteria relating to the provision of care to patients with specific medical conditions or complex medical histories, including requirements for consultation prior to the initiation of care; and
- (j) Specific written protocols governing situations where the dental therapist encounters a patient requiring treatment that exceeds the dental therapist's scope of practice or capabilities and protocols for referral of patients requiring evaluation and treatment by dentists, physicians, advanced registered nurse practitioners, or other health care providers.
- (2) The dental therapist shall accept responsibility for all services and procedures provided by the dental therapist or any auxiliary dental providers the dental therapist is supervising pursuant to the practice plan contract.
- (3) A supervising dentist who knowingly permits a dental therapist to provide a service or procedure that is not authorized in the practice plan contract, or any dental therapist who provides a service or procedure that is not authorized in the practice plan contract, commits unprofessional conduct for purposes of chapter 18.130 RCW.
- 38 (4) A dentist who enters into a written practice plan contract 39 with a dental therapist shall:

- 1 (a) Directly provide or arrange for another dentist or specialist 2 to provide any necessary advanced procedures or services needed by 3 the patient or any treatment that exceeds the dental therapist's 4 scope of practice or capabilities;
 - (b) Ensure that he or she or another dentist is available to the dental therapist for timely communication during treatment if needed.

- (5) A dental therapist shall perform only those services authorized by the supervising dentist and written practice plan contract and shall maintain an appropriate level of contact with the supervising dentist.
- 11 (6) Practice plan contracts must be signed and maintained by both 12 the supervising dentist and the dental therapist.
- 13 (7) A supervising dentist may supervise no more than a total of 14 five dental therapists at any one time.
- NEW SECTION. Sec. 7. Nothing in this chapter prohibits or affects:
- 17 (1) The practice of dental therapy by an individual otherwise 18 licensed under this title and performing services within his or her 19 scope of practice;
 - (2) The practice of dental therapy in the discharge of official duties on behalf of the United States government, including, but not limited to, the armed forces, coast guard, public health service, veterans' bureau, or bureau of Indian affairs;
 - (3) The practice of dental therapy pursuant to an education program described in section 4 of this act;
 - (4) The practice of dental therapy under the supervision of a dentist necessary to meet the clinical experience or preceptorship requirements of section 4 of this act; or
 - (5) The practice of federally certified dental health aide therapists or tribally licensed dental therapists practicing in clinics operated by an Indian health service, Indian health service direct, tribal 638, or an urban Indian health program system of care, as those terms are defined in the Indian health care improvement act, Title 25 U.S.C. Sec. 1603(12), (25) and (29).
- 35 <u>NEW SECTION.</u> **Sec. 8.** A dental therapist may practice only in 36 the following settings:
 - (1) Federally qualified health centers;

 - (4) Any other clinic or practice setting, including mobile or temporary dental clinics, in which at least thirty-five percent of the total patient base of the dental therapist consists of patients who:
 - (a) Are enrolled in a Washington state medicaid program;

- (b) Have a medical disability or chronic condition that creates a significant barrier to receiving dental care; or
- 14 (c) Have annual incomes of less than one hundred thirty-three 15 percent of the federal poverty level calculated using modified annual 16 gross income as defined in section 2002 of P.L. 111-148, as amended, 17 and do not have dental coverage, either through medicaid or private 18 insurance.
- NEW SECTION. Sec. 9. Chapter 18.130 RCW governs the unlicensed practice, the issuance and denial of licenses, and the discipline of persons licensed under this chapter. The dental quality assurance commission is the disciplining authority under this chapter.
- NEW SECTION. Sec. 10. (1) The department shall issue a limited license to any applicant who, as determined by the secretary:
 - (a) Holds a valid license, certification, or recertification in another state, Canadian province, or has been certified or licensed by a federal or tribal governing board in the previous two years, that allows a substantively equivalent, but not the entire scope of practice in section 5 of this act;
- 30 (b) Is currently engaged in active practice in another state, 31 Canadian province, or tribe;
- 32 (c) Files with the secretary documentation certifying that the 33 applicant:
- 34 (i) Has graduated from a dental therapy school accredited by the 35 commission on dental accreditation;
- (ii) Has successfully completed the national dental therapy examination, or until such time that that exam is developed, the national dental hygiene examination; and

- 1 (iii) Is licensed or certified to practice in another state or 2 Canadian province, or has been certified or licensed by a federal or 3 tribal governing board in the previous two years;

 - (e) Demonstrates to the secretary knowledge of Washington state law pertaining to the practice of dental therapy;

- (g) Meets requirements for AIDS education.
- 11 (2) The term of the limited license issued under this section is 12 eighteen months.
 - (3) A person practicing with a limited license granted under this section has the authority to perform only those dental therapy procedures in section 5 of this act that he or she was licensed or certified to practice in their previous state, tribe, or Canadian province.
- 18 (4) Upon demonstration of competency in all procedures in section 19 5 of this act, the limited license holder may apply for licensure as 20 a dental therapist under section 4 of this act.
- 21 (5) For the purposes of this section, "active practice" means 22 five hundred sixty hours of practice in the preceding twenty-four 23 months.
- 24 **Sec. 11.** RCW 18.32.030 and 2017 c 5 s 5 are each amended to read 25 as follows:

- (5) The use of roentgen and other rays for making radiographs or similar records of dental or oral tissues, under the supervision of a licensed dentist or physician;
- (6) The making, repairing, altering, or supplying of artificial restorations, substitutions, appliances, or materials for the correction of disease, loss, deformity, malposition, dislocation, fracture, injury to the jaws, teeth, lips, gums, cheeks, palate, or associated tissues or parts; providing the same are made, repaired, altered, or supplied pursuant to the written instructions and order of a licensed dentist which may be accompanied by casts, models, or impressions furnished by the dentist, and the prescriptions shall be retained and filed for a period of not less than three years and shall be available to and subject to the examination of the secretary or the secretary's authorized representatives;
- (7) The removal of deposits and stains from the surfaces of the teeth, the application of topical preventative or prophylactic agents, and the polishing and smoothing of restorations, when performed or prescribed by a dental hygienist licensed under the laws of this state;
- (8) A qualified and licensed physician and surgeon or osteopathic physician and surgeon extracting teeth or performing oral surgery pursuant to the scope of practice under chapter 18.71 or 18.57 RCW;
- (9) The performing of dental operations or services by registered dental assistants and licensed expanded function dental auxiliaries holding a credential issued under chapter 18.260 RCW when performed under the supervision of a licensed dentist, by dental therapists licensed under chapter 18.--- RCW (the new chapter created in section 22 of this act), or by other persons not licensed under this chapter if the person is licensed pursuant to chapter 18.29, 18.57, 18.71, or 18.79 RCW as it applies to registered nurses and advanced registered nurse practitioners, each while acting within the scope of the

- 19 (10) The performing of dental services described in RCW 20 18.350.040 by dental anesthesia assistants certified under chapter 21 18.350 RCW when working under the supervision and direction of an 22 oral and maxillofacial surgeon or dental anesthesiologist; and
- 23 (11) The performance of dental health aide therapist services to 24 the extent authorized under chapter 70.350 RCW.

- (1) "Applicant group" includes any health professional group or organization, any individual, or any other interested party which proposes that any health professional group not presently regulated be regulated or which proposes to substantially increase the scope of practice of the profession.
- (2) "Certificate" and "certification" mean a voluntary process by which a statutory regulatory entity grants recognition to an individual who (a) has met certain prerequisite qualifications specified by that regulatory entity, and (b) may assume or use "certified" in the title or designation to perform prescribed health professional tasks.
- (3) "Grandfather clause" means a provision in a regulatory statute applicable to practitioners actively engaged in the regulated health profession prior to the effective date of the regulatory statute which exempts the practitioners from meeting the prerequisite qualifications set forth in the regulatory statute to perform prescribed occupational tasks.

(5) "Inspection" means the periodic examination of practitioners by a state agency in order to ascertain whether the practitioners' occupation is being carried out in a fashion consistent with the public health, safety, and welfare.

- (6) "Legislative committees of reference" means the standing legislative committees designated by the respective rules committees of the senate and house of representatives to consider proposed legislation to regulate health professions not previously regulated.
- (7) "License," "licensing," and "licensure" mean permission to engage in a health profession which would otherwise be unlawful in the state in the absence of the permission. A license is granted to those individuals who meet prerequisite qualifications to perform prescribed health professional tasks and for the use of a particular title.
- (8) "Practitioner" means an individual who (a) has achieved knowledge and skill by practice, and (b) is actively engaged in a specified health profession.
- (9) "Professional license" means an individual, nontransferable authorization to carry on a health activity based on qualifications which include: (a) Graduation from an accredited or approved program,
