AN ACT Relating to clarifying the authority of a nurse working in a school setting; adding a new section to chapter 28A.210 RCW; and creating a new section.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 <u>NEW SECTION.</u> Sec. 1. (1) The legislature finds that:

6 (a) School administrators may not interfere with nursing care 7 provided by a registered nurse or an advanced registered nurse 8 practitioner working in a school setting, but may supervise a 9 registered nurse or an advanced registered nurse practitioner in all 10 other aspects of employment;

(b) Nursing is governed by specific laws and regulations and requires a unique license to practice. Clinical supervision of a nurse is based on knowledge of the laws, regulations, and rules governing nursing practice, nursing practice standards, and nursing performance standards;

16 (c) Student health needs have changed dramatically over the last 17 twenty years. The number of students with special health care needs 18 has risen exponentially;

(d) School nurses are held accountable through chapter 18.79 RCW and the uniform disciplinary act, chapter 18.130 RCW, for errors in nursing judgment and actions; (e) Individuals who are not nurses are unqualified to make
nursing judgments and assessments;

(f) The independent nature of nursing has been recognized in both statute and rule. For example, under RCW 18.79.040, "registered nursing practice" includes the "administration, supervision, delegation, and evaluation of nursing practice." Furthermore, continuing competency rules recently adopted by the nursing care quality assurance commission recognize and acknowledge the independent nature of nursing; and

10 (g) The ability of a nurse to practice nursing without the 11 supervision of a nonnurse supervisor is particularly important given 12 the primacy of the nurse-patient relationship.

13 (2) It is therefore the intent of the legislature to reaffirm the 14 authority of a licensed nurse working in a school setting to practice 15 nursing without the supervision of a person who is not a licensed 16 nurse.

(3) It is not the intent of the legislature to:

(a) Prohibit a nonnurse from supervising a licensed nurse working in a school setting with respect to matters other than the practice of nursing, such as matters of administration, terms and conditions of employment, and employee performance; or

(b) Require a school to provide clinical supervision for alicensed nurse working in a school setting.

24 <u>NEW SECTION.</u> Sec. 2. A new section is added to chapter 28A.210 25 RCW to read as follows:

(1) School administrators may not interfere with nursing care 26 27 provided by a registered nurse or an advanced registered nurse practitioner working in a school setting, but may supervise a 28 registered nurse or an advanced registered nurse practitioner in all 29 30 other aspects of employment. Only a registered nurse or an advanced 31 registered nurse practitioner licensed under chapter 18.79 RCW may supervise, direct, or evaluate a licensed nurse working in a school 32 setting with respect to the practice of nursing as defined in this 33 34 section.

35 (2) Nothing in this section:

(a) Prohibits a nonnurse supervisor from supervising, directing,
or evaluating a licensed nurse working in a school setting with
respect to matters other than the practice of nursing;

(b) Requires a registered nurse or an advanced registered nurse
practitioner to be clinically supervised in a school setting; or

3 (c) Prohibits a nonnurse supervisor from conferring with a 4 licensed nurse working in a school setting with respect to the 5 practice of nursing.

6 (3) Within existing funds, the superintendent of public 7 instruction shall notify each school district in this state of the 8 requirements of this section.

9 (4) For purposes of this section, "practice of nursing" means:

10 (a) Registered nursing practice as defined in RCW 18.79.040, 11 advanced registered nursing practice as defined in RCW 18.79.050, and 12 licensed practical nursing practice as defined in RCW 18.79.060, 13 including, but not limited to:

14 (i) The administration of medication pursuant to a medication or 15 treatment order; and

16 (ii) The decision to summon emergency medical assistance; and

17 (b) Compliance with any state or federal statute or 18 administrative rule specifically regulating licensed nurses, 19 including any statute or rule defining or establishing standards of 20 patient care or professional conduct or practice.
