State of Washington 63rd Legislature 2014 Regular Session

By Representatives Vick, Ryu, and Kirby; by request of Department of Financial Institutions

1 AN ACT Relating to clarifying the statute of limitations for 2 enforcement actions, sharing of information with federal and state regulatory authorities, and requiring call reports for nondepository 3 institutions regulated by the department of financial institutions; 4 RCW 18.44.430, 19.146.220, 31.04.045, 31.04.093, 5 amending and 6 31.45.110; adding new sections to chapter 19.230 RCW; and adding new 7 sections to chapter 31.45 RCW.

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

9 **Sec. 1.** RCW 18.44.430 and 2010 c 34 s 10 are each amended to read 10 as follows:

(1) The director may, upon notice to the escrow agent and to the insurer providing coverage under RCW 18.44.201, deny, suspend, decline to renew, or revoke the license of any escrow agent or escrow officer if the director finds that the applicant or any partner, officer, director, controlling person, or employee has committed any of the following acts or engaged in any of the following conduct:

(a) Obtaining a license by means of fraud, misrepresentation,concealment, or through the mistake or inadvertence of the director.

(b) Violating any of the provisions of this chapter or any lawful
 rules made by the director pursuant thereto.

3 (c) The commission of a crime against the laws of this or any other4 state or government, involving moral turpitude or dishonest dealings.

5 (d) Knowingly committing or being a party to, any material fraud, 6 misrepresentation, concealment, conspiracy, collusion, trick, scheme, 7 or device whereby any other person lawfully relying upon the word, 8 representation, or conduct of the licensee or agent or any partner, 9 officer, director, controlling person, or employee acts to his or her 10 injury or damage.

(e) Conversion of any money, contract, deed, note, mortgage, or 11 12 abstract or other evidence of title to his or her own use or to the use 13 of his or her principal or of any other person, when delivered to him 14 or her in trust or on condition, in violation of the trust or before the happening of the condition; and failure to return any money or 15 contract, deed, note, mortgage, abstract, or other evidence of title 16 17 within thirty days after the owner thereof is entitled thereto, and makes demand therefor, shall be prima facie evidence of such 18 19 conversion.

(f) Failing, upon demand, to disclose any information within his or her knowledge to, or to produce any document, book, or record in his or her possession for inspection of, the director or his or her authorized representatives.

(g) Committing any act of fraudulent or dishonest dealing, and a certified copy of the final holding of any court of competent jurisdiction in such matter shall be conclusive evidence in any hearing under this chapter.

(h) Accepting, taking, or charging any undisclosed commission,rebate, or direct profit on expenditures made for the principal.

30 (i) Committing acts or engaging in conduct that demonstrates the 31 applicant or licensee to be incompetent or untrustworthy, or a source 32 of injury and loss to the public.

33 (2) Any conduct of an applicant or licensee that constitutes 34 grounds for enforcement action under this chapter is sufficient 35 regardless of whether the conduct took place within or outside of the 36 state of Washington.

37 (3) In addition to or in lieu of a license suspension, revocation,38 or denial, the director may assess a fine of up to one hundred dollars

per day for each violation of this chapter or rules adopted under this chapter and may remove and/or prohibit from participation in the conduct of the affairs of any licensed escrow agent, any officer, controlling person, director, employee, or licensed escrow officer. <u>The statute of limitations on actions not subject to RCW 4.16.160 that</u> are brought under this chapter by the director is five years.

7 (4) In addition to or in lieu of (a) a license suspension, 8 revocation, or denial, or (b) fines payable to the department, the 9 director may order an escrow agent, officer, controlling person, 10 director, employee, or licensed escrow officer violating this chapter 11 to make restitution to an injured consumer.

12 **Sec. 2.** RCW 19.146.220 and 2013 c 30 s 5 are each amended to read 13 as follows:

(1) The director may enforce all laws and rules relating to the
 licensing of mortgage brokers and loan originators, grant or deny
 licenses to mortgage brokers and loan originators, and hold hearings.

17 (2) The director may impose fines or order restitution against
18 licensees or other persons subject to this chapter, or deny, suspend,
19 decline to renew, or revoke licenses for:

20

(a) Violations of orders, including cease and desist orders;

(b) False statements or omission of material information on the application that, if known, would have allowed the director to deny the application for the original license;

24 (c) Failure to pay a fee required by the director or maintain the 25 required bond;

26 (d) Failure to comply with any directive, order, or subpoena of the 27 director; or

(e) Any violation of this chapter.

(3) The director may impose fines on an employee, loan originator, independent contractor, or agent of the licensee, or other person subject to this chapter for:

(4) The director may issue orders directing a licensee, its
 employee, loan originator, independent contractor, agent, or other
 person subject to this chapter to cease and desist from conducting

1 (5) The director may issue orders removing from office or 2 prohibiting from participation in the conduct of the affairs of a 3 licensed mortgage broker, or both, any officer, principal, employee, or 4 loan originator of any licensed mortgage broker or any person subject 5 to licensing under this chapter for:

(a) Any violation of this chapter;

7 (b) False statements or omission of material information on the 8 application that, if known, would have allowed the director to deny the 9 application for the original license;

10 (c) Conviction of a gross misdemeanor involving dishonesty or 11 financial misconduct or a felony after obtaining a license; or

(d) Failure to comply with any directive or order of the director.

13 (6) Each day's continuance of a violation or failure to comply with 14 any directive or order of the director is a separate and distinct 15 violation or failure.

16 (7) <u>The statute of limitations on actions not subject to RCW</u> 17 <u>4.16.160 that are brought under this chapter by the director is five</u> 18 <u>years.</u>

<u>(8)</u> The director shall establish by rule standards for licensure of
 applicants licensed in other jurisdictions.

21 (((+))) (9) The director shall immediately suspend the license or 22 certificate of a person who has been certified pursuant to RCW 23 74.20A.320 by the department of social and health services as a person 24 who is not in compliance with a support order. If the person has continued to meet all other requirements for reinstatement during the 25 26 suspension, reissuance of the license or certificate shall be automatic upon the director's receipt of a release issued by the department of 27 28 social and health services stating that the licensee is in compliance 29 with the order.

30 <u>NEW SECTION.</u> Sec. 3. A new section is added to chapter 19.230 RCW 31 to read as follows:

The statute of limitations on actions not subject to RCW 4.16.160 that are brought under this chapter by the director is five years.

34 <u>NEW SECTION.</u> Sec. 4. A new section is added to chapter 19.230 RCW 35 to read as follows:

Each licensee on a nationwide licensing system shall submit reports of condition which must be in the form and must contain the information as the director may require.

4 Sec. 5. RCW 31.04.045 and 2010 c 35 s 3 are each amended to read 5 as follows:

6 (1) Application for a license under this chapter must be made to 7 the nationwide mortgage licensing system and registry or in the form 8 prescribed by the director. The application must contain at least the 9 following information:

10

(a) The name and the business addresses of the applicant;

(b) If the applicant is a partnership or association, the name of every member;

13 (c) If the applicant is a corporation, the name, residence address,14 and telephone number of each officer and director;

15 (d) The street address, county, and municipality from which 16 business is to be conducted; and

17

(e) Such other information as the director may require by rule.

(2) As part of or in connection with an application for any license 18 under this section, or periodically upon license renewal, each officer, 19 20 director, and owner applicant shall furnish information concerning his 21 her identity, including fingerprints for submission to the or 22 Washington state patrol, the federal bureau of investigation, ((the 23 nationwide mortgage licensing system and registry,)) or any 24 governmental agency or entity authorized to receive this information 25 for a state and national criminal history background check; personal 26 history; experience; business record; purposes; and other pertinent 27 facts, as the director may reasonably require. As part of or in connection with an application for a license under this chapter, or 28 29 periodically upon license renewal, the director is authorized to receive criminal history record information that includes nonconviction 30 31 data as defined in RCW 10.97.030. The department may only disseminate nonconviction data obtained under this section to criminal justice 32 This section does not apply to financial institutions 33 agencies. 34 regulated under chapters 31.12 and 31.13 RCW and Titles 30, 32, and 33 35 RCW.

36 (3) ((In order to reduce the points of contact which the federal 37 bureau of investigation may have to maintain, the director may use the 1 nationwide mortgage licensing system and registry as a channeling agent 2 for requesting information from and distributing information to the 3 department of justice or any governmental agency.

4 (4) In order to reduce the points of contact which the director may 5 have to maintain, the director may use the nationwide mortgage 6 licensing system and registry as a channeling agent for requesting and 7 distributing information to and from any source so directed by the 8 director.

9 (5)) At the time of filing an application for a license under this 10 chapter, each applicant shall pay to the director ((or through the 11 nationwide mortgage licensing system and registry)) an investigation 12 fee and the license fee in an amount determined by rule of the director 13 to be sufficient to cover the director's costs in administering this 14 chapter.

15 (((+6))) (4) Each applicant shall file and maintain a surety bond, approved by the director, executed by the applicant as obligor and by 16 a surety company authorized to do a surety business in this state as 17 surety, whose liability as such surety shall not exceed in the 18 19 aggregate the penal sum of the bond. The penal sum of the bond shall 20 be a minimum of thirty thousand dollars and based on the annual dollar 21 amount of loans originated or residential mortgage loans serviced. The 22 bond shall run to the state of Washington as obligee for the use and 23 benefit of the state and of any person or persons who may have a cause of action against the obligor under this chapter. The bond shall be 24 conditioned that the obligor as licensee will faithfully conform to and 25 26 abide by this chapter and all the rules adopted under this chapter. 27 The bond will pay to the state and any person or persons having a cause 28 of action against the obligor all moneys that may become due and owing 29 to the state and those persons under and by virtue of this chapter. In 30 lieu of a surety bond, if the applicant is a Washington business corporation, the applicant may maintain unimpaired capital, surplus, 31 and long-term subordinated debt in an amount that at any time its 32 outstanding promissory notes or other evidences of debt (other than 33 long-term subordinated debt) in an aggregate sum do not exceed three 34 35 times the aggregate amount of its unimpaired capital, surplus, and 36 long-term subordinated debt. The director may define qualifying "long-37 term subordinated debt" for purposes of this section.

1 Sec. 6. RCW 31.04.093 and 2013 c 29 s 5 are each amended to read 2 as follows:

3 (1) The director shall enforce all laws and rules relating to the
4 licensing and regulation of licensees and persons subject to this
5 chapter.

6

(2) The director may deny applications for licenses for:

7 (a) Failure of the applicant to demonstrate within its application
8 for a license that it meets the requirements for licensing in RCW
9 31.04.045 and 31.04.055;

10 (b) Violation of an order issued by the director under this chapter 11 or another chapter administered by the director, including but not 12 limited to cease and desist orders and temporary cease and desist 13 orders;

(c) Revocation or suspension of a license to conduct lending or residential mortgage loan servicing, or to provide settlement services associated with lending or residential mortgage loan servicing, by this state, another state, or by the federal government within five years of the date of submittal of a complete application for a license; or

(3) The director may suspend or revoke a license issued under thischapter if the director finds that:

(a) The licensee has failed to pay any fee due the state of
Washington, has failed to maintain in effect the bond or permitted
substitute required under this chapter, or has failed to comply with
any specific order or demand of the director lawfully made and directed
to the licensee in accordance with this chapter;

32 (b) The licensee, either knowingly or without the exercise of due 33 care, has violated any provision of this chapter or any rule adopted 34 under this chapter; or

35 (c) A fact or condition exists that, if it had existed at the time 36 of the original application for the license, clearly would have allowed 37 the director to deny the application for the original license. The 38 director may revoke or suspend only the particular license with respect to which grounds for revocation or suspension may occur or exist unless the director finds that the grounds for revocation or suspension are of general application to all offices or to more than one office operated by the licensee, in which case, the director may revoke or suspend all of the licenses issued to the licensee.

6 (4) The director may impose fines of up to one hundred dollars per
7 day, per violation, upon the licensee, its employee or loan originator,
8 or other person subject to this chapter for:

(a) Any violation of this chapter; or

10 (b) Failure to comply with any order or subpoena issued by the 11 director under this chapter.

12 (5) The director may issue an order directing the licensee, its 13 employee or loan originator, or other person subject to this chapter 14 to:

(a) Cease and desist from conducting business in a manner that isinjurious to the public or violates any provision of this chapter;

17 (b) Take such affirmative action as is necessary to comply with 18 this chapter; or

(c) Make a refund or restitution to a borrower or other person whois damaged as a result of a violation of this chapter.

(6) The director may issue an order removing from office or prohibiting from participation in the affairs of any licensee, or both, any officer, principal, employee or loan originator, or any person subject to this chapter for:

(a) False statements or omission of material information from an
application for a license that, if known, would have allowed the
director to deny the original application for a license;

(b) Conviction of a gross misdemeanor involving dishonesty orfinancial misconduct or a felony;

30 (c) Suspension or revocation of a license to engage in lending or 31 residential mortgage loan servicing, or perform a settlement service 32 related to lending or residential mortgage loan servicing, in this 33 state or another state;

34 (d) Failure to comply with any order or subpoena issued under this 35 chapter;

36 (e) A violation of RCW 31.04.027, 31.04.102, 31.04.155, or 37 31.04.221; or

(f) Failure to obtain a license for activity that requires a
 license.

3 (7) Except to the extent prohibited by another statute, the 4 director may engage in informal settlement of complaints or enforcement 5 actions including, but not limited to, payment to the department for 6 purposes of financial literacy and education programs authorized under 7 RCW 43.320.150. If any person subject to this chapter makes a payment 8 to the department under this section, the person may not advertise such 9 payment.

(8) Whenever the director determines that the public is likely to 10 11 be substantially injured by delay in issuing a cease and desist order, 12 the director may immediately issue a temporary cease and desist order. 13 The order may direct the licensee to discontinue any violation of this chapter, to take such affirmative action as is necessary to comply with 14 15 this chapter, and may include a summary suspension of the licensee's license and may order the licensee to immediately cease the conduct of 16 business under this chapter. The order shall become effective at the 17 18 time specified in the order. Every temporary cease and desist order 19 shall include a provision that a hearing will be held upon request to 20 determine whether the order will become permanent. Such hearing shall 21 be held within fourteen days of receipt of a request for a hearing unless otherwise specified in chapter 34.05 RCW. 22

23 (9) A licensee may surrender a license by delivering to the 24 director written notice of surrender, but the surrender does not affect the licensee's civil or criminal liability, if any, for acts committed 25 26 before the surrender, including any administrative action initiated by 27 the director to suspend or revoke a license, impose fines, compel the payment of restitution to borrowers or other persons, or exercise any 28 other authority under this chapter. The statute of limitations on 29 actions not subject to RCW 4.16.160 that are brought under this chapter 30 by the director is five years. 31

32 (10) The revocation, suspension, or surrender of a license does not 33 impair or affect the obligation of a preexisting lawful contract 34 between the licensee and a borrower.

35 (11) Every license issued under this chapter remains in force and 36 effect until it has been surrendered, revoked, or suspended in 37 accordance with this chapter. However, the director may on his or her

own initiative reinstate suspended licenses or issue new licenses to a
 licensee whose license or licenses have been revoked if the director
 finds that the licensee meets all the requirements of this chapter.

4 (12) A license issued under this chapter expires upon the licensee's failure to comply with the annual assessment requirements in 5 RCW 31.04.085, and the rules. The department must provide notice of б the expiration to the address of record provided by the licensee. 7 On 8 the 15th day after the department provides notice, if the assessment remains unpaid, the license expires. The licensee must receive notice 9 10 prior to expiration and have the opportunity to stop the expiration as set forth in rule. 11

(1) The director may issue and serve upon a licensee or applicant, or any director, officer, sole proprietor, partner, or controlling person of a licensee or applicant, a statement of charges if, in the opinion of the director, any licensee or applicant, or any director, officer, sole proprietor, partner, or controlling person of a licensee or applicant:

(a) Is engaging or has engaged in an unsafe or unsound financial
 practice in conducting a business governed by this chapter;

(b) Is violating or has violated this chapter, including violationsof:

24 (i) Any rules, orders, or subpoenas issued by the director under 25 any act;

(ii) Any condition imposed in writing by the director in connection
with the granting of any application or other request by the licensee;

7 (h) Commits a crime against the laws of any jurisdiction involving 8 moral turpitude, financial misconduct, or dishonest dealings. For the 9 purposes of this section, a certified copy of the final holding of any 10 court, tribunal, agency, or administrative body of competent 11 jurisdiction is conclusive evidence in any hearing under this chapter;

(i) Knowingly commits or is a party to any material fraud, misrepresentation, concealment, conspiracy, collusion, trick, scheme, or device whereby any other person relying upon the word, representation, or conduct acts to his or her injury or damage;

16 (j) Converts any money or its equivalent to his or her own use or 17 to the use of his or her principal or of any other person;

18 (k) Fails to disclose any information within his or her knowledge 19 or fails to produce any document, book, or record in his or her 20 possession for inspection by the director upon demand;

(1) Commits any act of fraudulent or dishonest dealing. For the purposes of this section, a certified copy of the final holding of any court, tribunal, agency, or administrative body of competent jurisdiction is conclusive evidence in any hearing under this chapter;

25 (m) Commits an act or engages in conduct that demonstrates 26 incompetence or untrustworthiness, or is a source of injury and loss to 27 the public;

(n) Violates any applicable state or federal law relating to theactivities governed by this chapter.

30 (2) The statement of charges must be issued under chapter 34.05 31 RCW. The director or the director's designee may impose the following 32 sanctions against any licensee or applicant, or any directors, 33 officers, sole proprietors, partners, controlling persons, or employees 34 of a licensee or applicant:

35 (a) Deny, revoke, suspend, or condition a license or small loan 36 endorsement;

37 (b) Order the licensee or person to cease and desist from practices

1 that violate this chapter or constitute unsafe and unsound financial 2 practices;

3 (c) Impose a fine not to exceed one hundred dollars per day for
4 each day's violation of this chapter;

5 (d) Order restitution or refunds to borrowers or other parties for 6 violations of this chapter or take other affirmative action as 7 necessary to comply with this chapter; and

8 (e) Remove from office or ban from participation in the affairs of 9 any licensee any director, officer, sole proprietor, partner, 10 controlling person, or employee of a licensee.

(3) The proceedings to impose the sanctions described in subsection (2) of this section, including any hearing or appeal of the statement of charges, are governed by chapter 34.05 RCW. <u>The statute of</u> <u>limitations on actions not subject to RCW 4.16.160 that are brought</u> <u>under this chapter by the director is five years.</u>

16 (4) Unless the licensee or person personally appears at the hearing 17 or is represented by a duly authorized representative, the licensee is 18 deemed to have consented to the statement of charges and the sanctions 19 imposed in the statement of charges.

(5) Except to the extent prohibited by another statute, the director may engage in informal settlement of complaints or enforcement actions including, but not limited to, payment to the department for purposes of financial literacy and education programs authorized under RCW 43.320.150.

25 <u>NEW SECTION.</u> Sec. 8. A new section is added to chapter 31.45 RCW 26 to read as follows:

(1) The requirements under any federal law or laws of another state 27 regarding the privacy or confidentiality of any information or material 28 29 provided to the department, and any privilege arising under federal or state law, including the rules of any federal or state court, with 30 31 respect to that information or material, continues to apply to the information or material after the information or material has been 32 disclosed to the department. If consistent with applicable law, the 33 information and material may be shared with all state and federal 34 35 regulatory officials without the loss of privilege or the loss of 36 confidentiality protections provided by federal law or state law.

1 (2) When the department is a party to a memoranda of understanding 2 or enforcement order issued by the consumer financial protection 3 bureau, the privacy, confidentiality, or privilege accorded to the 4 document by federal law continues to apply even after the memoranda or 5 order has been signed by the director or a designee.

6 (3) Any requirement under chapter 42.56 RCW relating to the 7 disclosure of confidential supervisory information or any information 8 or material described in subsection (1) or (2) of this section that is 9 inconsistent with subsection (1) or (2) of this section is superseded 10 by the requirements of this section.

11 <u>NEW SECTION.</u> Sec. 9. A new section is added to chapter 31.45 RCW 12 to read as follows:

Each licensee on a nationwide licensing system shall submit reports of condition which must be in the form and must contain the information as the director may require.
