## SENATE BILL 5087

State of Washington 65th Legislature 2017 Regular Session

**By** Senators Honeyford and Frockt; by request of Office of Financial Management

1 AN ACT Relating to the evaluation and prioritization of capital 2 budget projects at the public two-year and four-year institutions of 3 higher education; and amending RCW 43.88D.010 and 28B.77.070.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 Sec. 1. RCW 43.88D.010 and 2012 c 229 s 821 are each amended to 6 read as follows:

7 (1) By October 1st of each even-numbered year, the office of financial management shall complete an objective analysis and scoring 8 of all capital budget projects proposed by the public four-year 9 10 institutions of higher education and submit the results of the scoring process to the legislative fiscal committees and the four-11 12 year institutions. Each project must be reviewed and scored within one of the following categories, according to the project's principal 13 14 purpose. Each project may be scored in only one category. The 15 categories are:

16 (a) Access-related projects to accommodate enrollment growth at 17 main and branch campuses, at existing or new university centers, or through distance learning. Growth projects should provide significant 18 19 additional student capacity. Proposed projects must demonstrate that 20 they are based on solid enrollment demand projections, more 21 cost-effectively provide enrollment access than alternatives such as university centers and distance learning, and make cost-effective use
 of existing and proposed new space;

3 (b) Projects that replace failing permanent buildings. Facilities 4 that cannot be economically renovated are considered replacement 5 projects. New space may be programmed for the same or a different use 6 than the space being replaced and may include additions to improve 7 access and enhance the relationship of program or support space;

(c) Projects that renovate facilities to restore building life 8 and upgrade space to meet current program requirements. Renovation 9 projects should represent a complete renovation of a total facility 10 or an isolated wing of a facility. A reasonable renovation project 11 12 should cost between sixty to eighty percent of current replacement value and restore the renovated area to at least twenty-five years of 13 14 useful life. New space may be programmed for the same or a different use than the space being renovated and may include additions to 15 16 improve access and enhance the relationship of program or support 17 space;

(d) Major stand-alone campus infrastructure projects;

(e) Projects that promote economic growth and innovation through
 expanded research activity. The acquisition and installation of
 specialized equipment is authorized under this category; and

(f) Other project categories as determined by the office of financial management in consultation with the legislative fiscal committees.

25 (2) The office of financial management, in consultation with the legislative fiscal committees, shall establish a scoring system and 26 process for each four-year project category ((that is based on the 27 28 framework used in the community and technical college system of 29 prioritization)). Staff from the state board for community and technical colleges and the four-year institutions shall provide 30 31 technical assistance on the development of a scoring system and 32 process.

33 (3) The office of financial management shall consult with the 34 legislative fiscal committees in the scoring of four-year institution 35 project proposals, and may also solicit participation by independent 36 experts.

37 (a) For each four-year project category, the scoring system must,
 38 at a minimum, include an evaluation of enrollment trends,
 39 reasonableness of cost, the ability of the project to enhance

specific strategic master plan goals, age and condition of the
 facility if applicable, and impact on space utilization.

3 (b) Each four-year project category may include projects at the 4 predesign, design, or construction funding phase.

5 (c) To the extent possible, the objective analysis and scoring 6 system of all capital budget projects shall occur within the context 7 of any and all performance agreements between the office of financial 8 management and the governing board of a public, four-year institution 9 of higher education that aligns goals, priorities, desired outcomes, 10 flexibility, institutional mission, accountability, and levels of 11 resources.

12 (4) In evaluating and scoring four-year institution projects, the 13 office of financial management shall take into consideration project 14 schedules that result in realistic, balanced, and predictable 15 expenditure patterns over the ensuing three biennia.

16 (5) The office of financial management shall distribute common 17 definitions, the scoring system, and other information required for 18 the project proposal and scoring process as part of its biennial budget instructions. The office of financial management, 19 in consultation with the legislative fiscal committees, shall develop 20 21 common definitions that four-year institutions must use in developing their project proposals and lists under this section. 22

(6) In developing any scoring system for capital projects proposed by the four-year institutions, the office of financial management:

(a) Shall be provided with all required information by the four year institutions as deemed necessary by the office of financial
 management;

(b) May utilize independent services to verify, sample, or evaluate information provided to the office of financial management by the four-year institutions; and

32 (c) Shall have full access to all data maintained by the joint 33 legislative audit and review committee concerning the condition of 34 higher education facilities.

(7) By August ((1st)) <u>15th</u> of each even-numbered year each public four-year higher education institution shall prepare and submit prioritized lists of the individual projects proposed by the institution for the ensuing six-year period in each category <u>along</u> <u>with capital budget outlines for the ensuing biennium including: The</u> institutions' priority ranking of the project; the capital budget

category within which the project will be submitted; a description of 1 each capital project; and the amount and fund source being requested. 2 The lists must be submitted to the office of financial management and 3 the legislative fiscal committees. The four-year institutions may 4 aggregate minor works project proposals by primary purpose for 5 6 ranking purposes. Proposed minor works projects must be prioritized 7 the aggregated proposal, and supporting documentation, within including project descriptions and cost estimates, must be provided 8 to the office of financial management and the legislative fiscal 9 10 committees.

11 (8) Capital budget outlines for the two-year institutions must be 12 submitted to the office of financial management by August 15th of 13 each even-numbered year, and must include the prioritized ranking of 14 the capital projects being requested, a description of each capital 15 project, and the amount and fund source being requested.

16 (9) Institutions and the state board for community and technical 17 colleges shall submit any supplemental capital budget requests and 18 revisions to the office of financial management by November 1st and 19 to the legislature by January 1st.

(10)(a) The office of financial management shall develop a single 20 prioritized list of capital projects for the legislature to consider 21 that includes all of the projects requested by the four-year 22 23 institutions of higher education that were scored by the office of financial management pursuant to subsections (1) through (7) of this 24 25 section, including projects that were scored in previous biennia and received funding for an early project phase or not funded, so long as 26 the project has been requested for inclusion in the upcoming biennial 27 28 capital budget. The single prioritized list of capital projects must be based on the following priorities in the following order: 29

30 (i) Office of financial management scores pursuant to subsections
31 (1) through (7) of this section;

32 <u>(ii) Preserving assets;</u>

33 <u>(iii) Degree production; and</u>

34 (iv) Maximizing efficient use of instructional space.

35 (b) The office of financial management shall include all of the 36 capital projects requested by the four-year institutions of higher 37 education for inclusion in the upcoming biennial capital budget, 38 except for the minor works projects, in the single prioritized list

39 of capital projects provided to the legislature.

- 1 (c) The form of the prioritized list for capital projects 2 requested by the four-year institutions of higher education must be 3 provided as one list, ranked in priority order. The ranking for the 4 prioritized list of capital projects may not: 5 (i) Include subpriorities;
- <u>s (i) include subpriorities</u>,
- 6 (ii) Be organized by category;
- 7 (iii) Consider the fund source or amount requested; or
- 8 (iv) Assume any specific institutional share or distribution 9 pattern of projects among institutions in the priority list.

10 **Sec. 2.** RCW 28B.77.070 and 2012 c 229 s 110 are each amended to 11 read as follows:

(1) The council shall identify budget priorities and levels of 12 funding for higher education, including the two and four-year 13 institutions of higher education and state financial aid programs. It 14 15 is the intent of the legislature for the council to make budget 16 recommendations for allocations for major policy changes in accordance with priorities set forth in the ten-year plan, but the 17 legislature does not intend for the council to review and make 18 recommendations on individual institutional budgets. It is the intent 19 20 of the legislature that recommendations from the council prioritize 21 funding needs for the overall system of higher education in 22 accordance with priorities set forth in the ten-year plan. It is also the intent of the legislature that the council's recommendations take 23 24 into consideration the total per-student funding at similar public 25 institutions of higher education in the global challenge states.

26 (2) By December of each odd-numbered year, the council shall 27 outline the council's fiscal priorities under the ten-year plan that 28 it must distribute to the institutions, the state board for community 29 and technical colleges, the office of financial management, and the 30 joint higher education committee.

31 (((a) Capital budget outlines for the two-year institutions shall 32 be submitted to the office of financial management by August 15th of 33 each even-numbered year, and shall include the prioritized ranking of 34 the capital projects being requested, a description of each capital 35 project, and the amount and fund source being requested.

36 (b) Capital budget outlines for the four-year institutions must 37 be submitted to the office of financial management by August 15th of 38 each even-numbered year, and must include: The institutions' priority 39 ranking of the project; the capital budget category within which the 1 project will be submitted to the office of financial management in 2 accordance with RCW 43.88D.010; a description of each capital 3 project; and the amount and fund source being requested.

4 (c) The office of financial management shall reference these 5 reporting requirements in its budget instructions.))

6 (3) The council shall submit recommendations on the operating 7 budget priorities to support the ten-year plan to the office of 8 financial management by October 1st each year, and to the legislature 9 by January 1st each year.

10 ((((4)(a) The office of financial management shall develop one prioritized list of capital projects for the legislature to consider 11 that includes all of the projects requested by the four-year 12 institutions of higher education that were scored by the office of 13 financial management pursuant to chapter 43.88D RCW, including 14 15 projects that were previously scored but not funded. The prioritized 16 list of capital projects shall be based on the following priorities 17 in the following order:

- 18 (i) Office of financial management scores pursuant to chapter
  19 43.88D RCW;
- 20 (ii) Preserving assets;

21 (iii) Degree production; and

22 (iv) Maximizing efficient use of instructional space.

23 (b) The office of financial management shall include all of the 24 capital projects requested by the four-year institutions of higher 25 education, except for the minor works projects, in the prioritized 26 list of capital projects provided to the legislature.

27 (c) The form of the prioritized list for capital projects 28 requested by the four-year institutions of higher education shall be 29 provided as one list, ranked in priority order with the highest 30 priority project ranked number "1" through the lowest priority 31 project numbered last. The ranking for the prioritized list of 32 capital projects may not:

- 33 (i) Include subpriorities;
- 34 (ii) Be organized by category;

35 (iii) Assume any state bond or building account biennial funding 36 level to prioritize the list; or

37 (iv) Assume any specific share of projects by institution in the 38 priority list.

39 (5) Institutions and the state board for community and technical 40 colleges shall submit any supplemental capital budget requests and

- 1 revisions to the office of financial management by November 1st and
- 2 to the legislature by January 1st.))
