1 AN ACT Relating to a lien claimant's responsibilities when filing
2 mechanics' and materialmen's liens; amending RCW 60.04.091 and
3 60.04.081; and adding a new section to chapter 60.04 RCW.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 60.04.091 and 1992 c 126 s 7 are each amended to
6 read as follows:

7 Every person claiming a lien under RCW 60.04.021 shall file for
8 recording, in the county where the subject property is located, a
9 notice of claim of lien not later than (~~ninety~~) 90 days after the
10 person has ceased to furnish labor, professional services, materials,
11 or equipment or the last date on which employee benefit contributions
12 were due. The notice of claim of lien:

13 (1) Shall state in substance and effect:

14 (a) The name, phone number, and address of the claimant;

15 (b) The first and last date on which the labor, professional
16 services, materials, or equipment was furnished or employee benefit
17 contributions were due;

18 (c) The name of the person indebted to the claimant;

19 (d) The street address, legal description, or other description
20 reasonably calculated to identify, for a person familiar with the
21 area, the location of the real property to be charged with the lien;

1 (e) The name of the owner or reputed owner of the property, if
2 known, and, if not known, that fact shall be stated; and

3 (f) The principal amount for which the lien is claimed(~~(-)~~);

4 (2) Shall include a concise statement of facts stating why the
5 notice of claim of lien is being filed and include substantiating
6 documentation;

7 (3) Shall be signed by the claimant or some person authorized to
8 act on his or her behalf who shall affirmatively state they have read
9 the notice of claim of lien and believe the notice of claim of lien
10 to be true and correct under penalty of perjury, and shall be
11 acknowledged pursuant to chapter 64.08 RCW. If the lien has been
12 assigned, the name of the assignee shall be stated. Where an action
13 to foreclose the lien has been commenced such notice of claim of lien
14 may be amended as pleadings may be by order of the court insofar as
15 the interests of third parties are not adversely affected by such
16 amendment. A claim of lien substantially in the following form shall
17 be sufficient:

20, being sworn, says: I am the claimant (or attorney of
21 the claimant, or administrator, representative, or agent of the
22 trustees of an employee benefit plan) above named; I have read or
23 heard the foregoing claim, read and know the contents thereof, and
24 believe the same to be true and correct and that the claim of lien is
25 not frivolous and is made with reasonable cause, and is not clearly
26 excessive under penalty of perjury.

30 The period provided for recording the claim of lien is a period
31 of limitation and no action to foreclose a lien shall be maintained
32 unless the claim of lien is filed for recording within the (~~ninety-~~
33 ~~day~~) 90-day period stated. The lien claimant shall give a copy of
34 the claim of lien to the owner or reputed owner by mailing it by
35 certified or registered mail or by personal service within

1 ((fourteen)) 14 days of the time the claim of lien is filed for
2 recording. Failure to do so results in a forfeiture of any right the
3 claimant may have to attorneys' fees and costs against the owner
4 under RCW 60.04.181.

5 NEW SECTION. **Sec. 2.** A new section is added to chapter 60.04
6 RCW to read as follows:

7 (1)(a) If an owner requests clarification or additional
8 information from the lien claimant regarding the statement of facts
9 or documentation provided under RCW 60.04.091(2), the lien claimant
10 shall respond to the owner within 14 days of the owner's request.

11 (b) The lien claimant may respond through the lien claimant's
12 agent or attorney.

13 (2) The lien claimant's failure to respond within 14 days of the
14 owner's request for clarification or additional information may be
15 considered by a court when determining whether the lien is frivolous
16 and made without reasonable cause under RCW 60.04.081.

17 **Sec. 3.** RCW 60.04.081 and 2006 c 192 s 3 are each amended to
18 read as follows:

19 (1) Any owner of real property subject to a recorded claim of
20 lien under this chapter, or contractor, subcontractor, lender, or
21 lien claimant who believes the claim of lien to be frivolous and made
22 without reasonable cause, or clearly excessive may apply by motion to
23 the superior court for the county where the property, or some part
24 thereof is located, for an order directing the lien claimant to
25 appear before the court at a time no earlier than six nor later than
26 ((fifteen)) 15 days following the date of service of the application
27 and order on the lien claimant, and show cause, if any he or she has,
28 why the relief requested should not be granted. The motion shall
29 state the grounds upon which relief is asked, and shall be supported
30 by the affidavit of the applicant or his or her attorney setting
31 forth a concise statement of the facts upon which the motion is
32 based.

33 (2) The order shall clearly state that if the lien claimant fails
34 to appear at the time and place noted the lien shall be released,
35 with prejudice, and that the lien claimant shall be ordered to pay
36 the costs requested by the applicant including reasonable attorneys'
37 fees.

1 (3) If no action to foreclose the lien claim has been filed, the
2 clerk of the court shall assign a cause number to the application and
3 obtain from the applicant a filing fee pursuant to RCW 36.18.016. If
4 an action has been filed to foreclose the lien claim, the application
5 shall be made a part of that action.

6 (4) (a) If, following a hearing on the matter, the court
7 determines that the lien is frivolous and made without reasonable
8 cause, or clearly excessive, the court shall issue an order releasing
9 the lien if frivolous and made without reasonable cause, or reducing
10 the lien if clearly excessive, and awarding costs and reasonable
11 attorneys' fees to the applicant to be paid by the lien claimant. If
12 the court determines that the lien is not frivolous and was made with
13 reasonable cause, and is not clearly excessive, the court shall issue
14 an order so stating and awarding costs and reasonable attorneys' fees
15 to the lien claimant to be paid by the applicant.

16 (b) When determining whether a lien is frivolous and made without
17 reasonable cause, the court may consider the lien claimant's failure
18 to respond to an owner's request for clarification or additional
19 information, as required under section 2 of this act.

20 (5) Proceedings under this section shall not affect other rights
21 and remedies available to the parties under this chapter or
22 otherwise.
