ENGROSSED SENATE BILL 5964

State of Washington 63rd Legislature 2014 Regular Session

AN ACT Relating to training public officials and employees regarding public records, records management, and open public meetings; adding a new section to chapter 42.30 RCW; adding new sections to chapter 42.56 RCW; creating new sections; and providing an effective date.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 The legislature finds that the rights of NEW SECTION. Sec. 1. 8 citizens to observe the actions of their public officials and to have timely access to public records are the underpinnings of democracy and 9 are essential for meaningful citizen participation in the democratic 10 process. All too often, however, violations of the requirements of the 11 12 public records act and the open public meetings act by public officials and agencies result in citizens being denied this important information 13 14 and materials to which they are legally entitled. Such violations are 15 often the result of inadvertent error or a lack of knowledge on the 16 part of officials and agencies regarding their legal duties to the Also, whether due to error 17 public pursuant to these acts. or 18 ignorance, violations of the public records act and open public 19 meetings act are very costly for state and local governments, both in

terms of litigation expenses and administrative costs. The legislature 1 2 also finds that the implementation of simple, cost-effective training programs will greatly increase the likelihood that public officials and 3 agencies will better serve the public by improving citizen access to 4 public records and encouraging public participation in governmental 5 deliberations. Such improvements in public service will, in turn, 6 7 enhance the public's trust in its government and result in significant cost savings by reducing the number of violations of the public records 8 9 act and open public meetings act.

10 <u>NEW SECTION.</u> Sec. 2. A new section is added to chapter 42.30 RCW 11 to read as follows:

12 (1) Every member of the governing body of a public agency must 13 complete training on the requirements of this chapter no later than 14 ninety days after the date the member either:

(a) Takes the oath of office, if the member is required to take anoath of office to assume his or her duties as a public official; or

(b) Otherwise assumes his or her duties as a public official.

18 (2) In addition to the training required under subsection (1) of 19 this section, every member of the governing body of a public agency 20 must complete training at intervals of no more than four years as long 21 as the individual is a member of the governing body or public agency.

(3) Training may be completed remotely with technology includingbut not limited to internet-based training.

24 <u>NEW SECTION.</u> Sec. 3. A new section is added to chapter 42.56 RCW 25 to read as follows:

(1) Each local elected official and statewide elected official, and
each person appointed to fill a vacancy in a local or statewide office,
must complete a training course regarding the provisions of this
chapter, and also chapter 40.14 RCW for records retention.

30 (2) Officials required to complete training under this section may 31 complete their training before assuming office but must:

32 (a) Complete training no later than ninety days after the date the33 official either:

(i) Takes the oath of office, if the official is required to take
an oath of office to assume his or her duties as a public official; or
(ii) Otherwise assumes his or her duties as a public official; and

(b) Complete refresher training at intervals of no more than four
 years for as long as he or she holds the office.

3 (3) Training must be consistent with the attorney general's model4 rules for compliance with the public records act.

5 (4) Training may be completed remotely with technology including6 but not limited to internet-based training.

7 <u>NEW SECTION.</u> Sec. 4. A new section is added to chapter 42.56 RCW 8 to read as follows:

9 (1) Each elected state or local official, and each person appointed 10 to fill a vacancy in elective office, who is subject to the 11 requirements of this chapter must complete a training course regarding 12 the provisions of this chapter, and also chapter 40.14 RCW for records 13 retention.

14 (2) Elected officials may complete their training before assuming 15 office but must:

16 (a) Complete training no later than ninety days after the date the 17 official either:

18 (i) Takes the oath of office, if the official is required to take19 an oath of office to assume his or her duties as a public official; or

20 (ii) Otherwise assumes his or her duties as a public official; and

(b) Complete refresher training at intervals of no more than fouryears for as long as he or she holds the office.

(3) Training must be consistent with the attorney general's modelrules for compliance with the public records act.

(4) Training may be completed remotely with technology includingbut not limited to internet-based training.

27 <u>NEW SECTION.</u> Sec. 5. A new section is added to chapter 42.56 RCW 28 to read as follows:

(1) Public records officers designated under RCW 42.56.580 and records officers designated under RCW 40.14.040 must complete a training course regarding the provisions of this chapter, and also chapter 40.14 RCW for records retention.

33 (2) Public records officers must:

34 (a) Complete training no later than ninety days after assuming35 responsibilities as a public records officer or records manager; and

(b) Complete refresher training at intervals of no more than four
 years as long as they maintain the designation.

3 (3) Training must be consistent with the attorney general's model4 rules for compliance with the public records act.

5 (4) Training may be completed remotely with technology including6 but not limited to internet-based training.

7 <u>NEW SECTION.</u> Sec. 6. A new section is added to chapter 42.56 RCW 8 to read as follows:

9 The attorney general's office may provide information, technical 10 assistance, and training on the provisions of this chapter.

11 <u>NEW SECTION.</u> **Sec. 7.** This act may be known and cited as the open 12 government trainings act.

13 <u>NEW SECTION.</u> Sec. 8. This act takes effect July 1, 2014.
