1 WHEREAS, Pierce County Sheriff's Deputy Daniel Alexander
2 McCartney bravely served the people of Pierce County for three years;
3 and

4 WHEREAS, Deputy McCartney passed away on January 8th from
5 injuries sustained while responding to a call on duty; and

6 WHEREAS, Deputy McCartney graduated from Loyalton High School in
7 2002; and

8 WHEREAS, Deputy McCartney then enlisted in the United States
9 Navy, where he served as an Electronics Technician 2nd Class (E-5)
10 aboard the USS Abraham Lincoln from 2004-2008; and

11 WHEREAS, During his time in the Navy, Petty Officer Second Class
12 McCartney was awarded the Navy Marine Corps Achievement Medal, Global
13 War on Terror Service Medal, The NATO Medal, the Joint Services
14 Achievement Medal, and was twice awarded the Sea Services Deployment
15 Ribbon; and

16 WHEREAS, After being honorably discharged from the Navy, Deputy
17 McCartney served with the Hoquiam Police Department for six years;
18 and

19 WHEREAS, Deputy McCartney then transferred to the Pierce County
20 Sheriff's Department in 2014; and

21 WHEREAS, On January 8th, our community lost a husband, son,
22 father, coach, veteran, police officer, and hero; and

1 WHEREAS, Deputy McCartney's spirit of service will continue
2 through the lives he impacted as well as those he touched
3 throughout the community; and

4 WHEREAS, Deputy McCartney is survived by his wife and three
5 sons, with whom we now mourn;

6 NOW, THEREFORE, BE IT RESOLVED, That the Senate express
7 profound appreciation and enduring gratitude to Deputy McCartney
8 and the brave men and women that protect our state every day as
9 law enforcement officers; and

10 BE IT FURTHER RESOLVED, That copies of this resolution be
11 immediately transmitted by the Secretary of the Senate to the
12 family of Deputy McCartney.
