2	${f 1.}$ Page 1, line 9: delete the material beginning with "providing" and ending
3	with "procedures," on line 10.
4	${f 2.}$ Page 5, line 15: delete "For" and substitute "Beginning with the
5	accountability report published for the 2024–25 school year, for".
6	3. Page 5, line 16: delete the material beginning with "the number" and ending
7	with "(r)." on line 18 and substitute "the percentage of pupils reading at grade level
8	by the end of 3rd grade.".
9	4. Page 19, line 15: after that line insert:
10	"(d) Plan completion; 3rd grade. A 3rd grade pupil who has a personal reading
11	plan under par. (a) 1. is considered to have completed the personal reading plan if the

1	pupil's parent and the pupil's school agree that the pupil has met the goals outlined
2	in the personal reading plan and the pupil scores at grade-level in reading on a
3	summative assessment, as defined by the department by rule.".
4	5. Page 22, line 1: delete "AID. (a) <i>Payment for costs</i> " and substitute "SUPPORT.
5	(a) Payments and assessments".
6	6. Page 22, line 4: delete "sub. (2) or (3)" and substitute "sub. (3) (b)".
7	7. Page 22, line 15: after that line insert:
8	"(c) Assessments. The department shall provide to each school board and
9	operator of an independent charter school the reading readiness assessments
10	required for the school board or operator to comply with sub. (2) and (3) (a), at no cost
11	to the school board or independent charter school.".
12	8. Page 24, line 8: delete "by rule".
13	9. Page 24, line 11: delete lines 11 to 13 and substitute:
14	"(a) A requirement that the school board or operator of the charter school under
15	s. 118.40 (2r) or (2x) do all of the following for a pupil promoted to 4th grade who had
16	a personal reading plan under s. 118.016 (5) (a) 1. during the 3rd grade and who is
17	not considered to have completed the personal reading plan under s. 118.016 (5) (d):
18	1. Provide the pupil with intensive instructional services, progress monitoring,
19	and supports to remediate the identified areas of deficiency.
20	2. Notify the pupil's parent or guardian, in writing, that the pupil did not
21	complete the personal reading plan under s. 118.016 (5) (a) 1. and include a
22	description of the intensive instructional services and supports that will be provided
23	to the pupil to remediate the identified areas of reading deficiency.
