## 2023 ASSEMBLY BILL 1077

February 9, 2024 - Introduced by Representatives Summerfield, Hurd, Moses, Petryk, Pronschinske, Armstrong and Rozar, cosponsored by Senators James and Quinn. Referred to Committee on Health, Aging and Long-Term Care.

#### \*\*\*AUTHORS SUBJECT TO CHANGE\*\*\*

AN ACT to repeal 20.867 (3) (v); and to create 20.435 (1) (bd) of the statutes; relating to: transfer from the state building trust fund to the general fund, funding for grants to support hospital emergency department services, and making an appropriation.

#### Analysis by the Legislative Reference Bureau

This bill transfers \$15,000,000 from the state building trust fund to the general fund and eliminates a \$15,000,000 appropriation for a Building Commission grant in the 2021-22 fiscal year that was not used by a health system for the purpose of expanding psychiatric bed space. The bill increases the appropriation to the Joint Committee on Finance for supplemental appropriations by \$15,000,000 for fiscal year 2023-24 for grants to support hospital emergency department services.
