Analysis by the Legislative Reference Bureau

This bill ratifies and enters Wisconsin into the Social Work Licensure Compact, which provides for the ability of a social worker to become eligible to practice in other compact states. Significant provisions of the compact include the following:

1. The creation of a Social Work Licensure Compact Commission, which includes one member or administrator of the licensure authorities of each member state. The commission has various powers and duties granted in the compact, including establishing bylaws, promulgating binding rules for the compact, hiring officers, electing or appointing employees, and establishing and electing an executive committee. The commission may levy on and collect an annual assessment from each member state or impose fees on licensees of member states to cover the cost of the operations and activities of the commission and its staff.

2. The ability for a social worker who is licensed in a home state and satisfies certain other criteria to obtain a multistate license, which allows a social worker to practice social work in all other compact states (remote states) under a multistate authorization to practice. The compact specifies a number of requirements in order for an individual to obtain a social worker multistate license, including holding or being eligible for a social worker license in a home state, paying any required fees, and satisfying a number of criteria that are specific to the category of social work license the individual is seeking—bachelor’s, master’s, or clinical. A regulated social worker’s services in a remote state are subject to that member state’s regulatory authority. A remote state may take actions against a social worker’s multistate authorization to practice within that remote state, and if any adverse action is taken by a home state against a licensee’s multistate license, the social worker’s multistate authorization to practice in all other member states is deactivated until all encumbrances have been removed from the multistate license.

3. The ability of member states to issue subpoenas that are enforceable in other states.

4. The creation of a coordinated data system containing licensure and disciplinary action information on social workers. The compact requires all home state disciplinary orders that impose adverse actions against the license of a regulated social worker to include a statement that the regulated social worker’s multistate authorization to practice is deactivated in all member states until all conditions of the decision, order, or agreement are satisfied. A member state must

submit a uniform data set to the data system on all individuals to whom the compact is applicable as required by the rules of the commission.

5. Provisions regarding resolutions of disputes among member states and between member and nonmember states, including a process for termination of a state's membership in the compact if the state defaults on its obligations under the compact.

The compact becomes effective in this state upon enactment by seven states. The compact provides that it may be amended upon enactment of an amendment by all member states. A state may withdraw from the compact by repealing the statute authorizing the compact, but the compact provides that a withdrawal does not take effect until 180 days after the effective date of that repeal.

17 of which may be further governed by the rules of the commission; or

18 c. The substantial equivalency of the foregoing competency requirements
19 which the commission may determine by rule.

20 3. Attain at least a master's degree in social work from a program that is:

21 a. Operated by a college or university recognized by the licensing authority; and

22 b. Accredited, or in candidacy that subsequently becomes accredited, by an
23 accrediting agency recognized by either the Council for Higher Education
24 Accreditation or its successor; or the United States department of education.

1 4. Fulfill a practice requirement, which shall be satisfied by demonstrating
2 completion of either:

3 a. A period of postgraduate supervised clinical practice equal to a minimum of

9 (c) An applicant for a master's-category multistate license must meet all of the

13 b. Licensure of the applicant in their home state at the master's category,
14 beginning prior to such time as a qualifying national exam was required by the home
15 state at the master's category and accompanied by a continuous period of social work
16 licensure thereafter, all of which may be further governed by the rules of the
17 commission; or

18 c. The substantial equivalency of the foregoing competency requirements
19 which the commission may determine by rule.

20 2. Attain at least a master's degree in social work from a program that is:

21 a. Operated by a college or university recognized by the licensing authority; and

22 b. Accredited, or in candidacy that subsequently becomes accredited, by an
23 accrediting agency recognized by either the Council for Higher Education
24 Accreditation or its successor; or the United States department of education.

1 (d) An applicant for a bachelor's-category multistate license must meet all of
2 the following requirements:

3 1. Fulfill a competency requirement, which shall be satisfied by either:

6 beginning prior to such time as a qualifying national exam was required by the home

10 which the commission may determine by rule.

11 2. Attain at least a bachelor's degree in social work from a program that is:

12 a. Operated by a college or university recognized by the licensing authority; and

13 b. Accredited, or in candidacy that subsequently becomes accredited, by an
14 accrediting agency recognized by either the Council for Higher Education
15 Accreditation or its successor; or the United States department of education.

16 (e) The multistate license for a regulated social worker is subject to the renewal
17 requirements of the home state. The regulated social worker must maintain
18 compliance with the requirements of par. (a) to be eligible to renew a multistate
19 license.

20 (f) The regulated social worker's services in a remote state are subject to that
21 member state's regulatory authority. A remote state may, in accordance with due
22 process and that member state's laws, remove a regulated social worker's multistate
23 authorization to practice in the remote state for a specific period of time, impose
24 fines, and take any other necessary actions to protect the health and safety of its
25 citizens.

15 (c) Upon issuance of a multistate license, the home state licensing authority
16 shall designate whether the regulated social worker holds a multistate license in the
17 bachelor's, master's, or clinical category of social work.

18 (d) A multistate license issued by a home state to a resident in that state shall
19 be recognized by all compact member states as authorizing social work practice
20 under a multistate authorization to practice corresponding to each category of
21 licensure regulated in each member state.

22 **(6) AUTHORITY OF INTERSTATE COMPACT COMMISSION AND MEMBER STATE LICENSING**
23 **AUTHORITIES.** (a) Nothing in this compact, nor any rule of the commission, shall be
24 construed to limit, restrict, or in any way reduce the ability of a member state to enact
25 and enforce laws, regulations, or other rules related to the practice of social work in

3 (b) Nothing in this compact shall affect the requirements established by a
4 member state for the issuance of a single state license.

6 to limit, restrict, or in any way reduce the ability of a member state to take adverse
7 action against a licensee's single state license to practice social work in that state.

8 (d) Nothing in this compact, nor any rule of the commission, shall be construed
9 to limit, restrict, or in any way reduce the ability of a remote state to take adverse
10 action against a licensee's multistate authorization to practice in that state.

11 (e) Nothing in this compact, nor any rule of the commission, shall be construed
12 to limit, restrict, or in any way reduce the ability of a licensee's home state to take
13 adverse action against a licensee's multistate license based upon information
14 provided by a remote state.

15 **(7) REISSUANCE OF A MULTISTATE LICENSE BY A NEW HOME STATE.** (a) A licensee can
16 hold a multistate license, issued by their home state, in only one member state at any
17 given time.

18 (b) If a licensee changes their home state by moving between two member
19 states:

20 1. The licensee shall immediately apply for the reissuance of their multistate
21 license in their new home state. The licensee shall pay all applicable fees and notify
22 the prior home state in accordance with the rules of the commission.

23 2. Upon receipt of an application to reissue a multistate license, the new home
24 state shall verify that the multistate license is active, unencumbered and eligible for
25 reissuance under the terms of the compact and the rules of the commission. The

6 information by applicants for the purpose of obtaining an applicant's criminal

11 5. Notwithstanding any other provision of this compact, if a licensee does not

15 (c) If a licensee changes their primary state of residence by moving from a
16 member state to a nonmember state, or from a nonmember state to a member state,
17 then the licensee shall be subject to the state requirements for the issuance of a single
18 state license in the new home state.

19 (d) Nothing in this compact shall interfere with a licensee's ability to hold a
20 single state license in multiple states; however, for the purposes of this compact, a
21 licensee shall have only one home state, and only one multistate license.

22 (e) Nothing in this compact shall interfere with the requirements established
23 by a member state for the issuance of a single state license.

24 **(8) MILITARY FAMILIES.** An active military member or their spouse shall
25 designate a home state where the individual has a multistate license. The individual

3 (9) ADVERSE ACTIONS. (a) In addition to the other powers conferred by state law,
4 a remote state shall have the authority, in accordance with existing state due process
5 law, to:

6 1. Take adverse action against a regulated social worker's multistate
7 authorization to practice only within that member state, and issue subpoenas for
8 both hearings and investigations that require the attendance and testimony of
9 witnesses as well as the production of evidence. Subpoenas issued by a licensing
10 authority in a member state for the attendance and testimony of witnesses or the
11 production of evidence from another member state shall be enforced in the latter
12 state by any court of competent jurisdiction, according to the practice and procedure
13 of that court applicable to subpoenas issued in proceedings pending before it. The
14 issuing licensing authority shall pay any witness fees, travel expenses, mileage, and
15 other fees required by the service statutes of the state in which the witnesses or
16 evidence are located.

17 2. Only the home state shall have the power to take adverse action against a

19 (b) For purposes of taking adverse action, the home state shall give the same
20 priority and effect to reported conduct received from a member state as it would if
21 the conduct had occurred within the home state. In so doing, the home state shall
22 apply its own state laws to determine appropriate action.

23 (c) The home state shall complete any pending investigations of a regulated
24 social worker who changes their home state during the course of the investigations.
25 The home state shall also have the authority to take appropriate action(s) and shall

4 (d) A member state, if otherwise permitted by state law, may recover from the

6 resulting from any adverse action taken against that regulated social worker.

7 (e) A member state may take adverse action based on the factual findings of
8 another member state, provided that the member state follows its own procedures
9 for taking the adverse action.

10 (f) *Joint investigations.* 1. In addition to the authority granted to a member
11 state by its respective social work practice act or other applicable state law, any
12 member state may participate with other member states in joint investigations of
13 licensees.

14 2. Member states shall share any investigative, litigation, or compliance
15 materials in furtherance of any joint or individual investigation initiated under the
16 compact.

17 (g) If adverse action is taken by the home state against the multistate license
18 of a regulated social worker, the regulated social worker's multistate authorization
19 to practice in all other member states shall be deactivated until all encumbrances
20 have been removed from the multistate license. All home state disciplinary orders
21 that impose adverse action against the license of a regulated social worker shall
22 include a statement that the regulated social worker's multistate authorization to
23 practice is deactivated in all member states until all conditions of the decision, order
24 or agreement are satisfied.

1 (h) If a member state takes adverse action, it shall promptly notify the
2 administrator of the data system. The administrator of the data system shall
3 promptly notify the home state and all other member states of any adverse actions

6 participation in an alternative program may be used in lieu of adverse action.

7 (j) Nothing in this compact shall authorize a member state to demand the
8 issuance of subpoenas for attendance and testimony of witnesses or the production
9 of evidence from another member state for lawful actions within that member state.

10 (k) Nothing in this compact shall authorize a member state to impose discipline
11 against a regulated social worker who holds a multistate authorization to practice
12 for lawful actions within another member state.

13 **(10) ESTABLISHMENT OF SOCIAL WORK LICENSURE COMPACT COMMISSION.** (a) The
14 compact member states hereby create and establish a joint government agency
15 whose membership consists of all member states that have enacted the compact
16 known as the social work licensure compact commission. The commission is an
17 instrumentality of the compact states acting jointly and not an instrumentality of
18 any one state. The commission shall come into existence on or after the effective date
19 of the compact as set forth in sub. (14).

20 (b) *Membership, voting, and meetings.* 1. Each member state shall have and
21 be limited to one (1) delegate selected by that member state's state licensing
22 authority.

23 2. The delegate shall be either:

11 11. Hire employees, elect or appoint officers, fix compensation, define duties,
12 grant such individuals appropriate authority to carry out the purposes of the
13 compact, and establish the commission's personnel policies and programs relating

16 12. Assess and collect fees;

17 13. Accept any and all appropriate gifts, donations, grants of money, other

21 14. Lease, purchase, retain, own, hold, improve, or use any property, real,

25 16. Establish a budget and make expenditures;

7 agencies;

8 20. Establish and elect an executive committee, including a chair and a vice
9 chair;

10 21. Determine whether a state's adopted language is materially different from
11 the model compact language such that the state would not qualify for participation

13 22. Perform such other functions as may be necessary or appropriate to achieve
14 the purposes of this compact.

15 (d) *The executive committee.* 1. The executive committee shall have the power
16 to act on behalf of the commission according to the terms of this compact. The powers,

7 real estate;

8 f. Accusing any person of a crime or formally censuring any person;

9 g. Trade secrets or commercial or financial information that is privileged or
10 confidential;

11 h. Information of a personal nature where disclosure would constitute a clearly
12 unwarranted invasion of personal privacy;

13 i. Investigative records compiled for law enforcement purposes;

14 j. Information related to any investigative reports prepared by or on behalf of
15 or for use of the commission or other committee charged with responsibility of
16 investigation or determination of compliance issues pursuant to the compact;

17 k. Matters specifically exempted from disclosure by federal or member state
18 law; or

19 L. Other matters as promulgated by the Commission by Rule.

20 3. If a meeting, or portion of a meeting, is closed, the presiding officer shall state
21 that the meeting will be closed and reference each relevant exempting provision, and
22 such reference shall be recorded in the minutes.

23 4. The commission shall keep minutes that fully and clearly describe all
24 matters discussed in a meeting and shall provide a full and accurate summary of
25 actions taken, and the reasons therefore, including a description of the views

2 in such minutes. All minutes and documents of a closed meeting shall remain under
3 seal, subject to release only by a majority vote of the commission or order of a court

6 the payment of, the reasonable expenses of its establishment, organization, and
7 ongoing activities.

8 2. The commission may accept any and all appropriate revenue sources as

10 3. The commission may levy on and collect an annual assessment from each
11 member state and impose fees on licensees of member states to whom it grants a
12 multistate license to cover the cost of the operations and activities of the commission

15 aggregate annual assessment amount for member states shall be allocated based

3 (h) *Qualified immunity, defense, and indemnification.* 1. The members,

6 any claim for damage to or loss of property or personal injury or other civil liability
7 caused by or arising out of any actual or alleged act, error, or omission that occurred,
8 or that the person against whom the claim is made had a reasonable basis for
9 believing occurred within the scope of commission employment, duties or
10 responsibilities; provided that nothing in this subdivision shall be construed to
11 protect any such person from suit or liability for any damage, loss, injury, or liability
12 caused by the intentional or willful or wanton misconduct of that person. The
13 procurement of insurance of any type by the commission shall not in any way
14 compromise or limit the immunity granted hereunder.

15 2. The commission shall defend any member, officer, executive director,
16 employee, and representative of the commission in any civil action seeking to impose
17 liability arising out of any actual or alleged act, error, or omission that occurred

20 a reasonable basis for believing occurred within the scope of commission
21 employment, duties, or responsibilities; provided that nothing herein shall be

24 not result from that person's intentional or willful or wanton misconduct.

18 **(11) DATA SYSTEM.** (a) The commission shall provide for the development,
19 maintenance, operation, and utilization of a coordinated data system.

20 (b) The commission shall assign each applicant for a multistate license a
21 unique identifier, as determined by the rules of the commission.

22 (c) Notwithstanding any other provision of state law to the contrary, a member
23 state shall submit a uniform data set to the data system on all individuals to whom
24 this compact is applicable as required by the rules of the commission, including:

7 6. The presence of current significant investigative information; and

8 7. Other information that may facilitate the administration of this compact or

10 (d) The records and information provided to a member state pursuant to this
11 compact or through the data system, when certified by the commission or an agent
12 thereof, shall constitute the authenticated business records of the commission, and
13 shall be entitled to any associated hearsay exception in any relevant judicial,
14 quasi-judicial or administrative proceedings in a member state.

15 (e) Current significant investigative information pertaining to a licensee in any
16 member state will only be available to other member states.

17 1. It is the responsibility of the member states to report any adverse action
18 against a licensee and to monitor the database to determine whether adverse action
19 has been taken against a licensee. Adverse action information pertaining to a
20 licensee in any member state will be available to any other member state.

21 (f) Member states contributing information to the data system may designate
22 information that may not be shared with the public without the express permission
23 of the contributing state.

1 (g) Any information submitted to the data system that is subsequently
2 expunged pursuant to federal law or the laws of the member state contributing the
3 information shall be removed from the data system.

4 **(12) RULE MAKING.** (a) The commission shall promulgate reasonable rules in
5 order to effectively and efficiently implement and administer the purposes and
6 provisions of the compact. A rule shall be invalid and have no force or effect only if
7 a court of competent jurisdiction holds that the rule is invalid because the
8 commission exercised its rule-making authority in a manner that is beyond the
9 scope and purposes of the compact, or the powers granted hereunder, or based upon
10 another applicable standard of review.

11 (b) The rules of the commission shall have the force of law in each member state,
12 provided however that where the rules of the commission conflict with the laws of the
13 member state that establish the member state's laws, regulations, and applicable
14 standards that govern the practice of social work as held by a court of competent
15 jurisdiction, the rules of the commission shall be ineffective in that state to the extent
16 of the conflict.

17 (c) The commission shall exercise its rule-making powers pursuant to the
18 criteria set forth in this subsection and the rules adopted thereunder. Rules shall
19 become binding on the day following adoption or the date specified in the rule or
20 amendment, whichever is later.

21 (d) If a majority of the legislatures of the member states rejects a rule or portion
22 of a rule, by enactment of a statute or resolution in the same manner used to adopt
23 the compact within four (4) years of the date of adoption of the rule, then such rule
24 shall have no further force and effect in any member state.

25 (e) Rules shall be adopted at a regular or special meeting of the commission.

1 (f) Prior to adoption of a proposed rule, the commission shall hold a public
2 hearing and allow persons to provide oral and written comments, data, facts,
3 opinions, and arguments.

4 (g) Prior to adoption of a proposed rule by the commission, and at least thirty
5 (30) days in advance of the meeting at which the commission will hold a public
6 hearing on the proposed rule, the commission shall provide a notice of proposed rule
7 making:

8 1. On the website of the commission or other publicly accessible platform;

9 2. To persons who have requested notice of the commission's notices of proposed
10 rule making, and

11 3. In such other way(s) as the commission may by rule specify.

12 (h) The notice of proposed rule making shall include:

13 1. The time, date, and location of the public hearing at which the commission

15 location of the meeting where the commission will consider and vote on the proposed
16 rule;

17 2. If the hearing is held via telecommunication, video conference, or other
18 electronic means, the commission shall include the mechanism for access to the
19 hearing in the notice of proposed rule making;

20 3. The text of the proposed rule and the reason therefor;

21 4. A request for comments on the proposed rule from any interested person; and

22 5. The manner in which interested persons may submit written comments.

23 (i) All hearings will be recorded. A copy of the recording and all written
24 comments and documents received by the commission in response to the proposed
25 rule shall be available to the public.

18 possible, in no event later than ninety (90) days after the effective date of the rule.
19 For the purposes of this provision, an emergency rule is one that must be adopted
20 immediately in order to:

- 21 1. Meet an imminent threat to public health, safety, or welfare;
- 22 2. Prevent a loss of commission or member state funds;
- 23 3. Meet a deadline for the promulgation of a rule that is established by federal
24 law or rule; or
- 25 4. Protect public health and safety.

1 (m) The commission or an authorized committee of the commission may direct
2 revisions to a previously adopted rule for purposes of correcting typographical errors,
3 errors in format, errors in consistency, or grammatical errors. Public notice of any

5 subject to challenge by any person for a period of thirty (30) days after posting. The
6 revision may be challenged only on grounds that the revision results in a material
7 change to a rule. A challenge shall be made in writing and delivered to the

9 will take effect without further action. If the revision is challenged, the revision may
10 not take effect without the approval of the commission.

11 (n) No member state's rule-making requirements shall apply under this

14 executive and judicial branches of state government in each member state shall
15 enforce this compact and take all actions necessary and appropriate to implement
16 the compact.

17 2. Except as otherwise provided in this compact, venue is proper and judicial
18 proceedings by or against the commission shall be brought solely and exclusively in
19 a court of competent jurisdiction where the principal office of the commission is
20 located. The commission may waive venue and jurisdictional defenses to the extent
21 it adopts or consents to participate in alternative dispute resolution proceedings.
22 Nothing herein shall affect or limit the selection or propriety of venue in any action
23 against a licensee for professional malpractice, misconduct or any such similar
24 matter.

1 3. The commission shall be entitled to receive service of process in any

25 licensing authority and each of the member states' state licensing authority.

21 (j) *Enforcement.* 1. By majority vote as provided by rule, the commission may
22 initiate legal action against a member state in default in the United States District
23 Court for the District of Columbia or the federal district where the commission has
24 its principal offices to enforce compliance with the provisions of the compact and its
25 promulgated rules. The relief sought may include both injunctive relief and
