## 2019 ASSEMBLY BILL 433

September 12, 2019 - Introduced by Representatives SPIROS, C. TAYLOR, ANDERSON, BROSTOFF, CONSIDINE, DITTRICH, EMERSON, KOLSTE, KULP, MILROY, OHNSTAD, OTT, SHANKLAND, SNYDER, SPREITZER and SUBECK, cosponsored by Senators SCHACHTNER, PETROWSKI, ERPENBACH, BEWLEY, CARPENTER, RINGHAND, SMITH, L. TAYLOR and WIRCH. Referred to Committee on Mental Health.

1     **AN ACT** *to create* 20.435 (5) (dg) and 51.03 (7) of the statutes; **relating to:**  
2           regional crisis stabilization facilities and making an appropriation.

***Analysis by the Legislative Reference Bureau***

This bill requires the Department of Health Services to award grants to regional crisis stabilization facilities for adults based on criteria established by DHS such that each of five regions of the state established by DHS based on need have access to an equal amount. Current law requires certification by DHS in order to operate a youth crisis stabilization facility, which is a facility designed to prevent or de-escalate the minor's mental health crisis and avoid admission of the minor to a more restrictive setting.

5 **SECTION 2.** 20.435 (5) (dg) of the statutes is created to read:

6 20.435 (5) (dg) *Regional crisis stabilization facilities.* The amounts in the  
7 schedule to provide grants to regional crisis stabilization facilities under s. 51.03 (7).

8 **SECTION 3.** 51.03 (7) of the statutes is created to read:

9 51.03 (7) From the appropriation under s. 20.435 (5) (dg), the department shall  
10 award grants to regional crisis stabilization facilities for adults. The department  
11 shall establish criteria for a regional crisis stabilization facility to receive a grant  
12 under this subsection. In the 2020-21 fiscal year, the department shall establish 5  
13 regions based on the need for crisis stabilization services and shall award grants  
14 such that each region has access to an equal amount.
