## 2023 ASSEMBLY BILL 938

January 12, 2024 - Introduced by Representatives GUSTAFSON, GREEN, DONOVAN, ALLEN, EDMING, RETTINGER and ROZAR, cosponsored by Senators TESTIN, BRADLEY, CABRAL-GUEVARA, HUTTON and QUINN. Referred to Committee on Ways and Means.

1     **AN ACT** *to create* 71.05 (6) (b) 57. and 71.05 (6) (b) 58. of the statutes; **relating**  
2     **to:** an income tax subtraction for overtime wages and certain bonuses.

***Analysis by the Legislative Reference Bureau***

This bill creates an individual income tax exemption for hourly wages received by an employee for work performed in excess of 40 hours for a single employer in any week during the taxable year. The bill also creates an individual income tax exemption of up to \$2,500 for each taxable year for bonuses received by an employee for work performed for an employer.

Because this bill relates to an exemption from state or local taxes, it may be referred to the Joint Survey Committee on Tax Exemptions for a report to be printed as an appendix to the bill.

***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

3     **SECTION 1.** 71.05 (6) (b) 57. of the statutes is created to read:  
4     71.05 (6) (b) 57. For taxable years beginning after December 31, 2023, income  
5     received in the form of hourly wages received by an employee for work performed in  
6     excess of 40 hours for a single employer in any week during the taxable year.
