2023 SENATE BILL 152

April 3, 2023 - Introduced by Senators JACQUE, NASS, TAYLOR and WANGGAARD, cosponsored by Representatives MAGNAFICI, ORTIZ-VELEZ, BALDEH, BEHNKE, BRANDTJEN, CABRERA, CONLEY, EDMING, GUNDRUM, MURSAU, SUBECK, TITTL, WICHGERS, SINICKI and HAYWOOD. Referred to Committee on Insurance and Small Business.

AUTHORS SUBJECT TO CHANGE

1 **AN ACT** *to amend* 40.51 (8), 40.51 (8m), 66.0137 (4), 120.13 (2) (g) and 185.983
2 (1) (intro.); and *to create* 609.847 and 632.728 of the statutes; **relating to:**
3 coverage of individuals with preexisting conditions and benefit limits under
4 health plans.

Analysis by the Legislative Reference Bureau

This bill generally sets certain requirements and limitations on health insurance coverage in the event the federal Patient Protection and Affordable Care Act no longer preempts state law on the topic. Currently, the Affordable Care Act generally allows premium rates to be based only on individual or family coverage, rating area, age, and tobacco use; requires group and individual health insurance policies to accept every employer and individual that applies for coverage, known as guaranteed issue, and renew health insurance coverage at the option of the sponsor or individual; and prohibits health insurance policies from imposing preexisting condition exclusions. If those requirements and limitations of the Affordable Care Act become no longer enforceable or no longer preempt state law, all of the following apply under the bill:

1. Every individual health benefit plan must accept every individual in this state who applies for coverage and every group health benefit plan must accept every employer in this state that applies for coverage, regardless of whether any individual or employee has a preexisting condition. A health benefit plan may restrict enrollment in coverage to open or special enrollment periods, and the commissioner of insurance must ensure a statewide 45-day open enrollment period allowing

individuals, including individuals who do not have coverage, to enroll in coverage. Health benefit plans must provide special enrollment periods for certain qualifying events described in federal law.

2. A health benefit plan offered on the individual or small employer market or a self-insured governmental health plan may not vary premium rates for a specific plan on any basis except age, tobacco use, area in the state, and whether the plan covers an individual or a family.

3. A health benefit plan or a self-insured governmental health plan may not impose a preexisting condition exclusion. A preexisting condition exclusion is defined in the bill as a limitation or exclusion of benefits relating to a condition based on the fact that the condition was present before the date of enrollment for the coverage, whether or not any medical advice, diagnosis, care, or treatment was recommended or received before the date of enrollment for coverage.

4. A health benefit plan or a self-insured governmental health plan is prohibited from imposing an annual or lifetime limit on the dollar value of benefits under the plan.

The Affordable Care Act exempts certain plans from complying with the act's provisions. Similarly, any health benefit plan that is exempt from a provision of the Affordable Care Act is exempt from complying with the corresponding provision of this bill.

This proposal may contain a health insurance mandate requiring a social and financial impact report under s. 601.423, stats.

3 **SECTION 3.** 66.0137 (4) of the statutes is amended to read:

4 66.0137 (4) SELF-INSURED HEALTH PLANS. If a city, including a 1st class city, or
5 a village provides health care benefits under its home rule power, or if a town
6 provides health care benefits, to its officers and employees on a self-insured basis,
7 the self-insured plan shall comply with ss. 49.493 (3) (d), 631.89, 631.90, 631.93 (2),
8 632.728, 632.729, 632.746 (10) (a) 2. and (b) 2., 632.747 (3), 632.798, 632.85, 632.853,
9 632.855, 632.861, 632.867, 632.87 (4) to (6), 632.885, 632.89, 632.895 (9) to (17),
10 632.896, and 767.513 (4).

11 **SECTION 4.** 120.13 (2) (g) of the statutes is amended to read:

16 **SECTION 5.** 185.983 (1) (intro.) of the statutes is amended to read:

18 cooperative association organized under s. 185.981 shall be exempt from chs. 600 to
19 646, with the exception of ss. 601.04, 601.13, 601.31, 601.41, 601.42, 601.43, 601.44,
20 601.45, 611.26, 611.67, 619.04, 623.11, 623.12, 628.34 (10), 631.17, 631.89, 631.93,
21 631.95, 632.72 (2), 632.728, 632.729, 632.745 to 632.749, 632.775, 632.79, 632.795,

5 **632.728 Coverage of individuals with preexisting conditions; rating;**

7 (a) “Health benefit plan” has the meaning given in s. 632.745 (11).

8 (b) “Preexisting condition exclusion” means, with respect to coverage, a
9 limitation or exclusion of benefits relating to a condition based on the fact that the
10 condition was present before the date of enrollment for the coverage, whether or not
11 any medical advice, diagnosis, care, or treatment was recommended or received
12 before the date of enrollment for coverage.

13 (c) “Self-insured health plan” has the meaning given in s. 632.85 (1) (c).

14 (d) “Small employer” has the meaning given in s. 635.02 (7).

15 **(2) ACCESS TO COVERAGE.** Every individual health benefit plan shall accept
16 every individual in this state who applies for coverage and every group health benefit
17 plan shall accept every employer in this state that applies for coverage, regardless
18 of whether any individual or employee has a preexisting condition. A health benefit
19 plan may restrict enrollment in coverage described in this subsection to open or
20 special enrollment periods under sub. (4).

21 **(3) PREMIUM RATE VARIATION.** A health benefit plan offered on the individual or
22 small employer market or a self-insured health plan may vary premium rates for a
23 specific plan based only on the following considerations:

24 (a) Whether the plan covers an individual or a family.

25 (b) Rating area in the state, as established by the commissioner.

1 (c) Age, except that the rate may not vary by more than 3 to 1 for adults over
2 the age groups and the age bands shall be consistent with recommendations of the
3 National Association of Insurance Commissioners.

4 (d) Tobacco use, except that the rate may not vary by more than 1.5 to 1.

5 **(4) ENROLLMENT PERIODS.** (a) The commissioner shall ensure that every
6 individual health benefit plan has open enrollment during a statewide open
7 enrollment period of no longer than 45 days to allow individuals, including
8 individuals who do not have coverage, to enroll in coverage.

9 (b) Every health benefit plan shall provide special enrollment periods for
10 qualifying events under 26 USC 9801 (f) and 29 USC 1163.

11 **(5) PREEXISTING CONDITION EXCLUSION.** An individual or group health benefit
12 plan or a self-insured health plan may not impose a preexisting condition exclusion
13 for any time on an enrollee or beneficiary under the plan.

14 **(6) ANNUAL AND LIFETIME LIMITS.** An individual or group health benefit plan or
15 a self-insured health plan may not establish any of the following:

16 (a) Lifetime limits on the dollar value of benefits for an enrollee or a dependent
17 of an enrollee under the plan.

18 (b) Annual limits on the dollar value of benefits for an enrollee or a dependent
19 of an enrollee under the plan.

20 **(7) APPLICABILITY.** (a) This section applies only if provisions of the federal
21 Patient Protection and Affordable Care Act, P.L. 111-148, as amended, under 42
22 USC 300gg to 300gg-4 and 300gg-11 are no longer enforceable or no longer preempt
23 state law relating to individual or group health insurance policies. If this section
24 applies, this section supersedes any conflicting provision of s. 625.12 (1) or (2), 625.15
25 (1), 628.34 (3), 632.746, 632.76, 632.795 (4) (a), 632.896 (4), or 632.897 (11) (a) or any

1 other conflicting provision in chs. 600 to 655 to the extent this section conflicts with
2 that provision.

3 (b) 1. A health benefit plan that is not required to comply with 42 USC 300gg-1
4 as amended as of January 1, 2019, is not required to comply with sub. (2).

5 2. A health benefit plan that is not required to comply with 42 USC 300gg as
6 amended as of January 1, 2019, is not required to comply with sub. (3).

7 3. A health benefit plan that is not required to comply with 42 USC 300gg-3
8 as amended as of January 1, 2019, is not required to comply with sub. (5).

9 4. A health benefit plan that is not required to comply with 42 USC 300gg-11
10 (a) (1) (A) as amended as of January 1, 2019, is not required to comply with sub. (6)
11 (a).

12 5. A health benefit plan that is not required to comply with 42 USC 300gg-11
13 (a) (1) (B) as amended as of January 1, 2019, is not required to comply with sub. (6)
14 (b).
