31 (a) There is appropriated to the University of Wyoming six
32 million dollars (\$6,000,000.00) from the general fund.

2 (b) The reappropriation in Section 303(g) of this act and the
3 appropriation in subsection (a) of this section are for purposes
4 of establishing a center for smart contract research and
5 development at the University of Wyoming in accordance with this
6 section. The appropriation in this section and the reappropriation
7 in Section 303(g) of this act shall be subject to the following:
8

9 (i) Expenditure of the funds appropriated in this
10 section and reappropriated in Section 303(g) of this act is
11 conditioned upon a match of funds in the ratio of one dollar
12 (\$1.00) of appropriated or reappropriated funds to one dollar
13 (\$1.00) of matching funds from any private entity donating funds
14 or cryptocurrency for this purpose;
15

16 (ii) The state treasurer shall make transfers to the
17 university under this section not later than the end of the
18 calendar quarter following the quarter during which not less than
19 ten million dollars (\$10,000,000.00) in matching funds are
20 received by the university. For purposes of calculating the
21 matching amount only, the state treasurer shall use the value of
22 any donated cryptocurrency based on its fair market value at the
23 time the donation is received by the university. The state
24 treasurer shall transfer funds reappropriated in Section 303(g) of
25 this act before transferring funds appropriated in subsection (a)
26 of this section;
27

28 (iii) Matching funds appropriated or reappropriated that
29 are transferred to the University of Wyoming under this section
30 shall be endowed by the university and shall be deposited in a
31 separate endowment account. Funds in the separate endowment
32 account shall only be used as specified in this paragraph. Funds
33 within the separate endowment account shall be invested as provided
34 by law and shall not be expended for any other purpose. Earnings
35 generated from investments of the funds within the separate
36 endowment account shall only be used for the following purposes:
37

38 (A) Creating a center for smart contract research
39 and development at the University of Wyoming;

41 (B) Hiring an executive director and other
42 employees for the center for smart contract research and
43 development specified in subparagraph (A) of this paragraph;

45 (C) Hiring and funding endowed faculty positions
46 that are housed within the center;

1 (D) Hiring and funding research personnel and
2 graduate students to perform research and development for the
3 center.

5 (iv) The University of Wyoming may establish an advisory
6 council for the center for smart contract research and development
7 if the center is created as provided in this section;

8
9 (v) The reappropriation in Section 303(g) of this act
10 and the appropriation in this section shall not be transferred or
11 expended for any other purpose. Notwithstanding any other
12 provision of law, the reappropriation in Section 303(g) of this
13 act and the appropriation in this section shall not revert.".
