1 Delete the Larsen second reading amendment (HB0001H2009/AC), the  
2 Stith et al. second reading amendment (HB0001H2017/A), the  
3 Nicholas et al. second reading amendment (HB0001H2039/A), the  
4 Wilson et al. third reading amendment (HB0001H3007/A) and the  
5 Connolly et al. third reading amendment (HB0001H3012/A) entirely  
6 and further amend as follows:

8 Page 104-after line 25 Insert the following new section and  
9 renumber as necessary:

11 "[RESTORATION OF GOVERNOR'S STEP 3 BUDGET REDUCTIONS]

13 **Section 340.**

14  
15 (a) There is appropriated up to twenty-three million three  
16 hundred ninety-four thousand thirty-two dollars (\$23,394,032.00)  
17 from the legislative stabilization reserve account to the state  
18 auditor's office in order to restore one-half (1/2) of the general  
19 fund budget reductions identified as "step 3" budget reductions in  
20 the governor's 2021-2022 supplemental budget recommendations.  
21 There is authorized up to fifty-three (53) full-time employees for  
22 purposes of this section.

23  
24 (b) To the extent funds are available, there is appropriated  
25 matching amounts from nongeneral fund sources including federal  
26 and other funds necessary to increase expenditures wherein federal  
27 or state law provides for a specific matching amount.

28  
29 (c) Expenditure of funds appropriated under this section  
30 shall only be made upon approval of the governor and all transfers  
31 authorized under this section shall be approved by the governor  
32 and reported to the joint appropriations committee through the  
33 B-11 process as authorized by W.S. 9-2-1005(b)(ii) and reported  
34 pursuant to W.S. 9-2-1013(b). Transfers made under this section

1 shall not be subject to authorization created under 2020 Wyoming  
2 Session Laws, Chapter 80, Section 305.

3  
4 (d) The appropriation in this section shall not be  
5 transferred or expended for any other purpose and any unexpended,  
6 unobligated funds remaining from these appropriations shall revert  
7 as provided by law on June 30, 2022.

8  
9 (e) No funds appropriated under this section shall be  
10 transferred or expended for purposes that would increase the  
11 appropriation beyond the level of one-half (1/2) of the budget  
12 reduction identified as "step 3" in the governor's 2021-2022  
13 supplemental budget recommendations.

14  
15 (f) It is the intent of the legislature that the  
16 appropriation in this section be included within the standard  
17 budget for the immediately succeeding fiscal biennium for each  
18 agency receiving a transfer under this section.

19  
20 (g) It is the intent of the legislature that the governor  
21 use the appropriation and transfer authority under this section to  
22 delay general fund budget reductions identified as "step 3" budget  
23 reductions in the governor's 2021-2022 supplemental budget  
24 recommendations until at least November 1, 2021."
