12 **9-4-225. Capitol square preservation account.**

13  
14 The capitol square preservation account is created. The state  
15 treasurer may accept federal grants and other contributions,  
16 grants, gifts, transfers, bequests and donations of money from any  
17 source for deposit into the account. Funds within the account shall  
18 only be expended upon legislative appropriation. All funds within  
19 the account shall be invested by the state treasurer and all  
20 investment earnings from the account shall be credited to the  
21 general fund."

10 **Section 8.**

11  
12 (a) The chairman of the management council of the legislature  
13 shall appoint three (3) members of the management council and the  
14 governor shall appoint three (3) members of the state building  
15 commission or their designees to create a subcommittee to jointly  
16 oversee development of the design plans, construction of the  
17 interpretive exhibits and wayfinding in the capitol, the capitol  
18 extension and the Herschler building. The subcommittee shall:

19  
20 (i) In developing recommendations for design and construction  
21 documents to the interpretive exhibits, be guided by the schematic  
22 design documents developed as part of the capitol square project  
23 which are on file with the legislative service office;

24  
25 (ii) Report its recommendations to the management council and  
26 the state building commission for final approval.

27  
28 (b) The legislative service office and construction  
29 management division of the state construction department shall  
30 staff the subcommittee created by this section. The legislative  
31 service office, the state construction department, the department  
32 of education, the office of tourism, the department of state parks  
33 and cultural resources and other state entities as determined  
34 appropriate by the subcommittee shall provide support for the  
35 design and construction of the exhibits and wayfinding systems.

36  
37 (c) There is appropriated four million five hundred thousand  
38 dollars (\$4,500,000.00) from the strategic investments and  
39 projects account to the capitol square preservation account.

40  
41 (d) There is appropriated four million two hundred fifty  
42 thousand dollars (\$4,250,000.00) from the capitol square  
43 preservation account to the state construction department. The  
44 state construction department shall be the fiscal and contracting  
45 agent for expenditure of this appropriation. After consultation  
46 with the subcommittee created under this section, the state

1 construction department shall expend this appropriation for the  
2 purposes of:

3  
4 (i) Development of design and construction documents and  
5 the construction of interpretative exhibits for the capitol and  
6 the capitol extension in accordance with the recommendations  
7 approved by the management council and the state building  
8 commission;

9  
10 (ii) Design, construction and installation of a  
11 wayfinding system and signage for the capitol, the capitol  
12 extension and the Herschler building in accordance with the  
13 recommendations approved by the management council and the state  
14 building commission.

15  
16 (e) There is appropriated two hundred fifty thousand dollars  
17 (\$250,000.00) from the capitol square preservation account to the  
18 legislative service office. Subject to the approval of management  
19 council, this appropriation may be expended for purposes of any of  
20 the following:

21  
22 (i) Custom window treatments within meeting rooms  
23 occupied by the legislature in the capitol building;

24  
25 (ii) Noise reduction and echo cancellation improvements  
26 in meeting rooms occupied by the legislature in the capitol  
27 building and the capital extension;

28  
29 (iii) Acquisition of maquettes of the statues displayed  
30 in the capitol rotunda."
