17 (a) On July 1, 2021, all funds within the strategic  
18 investments and projects account created by 2013 Wyoming Session  
19 Laws, Chapter 73, Section 4, Section 300(e) ~~is continued and~~  
20 ~~codified shall be transferred to the legislative deficit control~~  
21 ~~account. Funds within the account shall only be expended by~~  
22 ~~legislative appropriation.~~ Subject to subsection (b) of this  
23 section, the governor may include appropriation requests from  
24 funds available within the ~~strategic investments and projects~~  
25 ~~account~~ legislative deficit control account within his biennial  
26 budget requests for one-time expenditures as he deems necessary.  
27 ~~All funds within the account shall be invested by the state~~  
28 ~~treasurer and all investment earnings from the account shall be~~  
29 ~~credited to the general fund, except as provided by W.S. 9-4-~~

32 (b) For fiscal year 2021 and in each fiscal year thereafter  
33 unencumbered and unobligated funds available for expenditure in

8 (a) ~~There is created~~The Wyoming state penitentiary capital  
9 construction account ~~within the strategic investments and projects~~  
10 ~~account created by W.S. 9-4-220 shall be transferred to and~~  
11 ~~continued within the legislative deficit control account.~~ Funds  
12 in the account shall only be expended upon legislative  
13 appropriation. Through the fiscal year ending June 30, 2034, all  
14 funds within the account shall be invested in the pool A investment  
15 account by the state treasurer pursuant to W.S. 9-4-715(p).  
16 Thereafter, all funds within the account shall be invested as  
17 determined by the state treasurer. All investment earnings from  
18 the account shall be credited to the account. For purposes of  
19 accounting and investing only, the Wyoming state penitentiary  
20 capital construction account shall be treated as a separate account  
21 from the ~~strategic investments and projects account~~ legislative  
22 deficit control account.

24 (b) Beginning on June 30, 2021 for fiscal year 2021 and June  
25 30 of each fiscal year thereafter as provided in this subsection,  
26 the state treasurer shall transfer ten million dollars  
27 (\$10,000,000.00), or as much thereof as is available, from any  
28 unobligated funds within the ~~strategic investments and projects~~  
29 ~~account~~ legislative deficit control account to the Wyoming state  
30 penitentiary capital construction account. The state treasurer  
31 shall cease transferring funds to the Wyoming state penitentiary  
32 capital construction account pursuant to this subsection on July  
33 1, 2038."
