## A BILL

for

- 1 AN ACT relating to the administration of government;
- 2 allowing the secretary of state to charge a fee to expedite
- 3 filings of documents as specified; authorizing a position;
- 4 providing an appropriation; specifying a contingency; and
- 5 providing for an effective date.

7 Be It Enacted by the Legislature of the State of Wyoming:

- 9 **Section 1.** W.S. 9-1-305(a) by creating a new
- 10 paragraph (viii) is amended to read:

12 9-1-305. Fees; amounts; collection; exceptions.

14 (a) The secretary of state shall collect the

1

15 following fees in advance for:

2	(viii) Expediting the filing of any document
3	filed pursuant to title 17, title 34 or title 40, chapters
4	1 and 2 of the Wyoming statutes, a maximum of five thousand
5	dollars (\$5,000.00). Notwithstanding any other law to the
6	contrary, the secretary of state may charge a fee as
7	specified in this paragraph to expedite the filing of a
8	document filed with the secretary of state's office
9	pursuant to title 17, title 34 or title 40, chapters 1 and
10	2 of the Wyoming statutes upon the request of the filer.
11	The fee and process for requesting an expedited filing
12	shall be established by rule of the secretary of state
13	taking into account the cost of the filing fee, the costs
14	of expediting the filing and deadlines for response
15	required by law. The expedition of a filing shall not grant
16	any benefit over a nonexpedited filing for purposes of the
17	timing of filing.

21 (a) Subject to subsection (c) of this section, the 22 secretary of state is authorized up to one (1) full-time 23 position for the period beginning with the effective date

- 1 of this act and ending June 30, 2026 for purposes of
- 2 implementing this act. It is the intent of the legislature
- 3 that the secretary of state include this full-time position
- 4 in its standard budget request for the immediately
- 5 succeeding fiscal biennium.

6

- 7 (b) Subject to subsection (c) of this section, there
- 8 is appropriated ninety-three thousand one hundred seventy-
- 9 nine dollars (\$93,179.00) from the general fund to the
- 10 secretary of state for the period beginning with the
- 11 effective date of this act and ending June 30, 2026 to be
- 12 expended only for the purposes of funding the position
- 13 authorized in subsection (a) of this section. This
- 14 appropriation shall not be transferred or expended for any
- 15 other purpose and any unexpended, unobligated funds
- 16 remaining from this appropriation shall revert as provided
- 17 by law on June 30, 2026. It is the intent of the
- 18 legislature that this appropriation be doubled and included
- 19 in the standard budget request of the secretary of state
- 20 for the immediately succeeding fiscal biennium.

- 22 (c) The authorization and appropriation under
- 23 subsections (a) and (b) of this section shall not be

1 effective if 2025 House Bill 0001 or Senate File 0001, as

2 enacted into law, authorizes at least one (1) additional

3 full-time position for the secretary of state compared to

4 the number of positions authorized in 2024 Wyoming Session

5 Laws, Chapter 118, Section 002.

7 Section 3. This act is effective July 1, 2025.
