The 13 department shall treat the records as confidential, 14 15 provided that the department, with the consent of the 16 registrant, or the registrant's parent, may share the records with a higher education institution for the purpose 17 of studying hemp extract if the records are redacted so 18 19 that the patient cannot be identified individually.
