8 Be It Enacted by the Legislature of the State of Wyoming:

10 **Section 1.** W.S. 31-4-106 is created to read:

11

12 31-4-106. Failure to title or register vehicle;

13 penalties; nonpayment of fines.

(a) In addition to the other penalties provided by 1 2 this section, any person who violates W.S. 31-4-101(a)(i)

3 shall be fined not more than seven hundred fifty dollars

4 (\$750.00), imprisoned for a period not to exceed six (6)

5 months, or both.

(b) The unpaid portion of any fine due under this 7

8 section becomes delinquent if not paid within one hundred

fifty-one (151) days of the date the fine was imposed. 9

Delinquent fines are a lien on the vehicle for which the 10

11 delinquent payment is due. Upon perfection of the lien

12 pursuant to W.S. 31-2-801 and subject to the priority of

13 other security interests, the department may foreclose on

the lien and collect the amount of delinquent fines in a 14

civil action against the vehicle owner. 15

Registration exemptions. 8 (a) The following vehicles are exempt from the 9 provisions of this article: 10 11 12 (v) Vehicles owned by a nonresident, validly registered in another state or country, displaying 13 registration numbers or plates in accordance with the laws 14 15 of that state or country and: 16 17 (A) Not operated for gain or profit in 18 Wyoming nor used for transportation to or from employment 19 in Wyoming; and 20 21 (B) Not owned or operated by a person employed in this state, unless that person is a daily 22 commuter from another jurisdiction which exempts vehicles 23

1	of daily commuters from Wyoming from registration under a
2	reciprocity agreement; and

4	(C) Not operated by a natural person who is
5	a resident of Wyoming.

7	Section 3. This act is effective July 1, 2017.
