## A BILL

for

- 1 AN ACT relating to motor vehicles; authorizing a special
- 2 license plate for support of cancer prevention and
- 3 awareness; specifying use of the funds donated for the
- 4 special license plate; specifying qualifications to receive
- 5 the special license plate; granting authority to promulgate
- 6 rules; specifying requirements for the design and continued
- 7 production of the special license plate; and providing for
- 8 an effective date.

10 Be It Enacted by the Legislature of the State of Wyoming:

12 **Section 1.** W.S. 31-2-229 is created to read:

13

- 14 31-2-229. Special plates; cancer prevention and
- awareness.

2 Any person required to register a vehicle in Wyoming may obtain distinctive cancer prevention 3 4 awareness license plates for any motor vehicle owned by 5 that person upon registration of the vehicle. plates issued under this section shall be displayed only on 6 the vehicle for which they are issued. The license plates 7 shall bear a distinctive symbol and letters identifying the 8 9 registrant as an individual supporting cancer prevention 10 and awareness.

To obtain and retain license plates under this 12 (b) 13 section the registrant shall submit an annual donation of at least one hundred dollars (\$100.00) to the cancer 14 control program established and administered by the 15 department of health. Donations must be received by the 16 17 department of health not less than sixty (60) days before the registration of the vehicle expires. Within thirty 18 (30) days of receiving the donation, the department shall 19 20 issue a proof of donation which shall establish the 21 registrant's eligibility to receive, or continue 22 displaying, a special cancer awareness license plate from the county. Donations to the cancer control program 23 collected under this section shall be payable to the 24

- 1 department of health and shall be deposited in an account
- 2 to be used in a manner consistent with the purposes of W.S.

3 35-25-203.

4

- 5 (c) Except as provided in this section, payment for
- 6 issuance and renewal of cancer prevention and awareness
- 7 license plates shall be subject to the same requirements
- 8 and fees as provided in this article. The fee required
- 9 under W.S. 31-3-102(a)(viii) shall apply to special license
- 10 plates described in this section.

11

- 12 (d) The department of health shall consult with the
- 13 department of transportation to design a special cancer
- 14 prevention and awareness license plate as authorized by
- 15 this section and arrange for production of the special
- 16 license plates. Following approval by the Wyoming
- 17 department of transportation, special cancer prevention and
- 18 awareness license plates shall be subject to redesign on
- 19 the same schedule as all license plates beginning with the
- 20 year 2017 reissuance. The license plates shall be issued by

21 the county treasurer of each county.

5 (f) Unless one thousand (1,000) sets of license

6 plates are issued under this section before December 31,

7 2016, the plate authorized under this section shall be

8 eliminated from production and the department shall report

9 the cessation of production to the legislature not later

10 than January 15, 2017.
