5 Be It Enacted by the Legislature of the State of Wyoming:

7 **Section 1.** W.S. 26-20-401 is created to read:

- 10 INHERITED ENZYMATIC DISORDER COVERAGE

- 12 26-20-401. Inherited enzymatic disorder coverage
- 13 required.

- 15 (a) All individual and group health insurance
- 16 policies providing coverage on an expense incurred basis,

1 individual and group service or indemnity type contracts 2 issued by any insurer including any nonprofit corporation 3 and individual and group service contracts issued by a 4 health maintenance organization, shall also 5 coverage for the equipment, supplies and outpatient selfmanagement training education, including medical 6 and nutrition therapy for the treatment of inherited enzymatic 7 disorders caused by single gene defects involved in the 8 9 metabolism of amino, organic and fatty acids if prescribed 10 by a health care professional legally authorized to prescribe such items under law. Covered inherited enzymatic 11 disorder outpatient self-management training and education 12 shall be provided by a certified, registered or licensed 13 14 health care professional with expertise in inherited enzymatic disorders. For purposes of this section, required 15 covered outpatient self-management training and education 16

shall be limited to:

19 (i) A one (1) time evaluation and training 20 program when medically necessary for the caregiver or 21 patient;

1 (ii) Additional medically necessary self-

2 management training shall be provided upon a significant

3 change in symptoms, condition or treatment.

5 (b) For purposes of this section, "inherited

6 enzymatic disorders" includes, but is not limited to

7 phenylketonuria, maternal phenylketonuria, maple syrup

8 urine disease, tyrosinemia, homocystinuria, histidinemia,

9 urea cycle disorders, hyperlysinemia, glutaric acidemias,

10 methylmalonic acidemia and propionic acidemia.

12 (c) The benefits provided under this section shall be

subject to the same annual deductibles or coinsurance

14 established for all other covered benefits within a given

15 policy. Private third party payors may not refuse, reduce

16 or eliminate coverage due to the requirements of this

17 section. Enforcement of this section shall be performed by

18 the commissioner or his designee.

20 (d) This section shall apply to a private health

21 benefit plan as defined under W.S. 26-1-102(a)(xxxiii)
