W.S. 26-32-101(a) and (b) is amended to 11 read: 12 13 26-32-101. Supervision and audit of funds; approval 14 of investment; promulgation of rules and regulations; 15 licenses.

2 The department shall supervise and audit the (a) 3 funds derived by any person either residing in or doing 4 business within the state, from prepaid or prearranged 5 funeral contracts providing for the sale of caskets, burial vaults, monuments or memorials or any burial supplies and б equipment and funeral services, if the sale is made, either 7 8 outright or on the installment basis, prior to the demise 9 the person purchasing them or for whom they are of 10 purchased, with the merchandise or service, or both, to be delivered at a future date at time of need. All funds 11 12 received from these contracts or arrangements by any person 13 either residing in or doing business within this state shall be received, invested and withdrawn according to 14 requirements the department approves. Investment in a bank, 15 16 trust company or federal building savings and loan 17 association in Wyoming is an approved investment. The 18 deposit of funds received from the sale of these contracts 19 or arrangements in irrevocable pre-need funeral trusts, the 20 funds of which are invested in compliance with W.S. 21 4-10-901 and 4-10-902, is an approved investment. Earnings, 22 including interest, income and dividends, from any 23 investment of an irrevocable pre-need funeral trust may

1	inure to the benefit of the seller of the prepaid or
2	prearranged funeral contract, but shall be withdrawn from
3	the irrevocable trust only upon the occurrence of an event
4	that requires withdrawal of the corpus of the trust.
5	Neither the person purchasing a prepaid or prearranged
6	funeral contract nor any person for whom the contract is
7	purchased shall be entitled to terminate or cancel the
8	contract or make demand for the funds paid for the contract
9	after the funds are deposited into an irrevocable pre-need
10	funeral trust.

12 (b) The commissioner shall promulgate rules and regulations for the purposes specified in subsection (a) of 13 14 this section to include regulation of contract provisions The rules shall require notice to 15 and funds thereunder. 16 buyers of prepaid or prearranged funeral contracts of the 17 types of investments into which funds derived from the sale 18 of these contracts may be deposited and the risks associated with those investments. The rules shall require 19 20 notice to buyers of the ability to cancel or terminate a 21 contract or make demand for any amounts paid for the 22 contract. Rules promulgated by the commissioner shall not require any additional surety bond amount for those monies 23

19	immediately upon completion of all acts necessary for a

21	the Wyoming Constitution.
