To provide a property owner with information regarding the 1 2 owner's property only, a city or town shall ensure that 3 notice is provided to the property owner of record of a 4 past due municipal water, sewer, electric, trash or recycling account. One (1) notice shall be sent when an 5 account has been past due for thirty (30) days and one (1) 6 notice shall be sent when an account has been past due for 7 sixty (60) days. Notices required by this section shall be 8 9 sent to the record owners by first class mail or electronic 10 mail to the record owners' addresses on file with the city 11 or town. Notices required by this section shall be in 12 addition to any notices sent to an account holder. Each 13 city or town shall adopt appropriate policies to implement 14 this section.
