1 1, 1966, may take any wildlife by the use of firearms on

2 land other than that of his own family, unless the person

3 possesses or can demonstrate they have obtained a

4 certificate of competency and safety in the use and

5 handling of firearms as provided by subsection (b) of this

6 section.

Except as provided in subsection (e) of this 8 (C) 9 section, a person who has not received a certificate of 10 competency and safety in the use and handling of firearms 11 as provided by subsection (b) of this section may apply to 12 the department for a special authorization to take wildlife 13 with the use of a firearm while being accompanied by a person who has attained the age of majority, acting as a 14 15 mentor, who possesses or can demonstrate he has obtained a 16 certificate of competency and safety in the use and handling of firearms and who possesses a valid Wyoming 17 18 hunting license. A mentor shall not provide supervision 19 for more than one (1) person, other than immediate family 20 members, at a time in the field. The special authorization 21 shall be valid for not more than one (1) year. Nothing in subsection shall be construed as altering the 22 23 requirements of W.S. 23-2-102(a). The commission shall

promulgate rules and regulations to carry out the purposes 1 2 of this subsection and subsection (e) of this section. 3 4 (e) A person under fourteen (14) years of age who has 5 not yet received a certificate of competency and safety in 6 the use and handling of firearms may take small game and game birds without receiving special authorization from the 7 8 department under subsection (c) of this section while being 9 accompanied by a person who has attained the age of majority, acting as a mentor, who possesses or can 10 11 demonstrate he has obtained a certificate of competency and 12 safety in the use and handling of firearms and who 13 possesses a valid Wyoming small game or game bird license. 14 A mentor shall not provide supervision for more than one 15 (1) person, other than immediate family members, at a time 16 in the field and shall not carry a firearm while providing 17 supervision. 18 19 Section 2. This act is effective July 1, 2017. 20 21 (END)
