A JOINT RESOLUTION

for

- 1 A JOINT RESOLUTION requesting Congress to enact legislation
- 2 expanding and improving efforts to coordinate reporting,
- 3 investigation and pursuit of justice for missing and murdered
- 4 Native Americans and other persons.

5

- 6 WHEREAS, in some tribal communities, Native Americans are
- 7 murdered at more than ten (10) times the national average;
- 8 and

9

- 10 WHEREAS, Native American and Alaska Native women and girls
- 11 are at least two (2) times more likely to experience rape or
- 12 sexual assault and two and one-half (2½) times more likely to
- 13 experience violent crimes compared to women and girls of all

1 other races, and those factors often are tied to cases

2 involving a disappearance or murder; and

3

4 WHEREAS, the National Crime Information Center reported five

5 thousand seven hundred twelve (5,712) cases of missing Native

6 American and Alaska Native women and girls in 2016, yet the

7 United States Department of Justice's federal missing persons

8 database only logged one hundred sixteen (116) cases; and

9

10 WHEREAS, Wyoming reported to the National Crime Information

11 Center one hundred seven (107) missing Native Americans in

12 2018 and ninety-three (93) missing Native Americans through

13 the end of July 2019, and it is likely that many cases go

14 unreported; and

15

16 WHEREAS, populations that experience chronic unemployment,

17 homelessness, substance abuse, severe poverty and high rates

18 of sexual violence and other crimes including Native American

19 and Alaska Native communities are at a higher risk of human

20 trafficking; and

21

22 WHEREAS, violence against children and crimes associated with

23 dating violence and domestic violence has immediate and long

1 term effects, including increased rates of altered

2 neurological development, poor physical and mental health,

3 poor school performance and substance abuse. Exposure to

4 this violence increases the instances of trauma in tribal

5 communities, which affects health outcomes, reduces

6 educational attainment, hinders economic growth and

7 undermines public safety; and

8

9 WHEREAS, investigation into cases of missing and murdered

10 Native Americans and domestic violence calls, which are

11 amongst the most dangerous calls that law enforcement

12 receives, is made difficult for tribal law enforcement

13 agencies due to a lack of necessary training, equipment or

14 funding, complicated jurisdictional structures, a lack of

15 interagency cooperation and a host of inadequate laws; and

16

17 WHEREAS, no federal agency has comprehensive data on how many

18 Native Americans are murdered or missing; and

19

20 WHEREAS, the Urban Indian Health Institute reported that the

21 challenges and barriers in accessing data on these issues

22 from law enforcement severely impede the ability of

1 communities, tribal nations and policymakers to make informed

2 decisions on how best to address this violence; and

3

4 WHEREAS, Savanna LaFontaine-Greywind, for whom federal

5 legislation is named, was a member of the Spirit Lake Tribe

6 and was murdered when she was eight (8) months pregnant; and

7

8 WHEREAS, Savanna's Act (2019 S. 227/H.R. 2733) will improve

9 tribal access to federal crime information databases on

10 missing persons and cooperation among tribal, federal, state,

11 and local law enforcement, and will mandate the United States

12 Attorney General to consult with tribes and submit a report

13 to Congress on how to resolve the barriers tribes face and to

14 review, revise and develop law enforcement and justice

15 protocols appropriate to address missing and murdered Native

16 Americans; and

17

18 WHEREAS, the Not Invisible Act (2019 S. 982/H.R. 2438) will

19 establish an advisory committee on violent crime composed of

20 law enforcement, tribal leaders, federal partners, service

21 providers and survivors to recommend actions to the

22 Department of Interior and Department of Justice. The bill

23 will also establish best practices for law enforcement on

1 combatting the epidemic of missing persons, murder and

- 2 trafficking of Native Americans and Alaska Natives, and
- 3 coordinate prevention efforts, grants and programs across
- 4 offices within the Bureau of Indian Affairs, the Department
- 5 of Justice and other agencies of the federal government
- 6 related to the murder of, trafficking of, and missing Native
- 7 Americans and Alaska Natives; and

8

- 9 WHEREAS, the Bridging Agency Data Gaps and Ensuring Safety
- 10 (BADGES) for Native Communities Act (2019 S. 1853/H.R. 4289)
- 11 will bridge agency data gaps by requiring federal law
- 12 enforcement databases to report on cases of missing or
- 13 murdered Native Americans, to coordinate with the National
- 14 Missing and Unidentified Persons System liaisons, to share
- 15 data with the tribes and to establish a background check
- 16 demonstration program to ensure safety for Native American
- 17 communities; and

18

- 19 WHEREAS, the Native Youth and Tribal Officer Protection Act
- 20 (2019 S. 290/H.R. 958) will build on the Violence Against
- 21 Women Act by allowing tribes to charge offenders for dating
- 22 violence, domestic violence, child violence and violence
- 23 committed against members of the tribal justice system and by

1 coordinating federal domestic violence training and hotline

2 resources; and

3

4 WHEREAS, the Studying the Missing and Murdered Indian Crisis

5 Act of 2019 (2019 S. 336/H.R. 2029) will direct the

6 Comptroller General of the United States to report on law

7 enforcement agencies' responses to reports of missing or

8 murdered Indians; and

9

10 WHEREAS, other proposed legislation will continue and grow

11 existing endeavors to support Native Americans and other

12 persons, including the Justice for Native Survivors of Sexual

13 Violence Act (2019 S. 288/H.R. 3977), which amends the Indian

14 Civil Rights Act of 1968 to extend the jurisdiction of tribal

15 courts to cover crimes involving sexual violence; the

16 Securing Urgent Resources Vital to Indian Victim Empowerment

17 (SURVIVE) Act (2019 S. 211/H.R. 1351), which amends the

18 Victims of Crime Act of 1984 and the Native American Child

19 Protection Act (H.R. 4957), which amends the Indian Child

20 Protection and Family Violence Prevention Act and the

21 Violence Against Women Reauthorization Act of 2019 (S.

22 2843/H.R. 1585), which reauthorizes the Violence Against

23 Women Act of 1994.

2 NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE

3 LEGISLATURE OF THE STATE OF WYOMING:

4

5 **Section 1.** That the Wyoming Legislature requests that

6 Congress swiftly enact legislation providing for justice for

7 missing and murdered Native Americans and other persons,

8 including enacting Savanna's Act, the Not Invisible Act, the

9 BADGES for Native Communities Act, the Native Youth and Tribal

10 Officer Protection Act, the Studying the Missing and Murdered

11 Indian Crisis Act of 2019 and other legislation that amends

12 and reauthorizes existing protections.

13

14 Section 2. That the Secretary of State of Wyoming

15 transmit copies of this resolution to the President of the

16 United States, to the President of the Senate and the Speaker

17 of the House of Representatives of the United States Congress

18 and to the Wyoming Congressional Delegation.
