Selective service registration.

Sponsored by: Joint Transportation, Highways & Military
Affairs Interim Committee

A BILL

for

1 AN ACT relating to selective service; requiring
2 certification of selective service registration consent via
3 driver's license and identification card applications;
4 requiring the department to transmit data to the selective
5 service system; conforming provisions; and providing for an
6 effective date.

8 *Be It Enacted by the Legislature of the State of Wyoming:*

9

10 **Section 1.** W.S. 31-7-143 is created to read:

11

12 **31-7-143. Selective service registration.**

13

14 (a) Upon receiving the certification required in
15 subsection (b) of this section, the department shall

1 forward electronically or via other means of transmission
2 to the selective service system the information necessary
3 from the applicant's Wyoming driver's license or
4 identification card for the applicant to comply with the
5 federal Selective Service Act, 50 U.S.C. 3802, et seq.

6

7 (b) An application under W.S. 31-7-111(b) and
8 31-8-101(a) shall include space for a certification and
9 notice to the applicant that reads: "By my signature I
10 certify that I am consenting to using information submitted
11 on this application for registration with the United States
12 Selective Service System if my registration is required by
13 federal law."

14

15 (c) The applicant's submission of the application
16 after signing the application containing the certification
17 in subsection (b) of this section constitutes the
18 applicant's consent to the transmission of the information
19 in subsection (a) of this section.

20

21 (d) Nothing in this section shall restrict the
22 information the department may provide under the federal
23 Driver's Privacy Protection Act.

2 **Section 2.** W.S. 31-7-111(b) by creating a new
3 paragraph (xv) and 31-8-101(a) are amended to read:

4

5 **31-7-111. Application for license or permit**
6 **generally.**

7

8 (b) The application shall include:

9

10 (xv) Information required by W.S. 31-7-143.

11

12 **31-8-101. Issuance to residents by department;**
13 **restrictions; limited to one state-issued credential;**
14 **digital identification card; definitions; rulemaking.**

15

16 (a) Any Wyoming resident may be issued an
17 identification card by the department of transportation if
18 the resident does not possess or surrenders any other
19 state-issued, REAL ID Act or other applicable federal law
20 compliant driver's license or identification card. The
21 application shall state the registrant's full legal name,
22 social security number, date of birth and any other
23 identifying data the department may require and shall be

1 signed and verified by the applicant. The application shall
2 include information required by W.S. 31-7-143. The
3 identification card shall at the applicant's request
4 indicate that the applicant is an anatomical organ donor as
5 provided by W.S. 35-5-205 or that the applicant has a
6 medical alert designation as provided for in W.S. 31-7-142.
7 Before receiving an identification card under this chapter
8 a person who previously has been licensed or issued an
9 identification card in this or any other state but who does
10 not have the credential in their possession shall complete
11 an affidavit of "No License/ID Card in Possession."

12

13 **Section 3.** This act is effective July 1, 2021.
