Advanced conversion technologies task force amendments.

A BILL

for

1 AN ACT relating to the University of Wyoming; renaming the
2 clean coal task force as the advanced conversion
3 technologies task force; amending the duties of the
4 advanced conversion technologies task force; renaming the
5 clean coal technology research account as the advanced
6 conversion technologies research account; extending the
7 sunset date of the advanced conversion technologies task
8 force as specified; and providing for an effective date.

10 *Be It Enacted by the Legislature of the State of Wyoming:*

11

12 **Section 1.** W.S. 21-17-121(a), (b)(intro), (ii),
13 (iii), (c) and (f) and 39-14-802(a) are amended to read:

14

15 **21-17-121. Advanced conversion technologies task**
16 **force; members; compensation; proposals; report.**

2 (a) The ~~clean coal research~~ advanced conversion
3 technologies task force created pursuant to 2007 Wyoming
4 Session Laws, Chapter 186, Section 2 shall exist until June
5 30, ~~2013~~ 2015. The task force shall consist of the voting
6 members of the Wyoming energy resources council created
7 pursuant to W.S. 21-17-117(e), or their designees.

8

9 (b) The task force shall meet at the call of the
10 chairman. The task force shall issue requests for
11 proposals for research projects into ~~clean coal~~ advanced
12 conversion technologies. The task force shall review and
13 evaluate proposals for research into ~~clean coal~~ advanced
14 conversion technologies, subject to the following:

15

16 (ii) Proposals shall be evaluated competitively
17 on their probable benefits to the state of Wyoming and ~~coal~~
18 mineral and energy programs within this state;

19

20 (iii) Proposals shall enhance and improve ~~clean~~
21 ~~coal technologies with an emphasis on methods of combusting~~
22 ~~sub bituminous coal at high altitudes~~ advanced conversion
23 technologies.

1 (c) The task force shall issue a report to the
2 governor and the joint minerals, business and economic
3 development interim committee annually, no later than
4 September 30, including, but not limited to,
5 recommendations regarding funding specific proposals for
6 research into ~~clean coal~~advanced conversion technologies
7 in Wyoming.

8
9 (f) The ~~clean coal~~advanced conversion technologies
10 task force may award funds in the ~~clean coal technology~~
11 advanced conversion technologies research account to
12 proposals for ~~clean coal~~advanced conversion technologies
13 after submitting the task force's recommendations to the
14 joint minerals, business and economic development interim
15 committee.

17 **39-14-802. Advanced conversion technologies research**
18 **account created; funds deposited; use of funds.**

19
20 (a) There is created the ~~clean coal~~advanced
21 conversion technologies research account into which shall
22 be deposited revenues as provided by law. Interest on
23 earnings from funds in the account shall be credited to the
24 account.
