The petition and documents filed pursuant to this 1 (d) 2 section, and the interlocutory decree, if entered, and the 3 final decree of adoption shall constitute a confidential 4 file and shall be available for inspection only to the judge, or, by order of court, to the parties to the 5 proceedings or their attorneys, except as provided in W.S. 6 35-1-416. Upon the entry of the final decree of adoption, 7 8 all records in the proceedings shall be sealed and may be 9 available for inspection only by order of court for good 10 cause shown. The clerk of court shall maintain a separate 11 journal for adoption proceedings to be confidential and 12 available for inspection only by order of the court for 13 good cause shown. The court may order inspection of all or 14 part of the confidential file in adoption proceedings only 15 if it appears to the court that the welfare and best 16 interests of the child will be served by the inspection.

## 18 **35-1-416.** Court reports of adoption.

20 (a) For each adoption of a child born in this state,
21 that is decreed by any court in this state, the court shall
22 require the preparation of a report of adoption on a form
23 prescribed and furnished by the state registrar of vital

records. The report shall include such facts as are 1 2 necessary to locate and identify the certificate of birth 3 of the person adopted, provide information necessary to 4 establish new certificate of birth of the person adopted, and shall identify the order of adoption and be certified 5 by the clerk of the court. The state registrar shall also 6 be furnished report of adoption as well as a certified copy 7 8 of adoption decree shall be furnished to the state

registrar as specified in subsection (c) of this section.

(b) Whenever an adoption decree is amended or annulled, the clerk of the court shall prepare a report thereof which shall include such facts as are necessary to identify the original adoption report and the facts amended in the adoption decree as necessary to properly amend the birth record. The report of the amended or annulled adoption decree shall be furnished to the state registrar as specified in subsection (c) of this section.

22 registrar of vital records the report of adoption, records
