1 (a) As used in this act: 2 (ix) "Official" means any elected or appointed 3 4 state official who receives compensation other than expense reimbursement from state funds, except for members of the 5 legislature and officials serving on an intermittent, 6 irregular or less than halftime basis; 7 8 9 9-3-501. Definitions. 10 11 (a) As used in this article: 12 (iii) "Employee" means any member of the state 13 legislature or person including any elected official 14 employed by and receiving compensation from the state of 15 16 Wyoming or a county, city, town or other political 17 subdivision, but does not include any at-will contract employee under W.S. 9-2-1022(a) (xi) (F); 18 19 20 9-3-508. 1 The state shall contribute monthly to the program (a) 2 the amount established and appropriated by the legislature 3 for each employee and official contributing to and 4 participating in the program in accordance with subsections 5 (b) and (c) of this section, except that there shall be no 6 state contribution for any member of the legislature eligible for participation in the program solely in his 7 8 capacity as a state legislator. Any legislative appropriation under any act adopted by the legislature for 9 10 contributions under this section shall be expended solely for the purposes specified in this section during the 11 12 budget period for which the appropriation is made and shall not be carried forward for contributions in succeeding 13 14 budget periods.

legislature participating in the program solely in his
capacity as a state legislator.

2 Section 2. This act shall not be applied to affect 3 the participation of any member of the legislature lawfully 4 participating as of the effective date of this act in any of the plans subject to this act. This act shall not be 5 6 construed to prohibit participation by a state legislator in any plan subject to this act if participation is based 7 8 upon employment or holding of an office other than as a member of the legislature. 9

Section 3. This act is effective immediately upon completion of all acts necessary for a bill to become law as provided by Article 4, Section 8 of the Wyoming Constitution.
