- 10 **Section 1.** W.S. 21-2-202(a) by creating a new
- 11 paragraph (xxxii) and 21-3-110(a) by creating a new
- 12 paragraph (xxx) are amended to read:

14 21-2-202. Duties of the state superintendent.

1 In addition to any other duties assigned by law, 2 the state superintendent shall: 3 4 (xxxii) By rule and regulation adopted not later 5 than July 1, 2011 establish requirements for school district policies regarding the use of seclusion and 6 restraint in schools as required under W.S. 7 21-3-110(a)(xxx). The state superintendent shall review 8 9 the policy of each district for compliance with the requirements of W.S. 21-3-110(a)(xxx) and rules and 10 11 regulations promulgated pursuant to this paragraph. If the state superintendent determines that the policy is not in 12 13 compliance under this paragraph the superintendent shall direct the board of trustees to revise the policy and 14 shall, upon request, assist the board in the adoption of 15 16 the policy. 17 18 21-3-110. Duties of boards of trustees. 19 The board of trustees in each school district 20 (a) 21 shall: 22 (xxx) Not later than December 31, 2011, adopt a 23 policy regarding the use of seclusion and restraint in 24

schools. In addition to any requirements provided by rule 1 2 and regulation of the state superintendent pursuant to W.S. 3 21-2-202(a)(xxxii), the policy shall require that the 4 parent or legal guardian of the student shall be notified 5 each time that seclusion or restraint is utilized for the student. The policy shall not be limited to any specified 6 7 group of students and shall apply any time that seclusion or restraint is used for any student. The district shall 8 9 submit a copy of the policy to the state superintendent for review as provided in W.S. 21-2-202(a)(xxxii) after the 10 initial adoption of the policy and any time thereafter that 11 the policy is substantially revised. As used in this 12 13 paragraph: 14 15 (A) "Restraint" means the use of physical

force, with or without the use of any physical device or 16 17 material, to restrict the free movement of all or a portion of a student's body. "Restraint" does not include 18 comforting or calming a student, holding the hand or arm of 19 a student to escort the student if the student is 20 21 complying, intervening in a fight or using a device 22 prescribed by an appropriate professional and consistent 23 with the student's individualized education program;

1	(B) "Seclusion" means removing a student
2	from a classroom or other school activity and isolating the
3	student in a separate supervised area. "Seclusion" does
4	not include a student requested break or in-school
5	suspension, detention or other appropriate disciplinary
6	measure.

8	Section 2. This act is effective immediately upon
9	completion of all acts necessary for a bill to become law
10	as provided by Article 4, Section 8 of the Wyoming
11	Constitution.
