## A BILL

for

- 1 AN ACT relating to insurance; providing for publication of

7 Be It Enacted by the Legislature of the State of Wyoming:

- 9 **Section 1.** W.S. 26-3-126(b)(iii), (c) and by creating
- 10 a new subsection (d) is amended to read:

- 12 26-3-126. Annual statement; correction and
- 13 publication of statements.

- 15 (b) After any corrections noted are made, the
- 16 commissioner shall:

2 (iii) Cause each summary and certificate to be 3 published for six (6) successive days in a daily newspaper 4 of general circulation within the state, or for six (6) 5 successive weeks in a weekly newspaper of general circulation, and the insurer shall pay the cost of 6 publication upon receipt of a statement from the newspaper 7 directly accessible to the public via a link from the main 8 9 page of the official department website. 10 (c) Insofar as is possible The commissioner shall 11 distribute the publications equally among the newspapers 12 located in this state. supply a list of all insurers that 13 14 have filed an annual statement to each newspaper of general circulation within the state that meets the requirements of 15 a legal newspaper pursuant to W.S. 18-3-519. The 16 17 newspapers shall then publish the list annually. The list shall include each company's national association of 18 19 insurance commissioners number. The publication shall include the names of any companies that were suspended or 20 21 revoked within the previous year. The publication shall also include a description of how to access more 22 23 information about companies using the official department

1 website. The cost of publication shall be shared equally

2 among the companies on the list.

For disability insurance, the commissioner may 4 5 require inclusion in the publication required by subsection (c) of this section data relating to the quality and 6 7 availability of insurance, which may include but is not limited to the number and geographic dispersion of 8 9 policies, area of service and value of policies sold within Wyoming for disability insurance. The commissioner shall 10 11 cause the information for companies selling disability insurance to be published at a time convenient to the open 12 13 enrollment period, which may be different from the time for 14 publishing the information for other insurance companies. Both publications shall also include a description of how 15 to access more information about companies using the 16 17 official department website and the publication disability companies may include information about how to 18 additional information on 19 access companies selling disability insurance. 20
