A BILL

for

- 1 AN ACT relating to education; modifying the membership of
- 2 the University of Wyoming board of trustees; providing
- 3 qualifications; making the act contingent upon passage of a
- 4 constitutional amendment as specified; specifying
- 5 legislative findings; specifying implementation; and
- 6 providing for an effective date.

8 Be It Enacted by the Legislature of the State of Wyoming:

10 **Section 1.** W.S. 21-17-201 is amended to read:

11

- 12 21-17-201. Composition; appointment and
- 13 qualifications of members generally; members ex officio;
- 14 quorum.

The government of the university is vested in a board of 1 2 twelve (12) thirteen (13) trustees appointed by the governor, no two (2) of whom may be residents of the same 3 4 county of the state. No more than two (2) appointed 5 trustees shall be residents of a state other than Wyoming. Any person appointed as trustee who is not a resident of 6 Wyoming shall possess verifiable and demonstrable interest 7 8 in and past interactions with the university which are reflective of commitment to the educational mission of the 9 university. At least one (1) trustee shall be appointed 10 11 from each appointment district pursuant to W.S. 9-1-218. Not more than seven (7) members of the board shall be 12 registered in the same political party. The governor, the 13 president of the university, the state superintendent of 14 15 public instruction, and the president of the associated students of the university are members ex officio, having 16 17 the right to speak, but not to vote. A majority of the 18 board is a quorum.

Section 2. This act is effective only if the electors 20 adopt a constitutional amendment at the 2014 21 22 election removing the requirement that all trustees of the University of Wyoming must be a resident of the state of 23 Wyoming, as provided in 2013 Senate Joint Resolution 1. 24

1 Section 3. Notwithstanding W.S. 21-17-202, the

2 initial term of the board of trustee member appointed

3 pursuant to this act shall expire on March 1, 2021. The

4 governor shall nominate, and the additional board member

5 shall be confirmed, in accordance with W.S. 21-17-202

7 **Section 4.** The legislature finds that the University

8 of Wyoming prepares students for life in a global economy

9 and that the university is integrally involved in a world

10 extending well beyond the borders of Wyoming. Removing

11 restrictions on qualifications for potential board of

12 trustee members as provided in this act reflects those

13 realities while at the same time ensuring that all or nearly

14 all trustees will be Wyoming residents.

Section 5. Subject to section 2 of this act, this act

17 is effective upon certification of the election results of

3

18 the 2014 general election.
