for

- 1 AN ACT relating to gambling; exempting poker from the
- 2 definition of gambling as specified; allowing boards of

- 5 fide social relationships or poker in business
- 6 establishments; and providing for an effective date.

8 Be It Enacted by the Legislature of the State of Wyoming:

10 **Section 1.** W.S. 6-7-105 is created to read:

12 6-7-105. County and municipal prohibition.

- 14 Notwithstanding any other provision of law, a board of
- 15 county commissioners or municipal governing body may, by
- 16 resolution or ordinance respectively, prohibit games,

1 wagers or transactions taking place in a business

- 2 establishment which would otherwise be permitted under W.S.
- 3 6-7-101(a)(iii)(E) or (J). Any regulation by a municipality
- 4 within the county shall apply within that municipality if
- 5 it is at least as restrictive as the county restrictions or
- 6 if the county commissioners do not adopt a resolution
- 7 pursuant to this section.

- 9 **Section 2.** W.S. 6-7-101(a)(iii) by creating a new
- 10 subparagraph (J) and (ix) is amended to read:

12 **6-7-101.** Definitions.

14 (a) As used in this article:

- 16 (iii) "Gambling" means risking any property for
- 17 gain contingent in whole or in part upon lot, chance, the
- 18 operation of a gambling device or the happening or outcome
- 19 of an event, including a sporting event, over which the
- 20 person taking a risk has no control, but does not include:

- 22 (J) Poker games, whether or not incidental
- 23 to a bona fide social relationship, when held in any

2	paragraph (a)(ix) of this section.

4	(ix) "Profit" means benefit other than a gain,
5	which is realized or unrealized and direct, including
6	benefits from unequal advantage in a series of transactions
7	but does not include benefits of proprietorship or
8	management of a business wherein a game, wager or
9	transaction described in W.S. 6-7-101(a)(iii)(E) or (J)
10	occurs;

12	Section 3. This act is effective July 1, 2010.
